Preface

This book is intended to teach you how to compose music. If you already compose, it will make you more fluent and will help you to expand the ideas and skills you already have. It is not a book about music. It is not a book about composition. It is a book that requires your participation; you will actually begin composing in the first chapter. Knowledge and experience, in other words, are given in one stroke.

Most of the teaching takes place in the form of exercises; in fact, to read this book is to work through the exercises. Each exercise acquaints you with a particular procedure or resource—information that, in most cases, you will use right away to compose a short piece. I have found this method of teaching to be highly effective. Instant application provides you with instant experience. Furthermore, there is absolutely no better way to learn something than to try it yourself.

The focus of this book is on melody, which is the essence of music. Harmony is also emphasized, and you will be able to gain a good understanding of the important relationship between harmony and melody. Most of the harmonic material is limited to major and minor triads, with the exception of the exercises on “magic” chords and non-3rd chords derived from melody.

I have used only those procedures and materials that have proven to be most useful in my classes. Included in these are topics—words and music and popular music as a source—that have not been dealt with in any other book. Some topics such as

isomelody, organum, pointillism, and minimalism may not be immediately familiar to you, but it should take you no time to feel comfortable with them; the instructions and guidelines are very clear and easy to understand.

Whom This Book Is for

This book is for anyone and everyone who wants to compose music. The students in my classes have varying backgrounds, goals, and tastes, and they have all been successful with my method of teaching composition—even those who have only a minimal background in music. To begin this book you should know the treble and bass clefs, the C major scale, the rudiments of time signatures and note values, and how to construct intervals. This knowledge is the equivalent of less than a semester in music theory. In some cases a background in piano study will suffice, and in all cases even a slight ability at the piano is helpful, but not necessary.

A unique aspect of this book is that students at any level can benefit by using it; beginners can start at the bottom, and those with more experience can hone the skills they already have. Further, the structure allows students to concentrate on the areas that are applicable to their individual needs. Teachers will find this book especially useful for this reason. *Composing Music* has been used successfully in two-semester courses at Columbia College, Chicago. It worked particularly well because some of the students were instrumentalists and were able to perform the exercises and examples in class.

While *Composing Music* works well for music courses, it is also suited to self-study. The approach and instructions are straightforward, and you can easily work through the book by yourself. You will find that the book provides all the guidance you need.

About the Exercises

When I teach I encourage my students to compose immediately. The exercises are designed in such a way that only a few elements are available at a time. This approach isolates each detail of the composition process so that each one can be more deeply understood.

For example, in Chapter 9 there is an exercise on “magic” chords in which you are given a unique chord and are asked to compose a melody made up exclusively of tones in this chord. You are given an accompaniment, some suggestions on form and shape, and

some other simple guidelines. This is your starting point. When you have completed the exercise, you will feel comfortable basing a melody on the tones of an interesting chord and you will have experienced the unifying influence that such a procedure provides. This sort of exercise improves your ability to develop and control material.

As in the preceding example, each exercise provides you with a specific number of resources to work with. The technique of limiting resources is used extensively throughout this book; it is a most useful and effective method for teaching students how to compose. When you are faced with a blank sheet of music paper and no guidelines, it is often difficult to know how to begin. The limitations act as guidelines and give you the initial direction you will need to complete each exercise. By having a restricted number of resources to work with, you will learn to accomplish more and do less. The beginning composer in particular tends to use more chords, rhythms, and tones than are necessary and frequently gets less than successful results. You will be surprised by the mileage you can get from well-chosen guidelines.

Finally, the order of the chapters is sequential, as it is in most books; but in this book the order does not need to be rigidly adhered to, especially in the later chapters. Whatever your background, I encourage you to complete at least the first four chapters in their proper order. Chapter 8, "Accompaniment Procedures," should be completed before you do the chapters that follow it. Chapter 14, on picture music, may be embarked upon at any time with good results.

Materials You Will Need

For the fill-in exercises you will need a good pencil with soft lead (Eberhard Faber Blackwing 602s, though expensive, are excellent) and a good eraser (the white, plastic type gives very clean results). You will need manuscript paper with a hard surface for the out-of-book projects. I recommend Aztec paper, 9½ by 12½ inches in size, which is available from Associated Music-Copy Service Corporation (231 West 54th Street, New York, NY 10019). For the out-of-book projects I also suggest that you use a fountain pen that is suitable for writing music; Sheaffer makes an excellent and inexpensive calligraphy model with three point styles. The fine point is best for writing music.

For "Picture Music," (Chapter 14) you will need art paper (the size can vary from 15 by 18 inches to 18 by 20 inches) and several different colored felt-tip markers with large, but not too large, tips. Marko by Flair is good.

Bear in mind that neat and legible music expresses clear thinking to your players and leads to a higher level of performance, even in the classroom.

Once You Have Finished This Book

Although several other fine books on composition are currently available, their content is largely theoretical. *Composing Music*, on the other hand, presents entirely practical information that is easy to absorb because you apply it immediately. The experience you will obtain from this book will make you comfortable with a variety of sources and procedures. You will have developed the ability to use these procedures in your own composing. You will have learned the important principles for setting words to music and the way to use many types of music for ideas. You will have developed a good sense of the relationship of the many different parts of composition to the whole. In addition, you will have a valuable reference book of ideas and a set of outlines (in the form of exercises) that you can continue to refer to for future pieces.

Inevitably you will have discovered something important about your own nature and your own ideas.

Lastly I should say that this book has a point of view that would have been considered conservative a few years ago but might be seen as almost daring these days; music must have a breadth of thought and feeling that I call *humanistic*—it must be directed to an audience, and it must always be life supporting.

General Rules for the Exercises

1. Prepare yourself for each exercise. In order to do your best work, it is important to give yourself fully to the exercises. Try to set the right tone, both mentally and emotionally, and strive for stillness of mind. Thorough concentration is crucial.

2. Get in touch with your voice and your ear. Sing as you compose and find the tones through what you sing. Playing the piano (or some other instrument) will, of course, help develop your ear, but your main aim should be to get the music in your ear and voice as well as in your mind and fingers. Learn to sing, tone by tone, what you compose, *while* you are composing it. Then you must be able to sing the completed melody—without pause.

3. Melodies with no harmony or accompaniment should be started and ended on the first tone of the scale (the tonic) and in the same octave as the first tone. You may *begin* a melody that is harmonized or accompanied on any tone, provided that you end on the tonic, preferably *below* the starting tone. This rule will help you stay in one key and will also give shape to your melodies.

4. Use 2nds and 3rds freely. Take care with skips and with augmented and diminished intervals. This rule is an expression of the capabilities of the human voice, from which all melody derives. And do not exceed a total range of a major 10th: in other words, the highest and lowest notes of your melody must not be more than a 10th apart.

5. Write for instruments that are available to you. It is important to be able to hear your music played, and it is exciting to see how written music can be transformed into actual sound. Hearing your music will also curb the normal tendency of the beginning composer to go beyond what is playable and practical.

6. The melodies you compose should be written for string instruments or wind instruments. Most of the melodies in the exercises tend to be simple, and string and wind instruments have the capacity to perform this kind of melody with more expression and emotion than other instruments do. The piano is particularly inappropriate for these melodies because it can easily neutralize them. But it is all right to use guitar or piano for a) harmonies or b) accompaniment.

7. Always specify the tempo and dynamics (including crescendo and decrescendo); indicate whether the notes are to be played legato (by means of slur-phrasing markings) or staccato. This rule will encourage you to make your music ready for performance because these indications are as much a part of the music as the notes themselves. (See Appendix B, "Musical Symbols.")

8. Give titles to all of the exercises that are longer than six measures. A title will help you to express a unified mood or idea, and it will also help the instrumentalist perform what you write as living music rather than merely as an exercise. It will also help the listener (for whom all composers should have sympathy and affection) understand your music. Make sure that the title expresses the music and that the music expresses the title. Don't use titles that describe the technique you are using (such as "A Special Chord") or titles that give the date of composition ("Tuesday Morning"). Use titles that tell the performer and the listener something about the nature of the music itself.

9. Write mostly in 4/4 and 3/4 meter and use only the following note values, which I call the Basic Note Values:



(only in even-numbered groups—of two, four, six, etc.—and never followed by a rest)



(only in groups of four, eight, twelve, etc. and never followed by a rest)



(use $\frac{1}{4}$ note rests freely, but don't use more than two in succession)

No rests other than the $\frac{1}{4}$ note rest are allowed. And no ties between notes. As the very last measure of an exercise it is all right to use a note that occupies a full measure—such as a whole note in $\frac{4}{4}$ or a dotted $\frac{1}{2}$ note in $\frac{3}{4}$.

10. Don't alter the tempo with ritardandos, accelerandos, or fermatas (also called "holds" or "bird's eyes"). These can get in the way of clear rhythmic motion.

The time signatures $\frac{3}{4}$ and $\frac{4}{4}$, combined with the Basic Note Values, are by far the best rhythmic materials for the developing composer to work with. The above rule will do more to keep you out of trouble and in a direct line with success than any other. You should also restrict the number of different rhythms you use in an exercise; two or three different rhythms will generally serve you better than ten. You may occasionally write in $\frac{5}{4}$ or $\frac{7}{4}$, if you preserve the division of $\frac{5}{4}$ into $2 + 3$ or $3 + 2$ and the division of $\frac{7}{4}$ into $4 + 3$ or $3 + 4$.

$\frac{5}{4}$, for example, is often made up of this rhythm ($2 + 3$):



or this rhythm ($3 + 2$):



Under no circumstances should you use both of the above rhythms in one melody. In many cases, the division into $2 + 3$ (or $3 + 2$) is not as easy to see as it is here, but your ear will tell you if you are shifting from one division to another. All of these rules apply to $\frac{7}{4}$ also.

Always keep in mind the following: **less is more, and silence is music.**

11. Control and restrictions lead to creativity and expansion. From time to time I come across a student who resists the restrictions of this book—especially the General Rules (to which not all of the given examples conform, it should be noted). Such resistance is understandable and you may be feeling it. But let me emphasize the reasons behind these restrictions.

Some restrictions give focus, focus on the procedures at hand—they keep you from having so many choices that you are unable to get in touch with your feelings and ideas. An exercise that asks you to use such-and-such a rhythm and only four given tones is an example of this type of restriction.

Other restrictions are designed to keep you out of trouble. The rule requiring basic note values, for example, helps you to

achieve rhythmic balance, to be able to write a melody that retains its momentum, that keeps going, that does not sag. “Forbidden” rhythms, like a measure of dotted 16th and 32nd notes followed by two whole notes, invite trouble for the developing composer. I want you to be trouble-free when you work with this book. I want you to be challenged, to feel pleasure and to achieve excellence.

Finally, these restrictions are a way of not having to pay attention to anything except what is deep inside of you—**follow the rules and write the music.**

The Cell, the Row, and Some Scales

THE IMPERIAL FLUTE

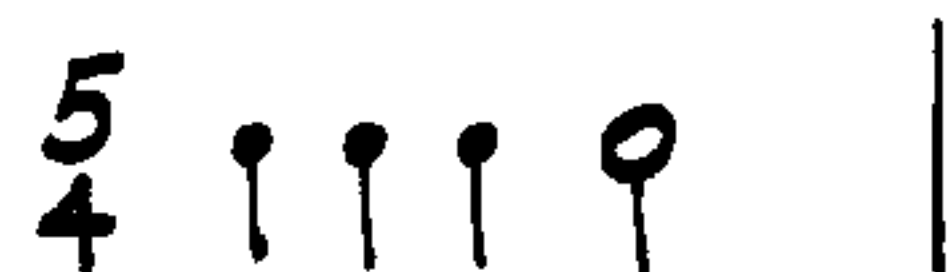
Imagine that you have been captured by the Lorac, a warlike tribe ruled by Edrevol, who will spare your life only if you please him with the music you write for the Imperial Flute. The Imperial Flute can, however, play only four tones:

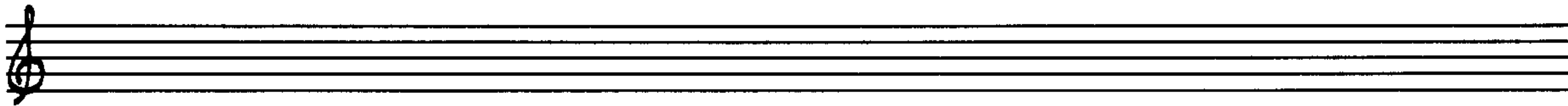
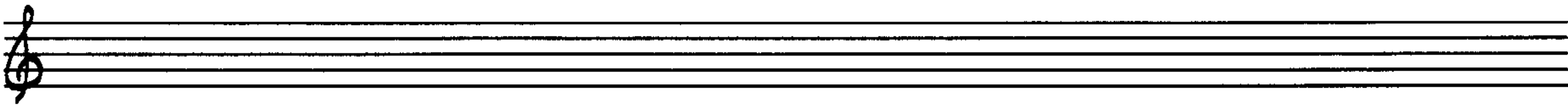
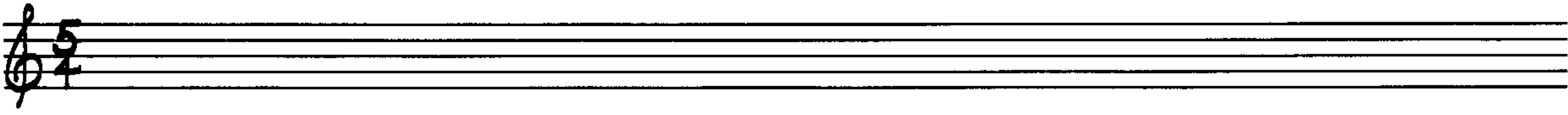


Exercise 1

1. Compose a melody for this four-tone flute, using only the tones shown in Example A.
2. Use only this rhythm (there are no rests in this exercise):



3. To unify your melody and to give it shape, occasionally repeat a measure, either consecutively or after intervening measures.
4. Try not to use all the tones all the time. Study the expressive possibilities of each tone in relation to the other tones. Even though you have four tones to work with, you might consider omitting one tone in the first few measures.
5. Refer to the "General Rules for the Exercises" (p. 1) for the rules that are applicable, here and in all exercises.



The four-note flute is an example of pitch limitation—only four tones or pitches are available for you to use. Pitch limitation will be referred to frequently in this book, as will other forms of limitation of resources. Being subject to limited resources will develop your sense of detail, and it will free you from technical considerations allowing you to concentrate on what you want to express.

THE CELL

The tones of the four-tone flute constitute a limited form of the cell, in which you may also use the same tones in other octaves.

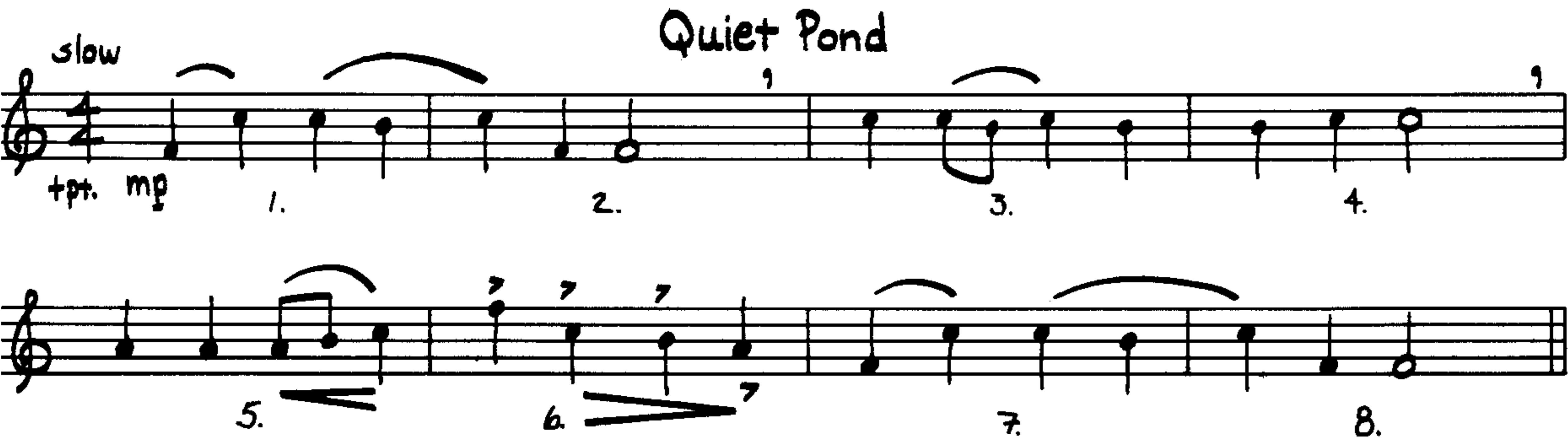
Example B

If the cell is made up of the tones shown in *a* of Example B, you may also use the tones shown in *b*, as well as other octave forms of the original four tones.



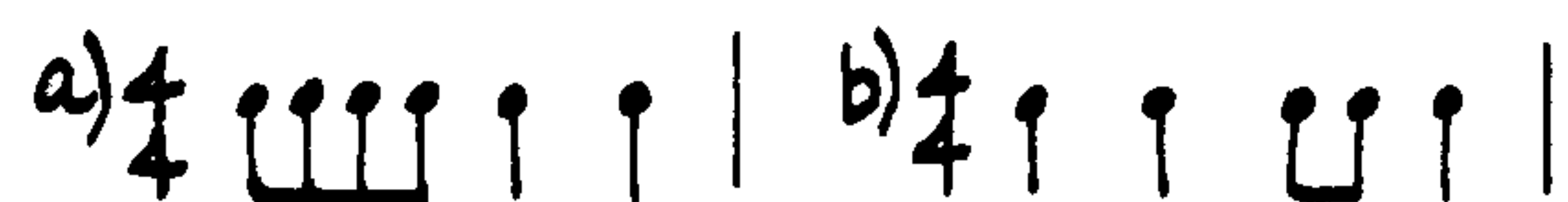
Here is a melody drawn from Example B. Note that the tone A is used only in the fifth and sixth measures.

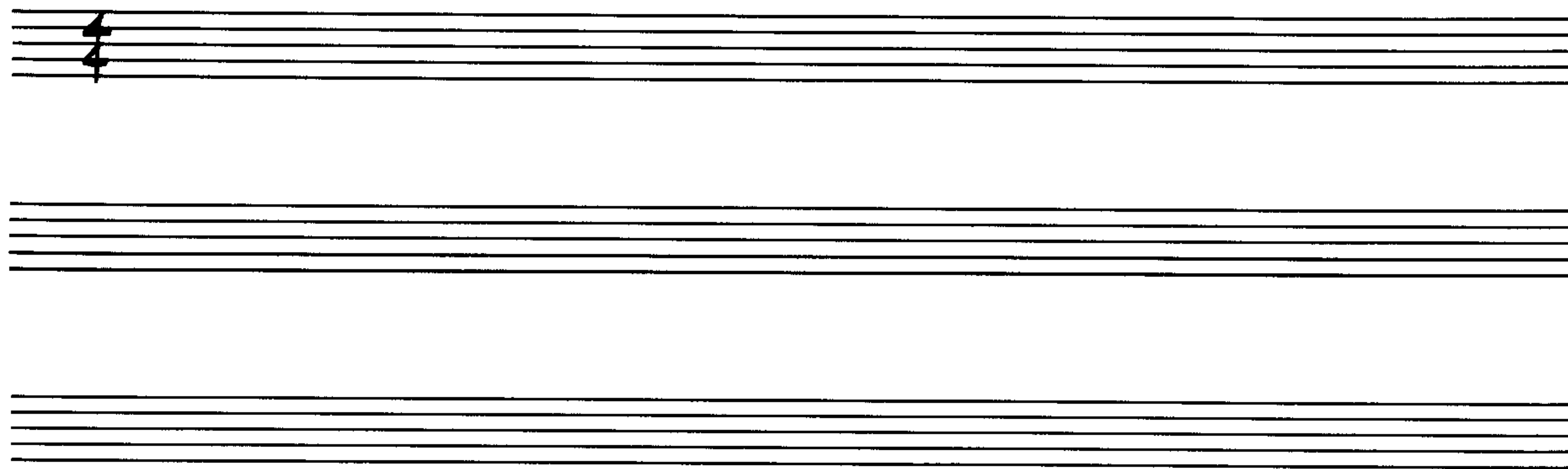


Exercise 2

1. Compose a melody using only the tones of the cell in Example B. You may use octave forms of these tones also.
2. Use only these two rhythms:



3. Occasionally repeat a measure to help give shape and unity to your melody.



THE ROW

The next pitch-limitation procedure is the row:

In the row, the tones are always used in the same order (1 2 3 4 5, as shown in Example E). In other words, you may not use tone 4 until you have used tone 3; tone 5 must be preceded by tone 4. After using all the tones of the row, start again with tone 1. You may repeat tones (see the repetition of tone 1 in measure 3), but only *immediately* (1 2 2 2 3 4 4 5 1, and so on), and you may use tones in other octaves (see measures 4 and 5).

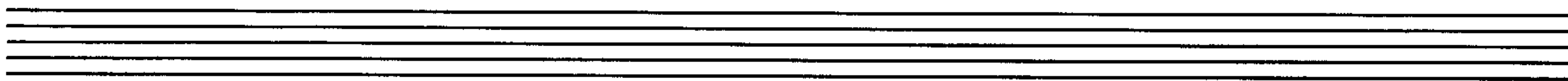
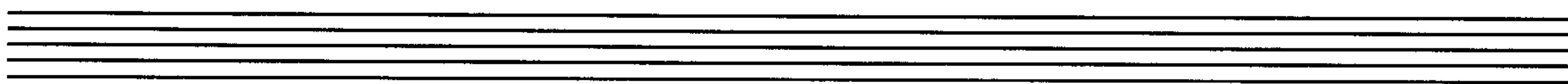
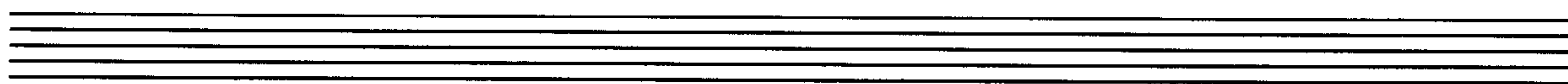


Exercise 3

1. Compose a melody that is six to ten measures in length. Use only the row in Example D as well as the octave forms of these tones.
2. Use only these two rhythms:



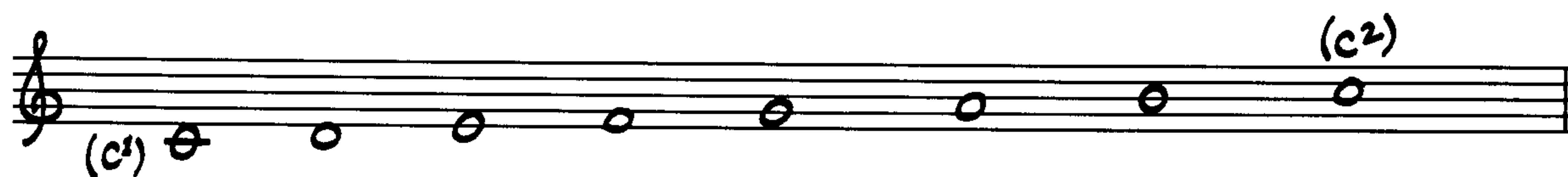
3. Place a number near each of the tones in the melody to show its sequence in the row.

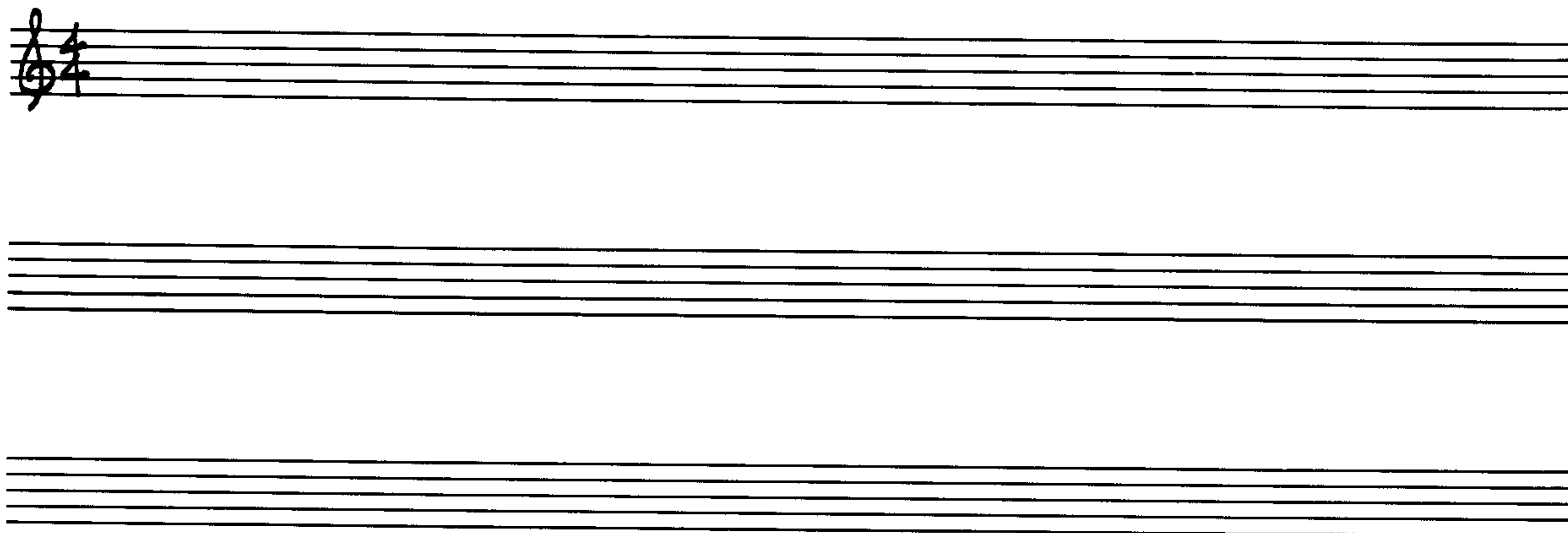


Exercise 4

1. Compose a melody using only the tones presented in Example F (and the octave forms of these tones). Consider the melody as a whole, rather than as isolated measures.
2. The first and last tones must be c^1 (middle C).
3. Use only this rhythm:



4. Occasionally repeat a measure, either consecutively or after intervening measures. *Hint:* Repeated measures should always be written out in full. Never abbreviate repeated measures because it makes them too easy to use; if you have to write them out completely, you will use them because you really want them.
5. Refer to the General Rules that are applicable, here and in all exercises.



THE DORIAN SCALE

This is the D Dorian Scale:

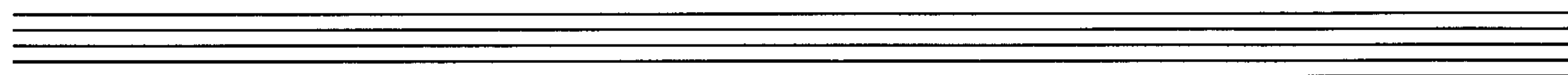
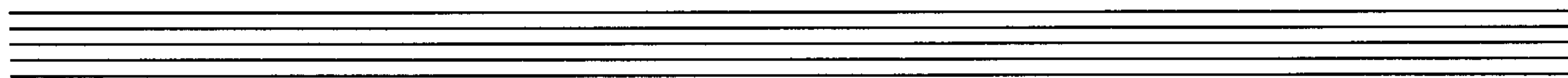
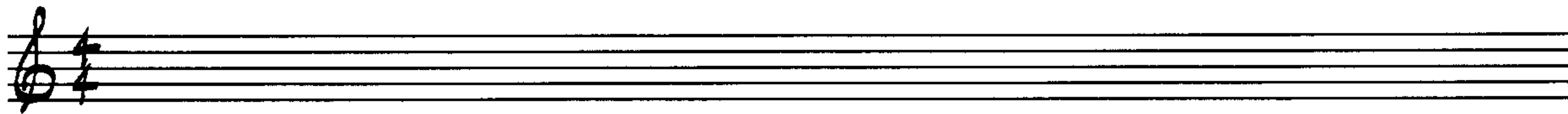
It contains the same tones as those in the C major scale, but it centers around the tone D. When you use it for unaccompanied melodies, you must begin and end with the tone D and you must use the tone D frequently; the ear must hear such a melody in the key of D, not C.

Exercise 5

1. Compose a melody of six to ten measures, expressing water: a lake, a stream, a waterfall, or rain, for example.
2. Use only the tones in Example G and octave forms of these tones. Don't let your melody slip into C major.
3. Use only this rhythm:

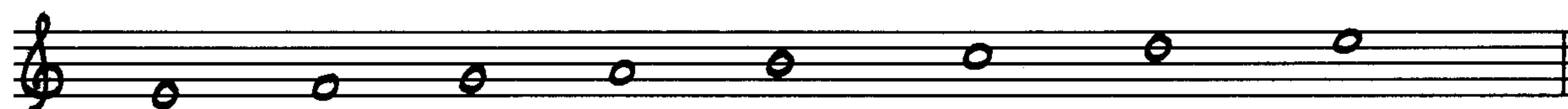


4. From time to time, you may repeat a measure, either consecutively or after intervening measures.



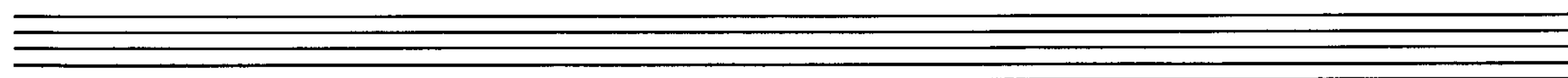
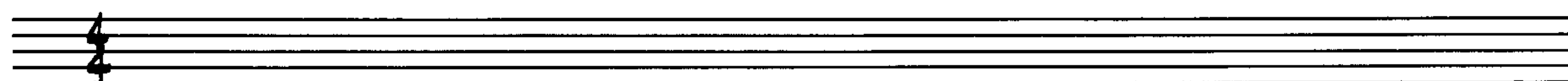
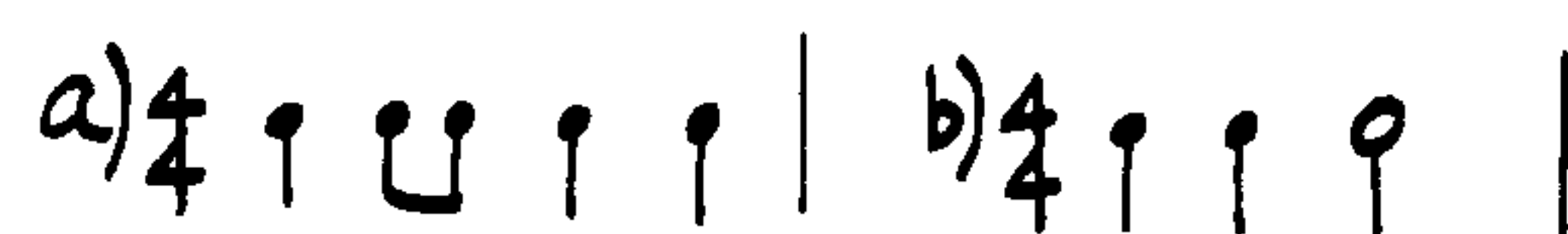
Like the D Dorian scale, the E Phrygian scale shares the tones of the C major scale:

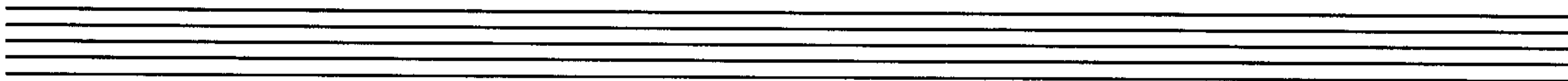
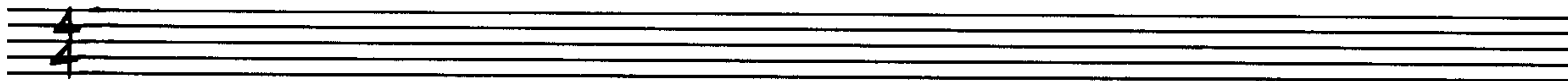
Exercise 6

Exercise 7

Write a “mistake exercise” based on Exercise 6. Ignore all instructions and do everything wrong that you can, especially with respect to maintaining E as the tonic. Label all your mistakes.



THE BASIC NOTE VALUES

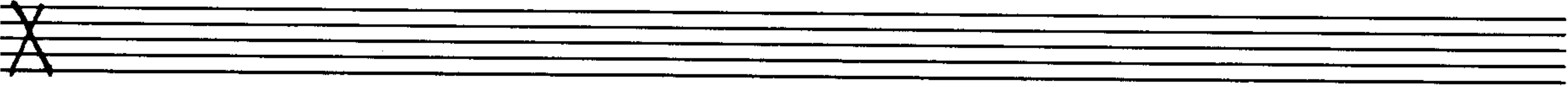
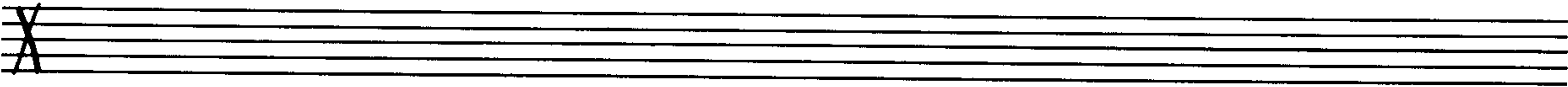
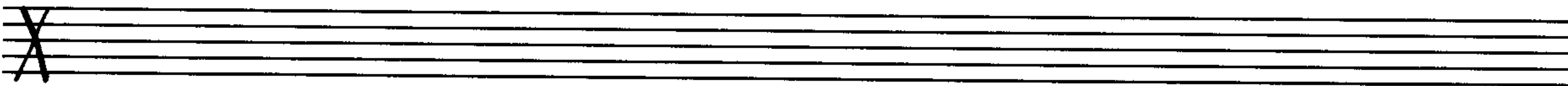
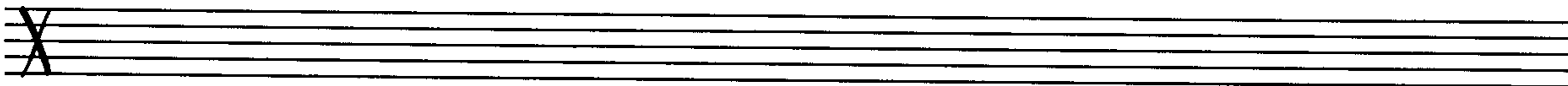
In all the exercises you have worked on so far, the rhythms have been given—that is, you have been restricted to one or two rhythms. This restraint constitutes another limitation of resources, as do the Basic Note Values referred to in the General Rules.

Exercise 8

- 1. Compose eight to twelve measures for a percussion instrument of indefinite pitch, using only the Basic Note Values. Repeat a measure from time to time. (Note the use of X as a clef sign.)
- 2. No figurations such as these are permitted:



- 3. Avoid 8ths or 16ths followed by a rest because such figurations are difficult to perform:



Example I shows six violations of the rules given in Exercise 8. Try to identify the violations before looking at the Violation List.

1. Note value not on list of Basic Note Values
2. Figuration not permitted
3. Lack of balance between long notes and short notes
4. Two 8ths or four 16ths followed by a rest
5. Ties not permitted
6. Too many rests

You may feel unduly restricted by the Basic Note Values, but the truth is that hundreds of rhythms can be evolved from them, and many splendid melodies are made up of only two or three rhythms. Restrict yourself to the Basic Note Values and try to work with very few rhythms. Also, make your rhythms fit each other and flow from one into the other.

Harmony (I)

CHORD PROGRESSIONS: A BEGINNING

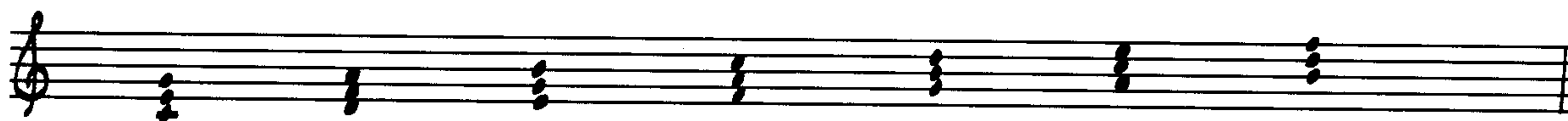
A chord consists of three or more tones sounded simultaneously. A triad is a chord made up of two 3rds. A major triad has a major 3rd on the bottom and a minor 3rd on top; imagine a large box (a major 3rd) underneath a small box (a minor 3rd). A minor triad has a minor 3rd on the bottom and a major 3rd on top. The outer tones of a major or minor triad form a perfect 5th.

Example A



If we construct triads on the tones of the C major scale using only the tones of this scale, we obtain the following chords, which are called *diatonic* chords.

Example B



The triads built on C, F, and G are major triads—a major 3rd on the bottom and a minor 3rd on top. The triads built on D, E, and A are minor triads—a minor 3rd on the bottom and a major 3rd on top. The triad built on B is a diminished triad: it is made up of two minor 3rds.

In popular music, an alphabetical letter by itself indicates a major triad (note that the letter is always capitalized).

Similarly an alphabetical letter followed by “Min,” “Mi,” “min,” “mi,” “m,” or a dash (—) indicates a minor triad (I prefer “min”).

A diminished triad is indicated by the alphabetical letter followed by a small zero.

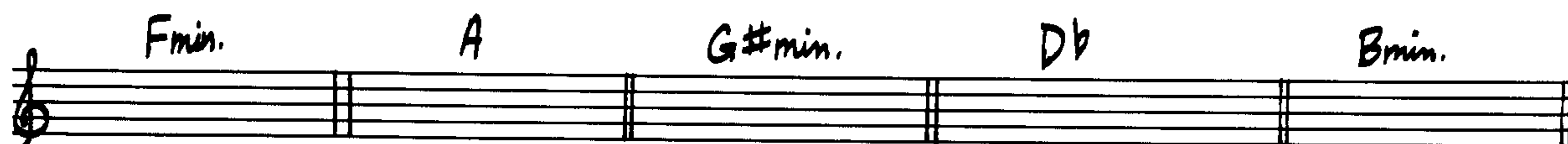
The seven triads of C major can be represented by alphabetical symbols as shown in Example F.

Write out the tones indicated by these chord symbols:



Now let us discuss chord progression, beginning with the movement of one chord to another. The diminished triad has been excluded from most of this book because it has implications beyond the more fundamental work we are concerned with here.

Major or minor triads derived from C major move freely among themselves. Movement between those chords built on the tones that are a perfect 4th or perfect 5th apart is strongest and most propulsive (see Example G, a). Next in strength is movement between chords built a 2nd apart (see Example G, b). The most neutral movement is between chords built a 3rd apart, especially in diatonic harmony; chords a 3rd apart have two tones in common (see Example G, c). Each type of movement is valuable in its own way.

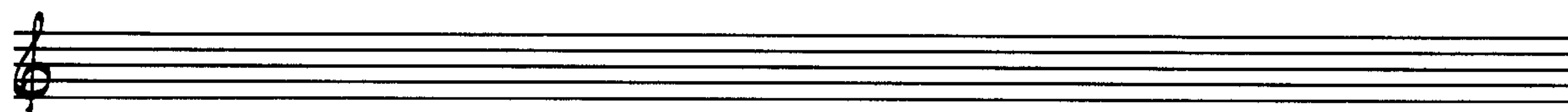


Exercise 2

Construct various two-chord progressions, using major and minor triads from C major as follows. (Place alphabetical symbols above the staff.)

Hint: Play these progressions over and over. Get to know them.



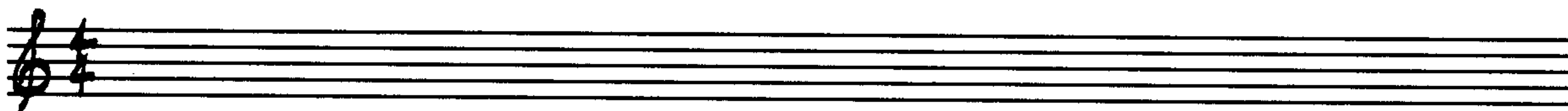
To construct a series of chords, let us begin with these guidelines:

Basic Rules for Diatonic Chord Progressions

1. Use only diatonic major and minor triads. These may move freely among themselves.
2. The first and last chord must be the triad built on the first step of the scale, the tonic.
3. The root of the next-to-the-last chord must move to the root of the last chord by an interval of a 2nd, 4th, or 5th from above or below.
4. Make sure that the roots of the chords (the tones on which each of the chords is built) form a singable line.
5. Construct your progression so that it points strongly “back home” to the tonic.

Exercise 3

1. Construct a chord progression of eight to ten measures in C major, one chord per measure.
2. Use only major and minor triads derived from the C major scale.
3. Express these chords as alphabetical symbols and give each the duration of a measure.
4. Apply the Basic Rules for Diatonic Chord Progressions.



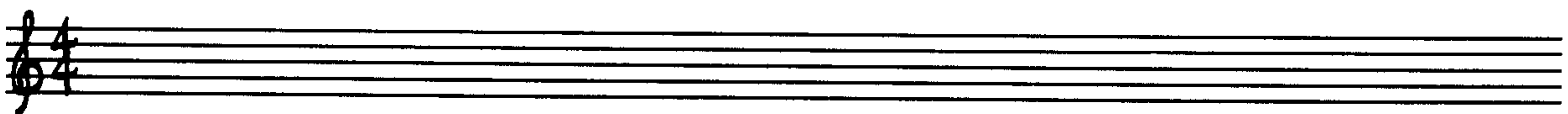
Example H shows the D Dorian scale followed by the diatonic triads built on each step. These triads are identical with those of C major because D Dorian and C major share the same tones.

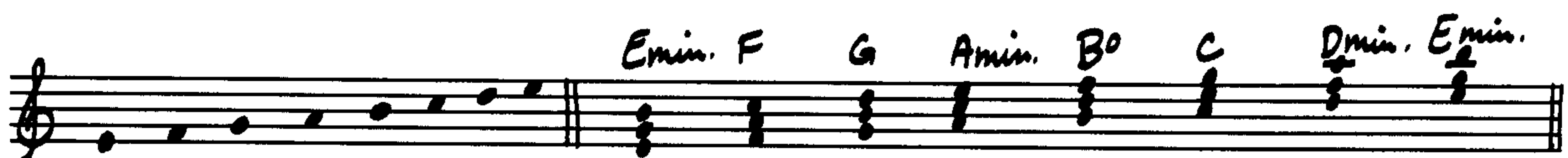
Exercise 4

1. Construct a chord progression of eight to ten measures in D Dorian, one chord per measure.
2. Use only major and minor triads from D Dorian.
3. Write the chords as alphabetical symbols.
4. Apply the Basic Rules for Diatonic Chord Progressions and be especially careful to maintain and support D as the tonic; use the D minor and A minor chords frequently; don't let the progression slip into C major.



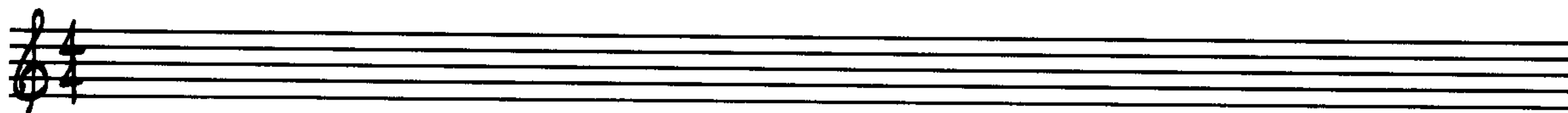
Here is the E Phrygian scale, followed by triads built on each of its steps. The chords here are identical with those of C major and D Dorian.

1. Compose a chord progression of eight to twelve measures in E Phrygian, one chord per measure.
2. Use only the major and minor triads (no diminished triads).
3. Use alphabetical symbols for this exercise.
4. Apply the Basic Rules again, and be very careful to stay in the key of E Phrygian by using the E minor and A minor chords frequently.



REDISTRIBUTION

A simple way to read chord symbols at the piano is to play the triad in the treble clef and the root of the chord in the bass clef:

It is easier to play chords in this way if the tones in the right hand (the treble clef) are closer together than in the preceding example. In Example K, I have redistributed the tones of some

chords (marked with an asterisk) in order to keep the right hand within as small an area as possible. The root of the chord is still in the left hand.

3. Play these chords at the keyboard. Redistribution is sometimes weak; be sure it sounds right.

NONDIATONIC CHORD PROGRESSIONS

Until now our chord progressions have been diatonic—drawn solely from the tones in the C major scale. The progression in Example L begins and ends with a C major triad, and it establishes this chord as the tonic, but it contains several chords that are nondiatonic. Note that all the chords are major triads. Play the chords and then play the roots alone.

Examples L and M demonstrate a simple rule: Chords of the same type move freely among themselves (a major triad goes freely to

any other major triad; a minor triad goes freely to any other minor triad).

When we combine this simple rule with the Basic Rules for Diatonic Chord Progressions, a new set of rules is created that covers a lot of ground. These rules will protect you from some of the basic mistakes that students usually make and they will still allow you to be imaginative and creative.

Basic Rules for Mixed Progressions

1. Use only major and minor triads.
2. Begin and end with a tonic triad (for our purposes, this will be C, D minor, or E minor, from C major, D Dorian, or E Phrygian, respectively).
3. Diatonic triads from within the key may move freely among themselves.
4. A chord of one type may move freely to any other chord of the same type—that is, a major triad, whether it is a diatonic or nondiatonic triad, may move to any other major triad, diatonic or nondiatonic.
5. The root of the next-to-the-last chord must move by 2nd, perfect 4th, or perfect 5th (from above or below) to the root of the last chord.
6. The roots of the chords must support the tonic, and they must form a singable line.

Hint: Fast tempos require simpler progressions and fewer chords than slow tempos.

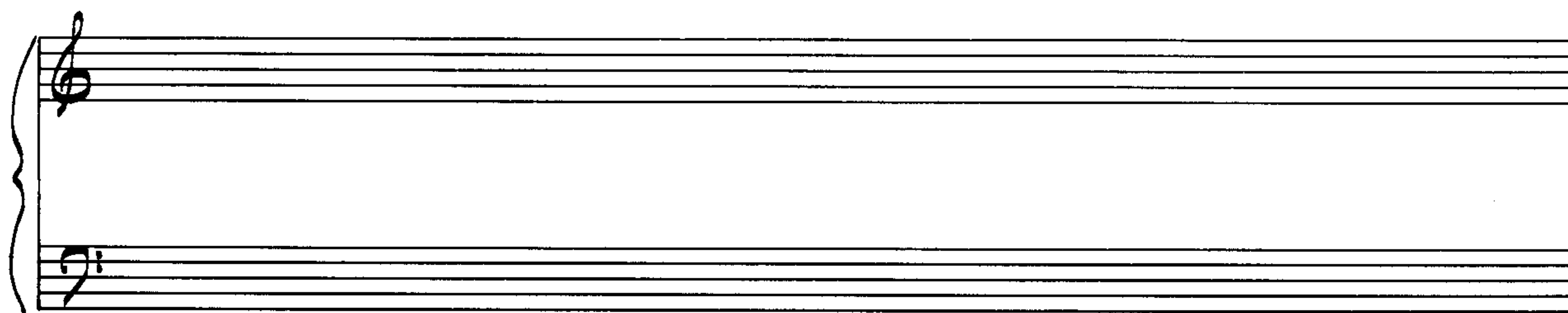
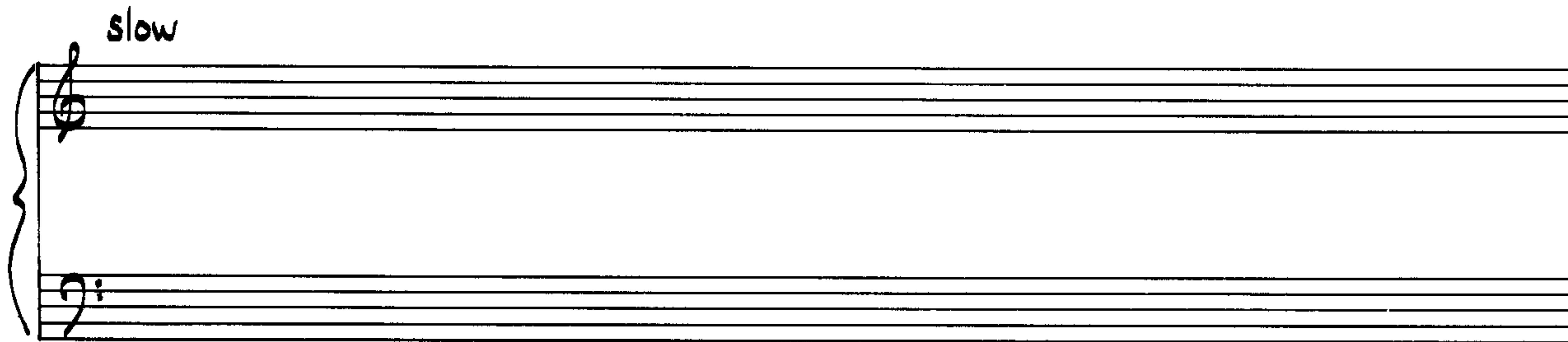

MELODY AND HARMONY

To harmonize a melody, you must find chords that contain the melody tones and that also follow one of the two sets of rules thus far given. For now, let us use the expanded rules—the Basic Rules for Mixed Progressions.

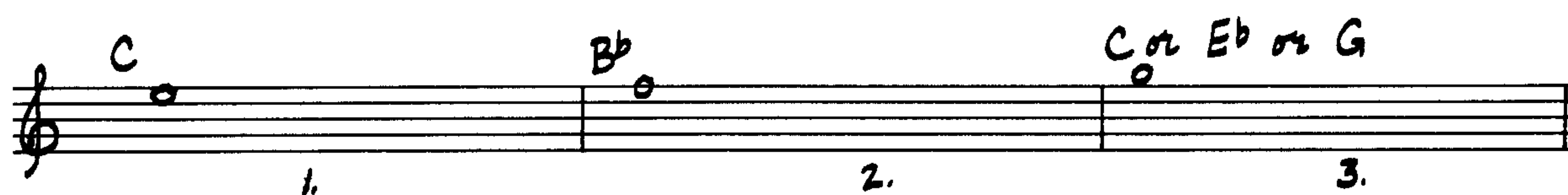
The C major chord in measure 1 in Example P may be followed by either a diatonic triad or a nondiatonic major triad. The tone F in measure 2 is a chord member of two diatonic triads, D minor and F major, and of two nondiatonic major triads, D[♭] B[♭].

Let us say that you choose to use a B^b major triad for measure 2 of Example P. This decision means that in measure 3 of Example Q you must go to a major triad—one that contains the melody tone G:

The next task is to harmonize two tones per chord, both of which must be members of the same chord. RETROGRADE

Retrograde is another form of transformation. In Example D, you see Example A from back to front; all the tones and rhythms are the same but are reversed.

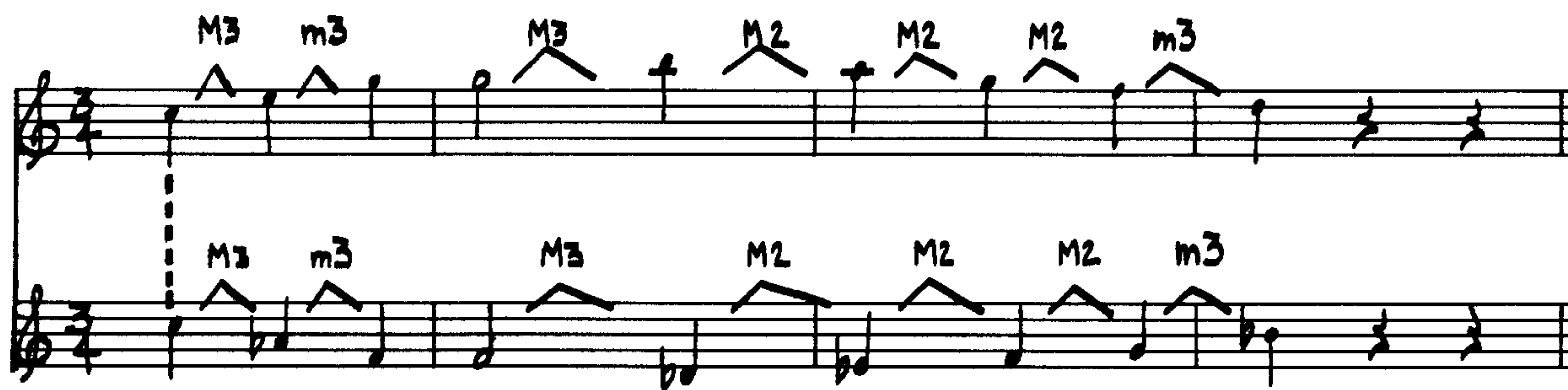
In Exercise 4 you have constructed a *palindrome*, which is a melodic phrase that reads the same backward and forward. In language, familiar palindromes are “Madam, I’m Adam” and “A man, a plan, a canal, Panama.” Palindromes are good examples of how transformation can be used to obtain new material.

Always remember that the retrograde may not be interesting to you or that you might like the retrograde better than the original and thus not use the original series of tones at all.

INVERSION

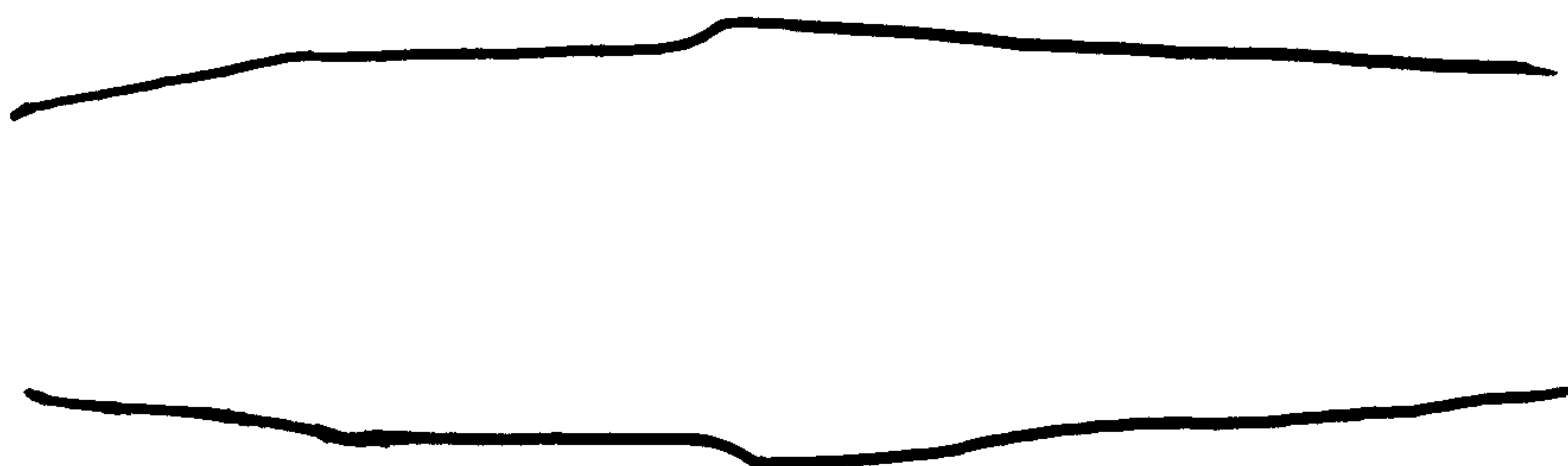
Inversion is another transformational form. Exact inversion consists of exactly mirroring the original; a major 3rd up in the original requires a major 3rd down in the inversion, and so forth. In Example E, the lower staff is an exact inversion of the upper. The two are not meant to be played simultaneously.

You don't always have to increase the value of the notes by the same proportion. Sometimes you can increase the value of some

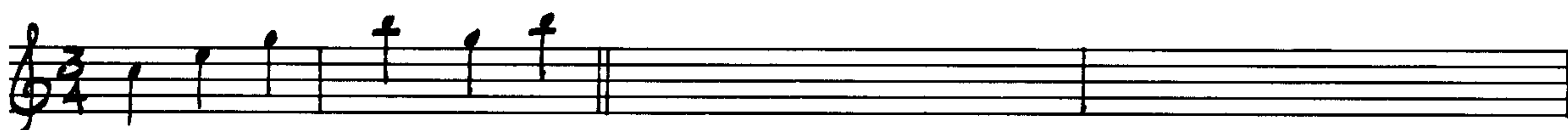

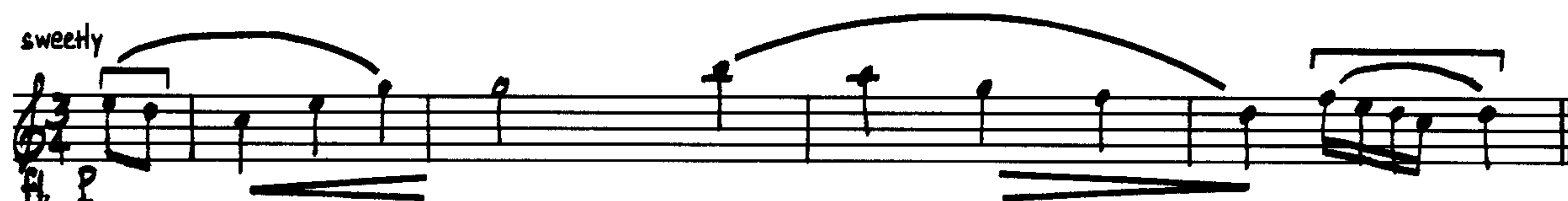

ADDITION AND SUBTRACTION

The next transformational procedure consists of *addition* and *subtraction*, as shown in Example S, in which tones are added to the figuration of Example A.

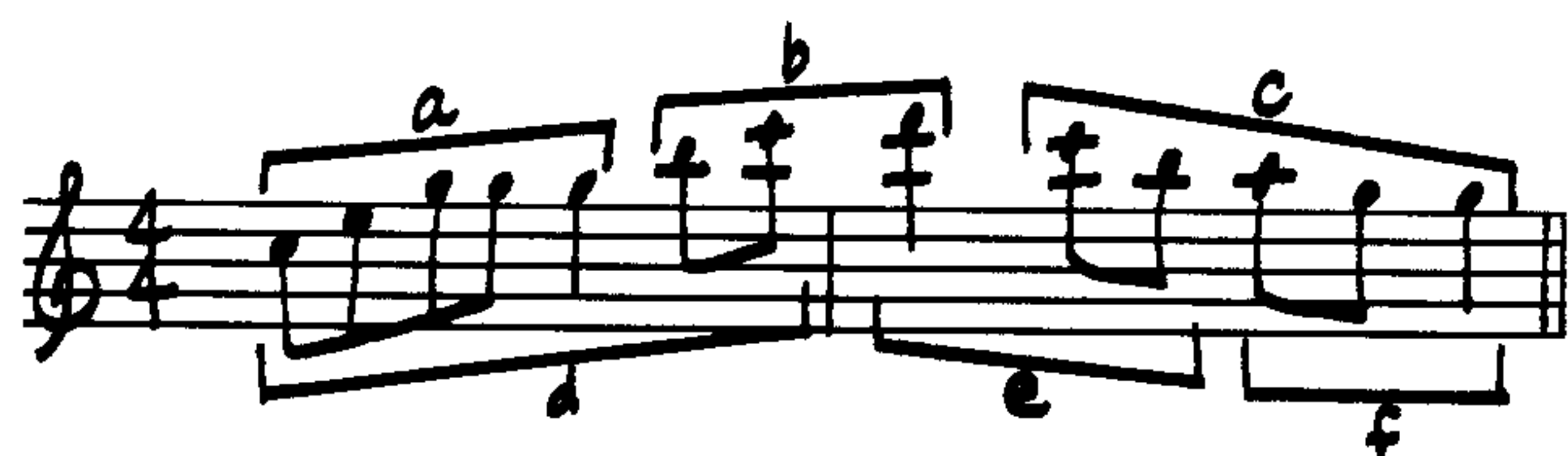

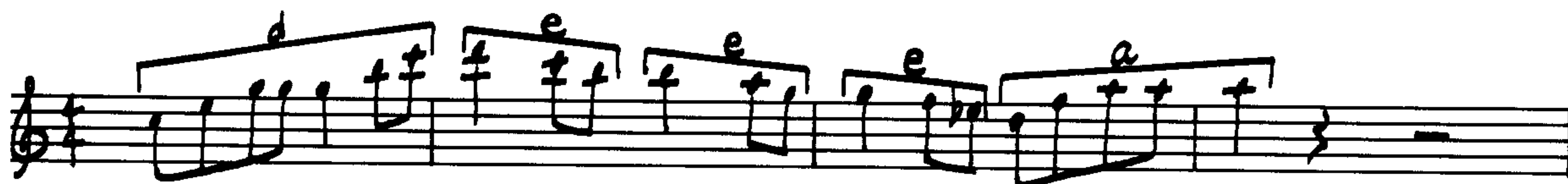

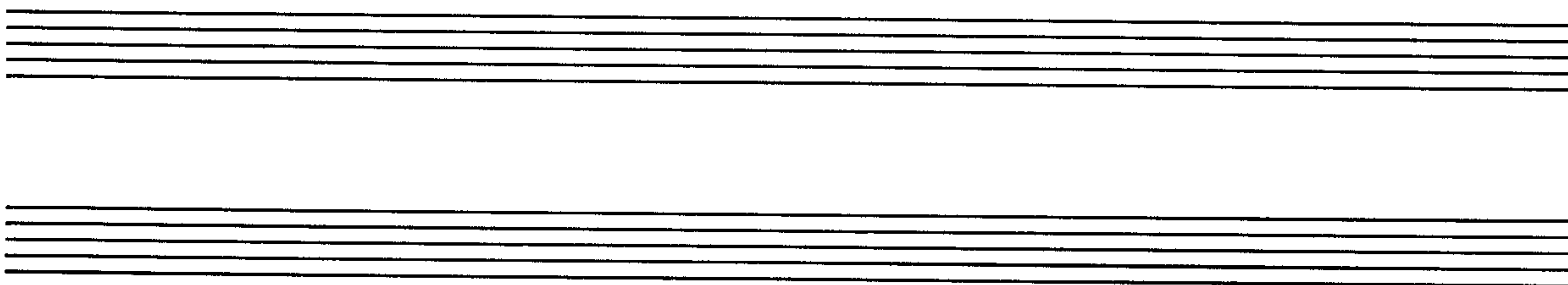

Finding subfigurations and then working with them is an especially rewarding procedure. You will see its compositional relevance in Chapter 4, which deals with the small theme, as well as in later chapters.

APPLICATIONS OF TRANSFORMATION

Transformation is a valuable technique that has several purposes. As suggested earlier, by using the transformational process you will be able to work with and improve your original inspiration.

Secondly, by using it you can alter your initial idea so that it will fit in better with your larger plans. Transformation will also create new material by stretching out an idea. Finally, it will allow you to achieve unity and integrity in your work. If the first theme of your work is outstanding and it also sounds good when inflected, by using the inflected theme later you are adding variety to your piece. These two concepts of unity and variety, which you have heard countless times, will now perhaps assume a clearer meaning.

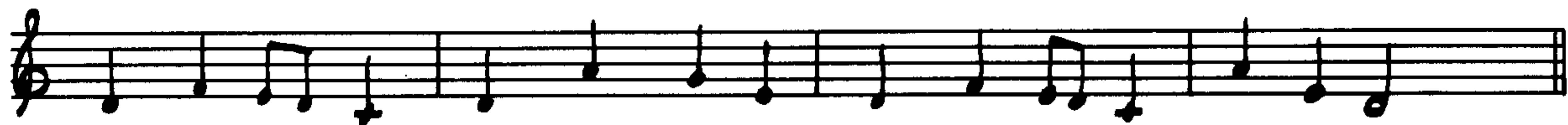

The Small Theme and the Large Theme

THE MOTIVE AND THE SMALL THEME

The *small theme* starts with the *motive*, which is a series of tones distinct in shape and yet incomplete; it is usually one or two measures long.

Example A shows a small theme made up of one motive, *a*, repeated exactly and also repeated in transposed form. Note that the transpositions are *tonal*—that is, they correspond to the scale of D Dorian—and that some are exact transpositions and some are inexact. Transpositions of a motive are called *sequences*. In Example A both exact repetitions of the motive and sequences are labeled *a*.

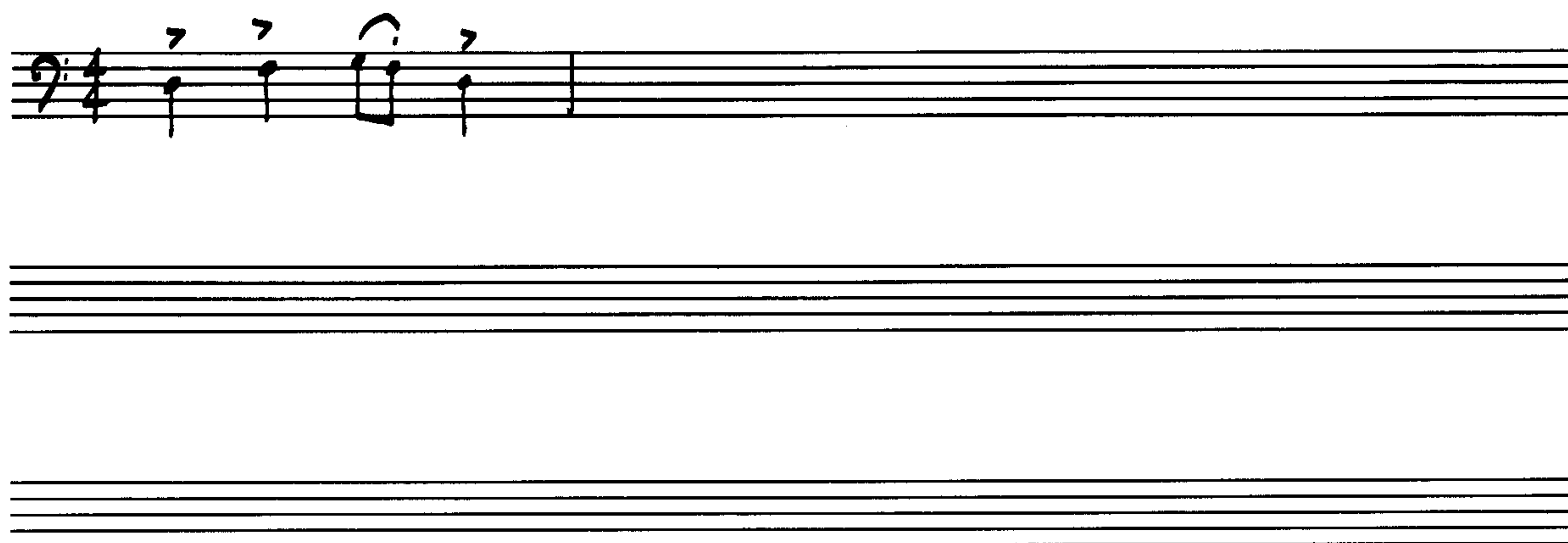

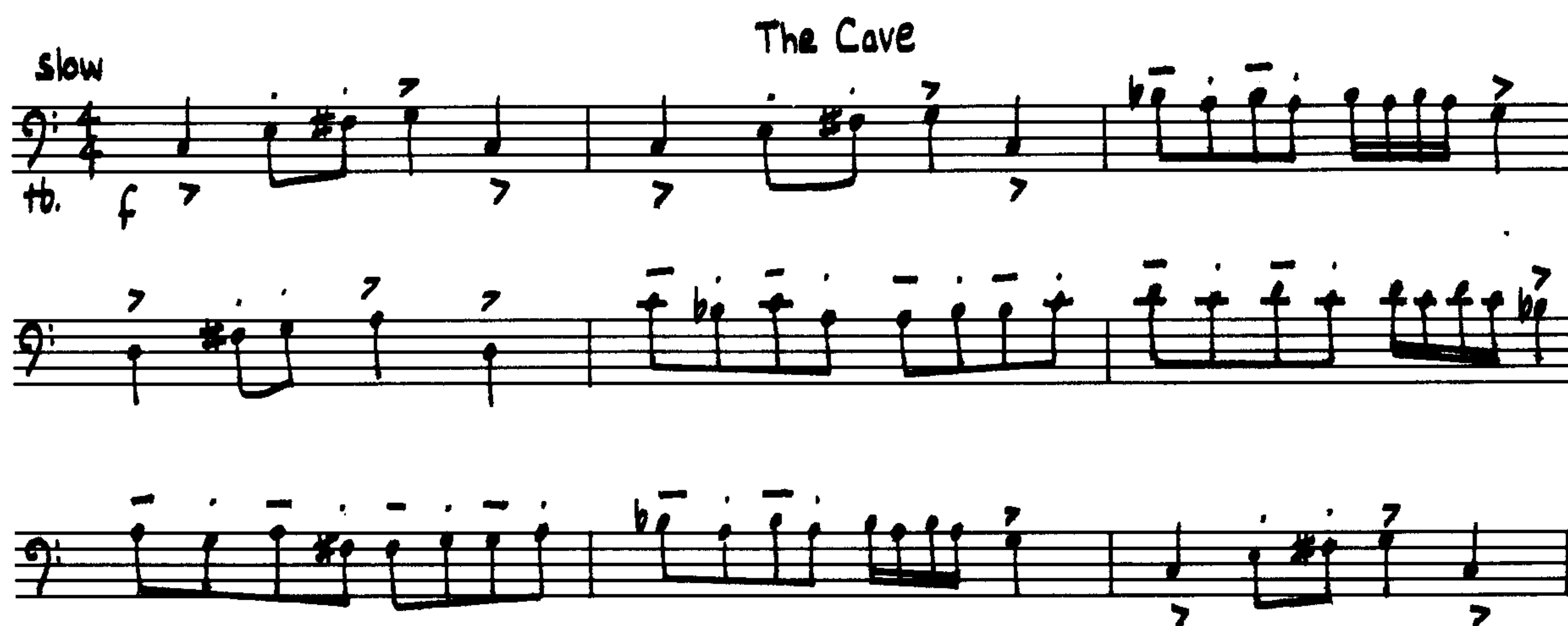

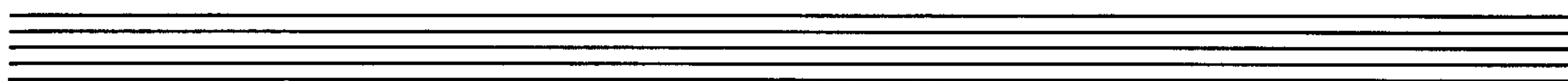

MORE ON THE SMALL THEME

Many arrangements of motives are possible in the small theme. A particularly demanding arrangement is *a a b a*, shown in Example C, in which the *a* has three different functions: in measure 1 it constitutes the opening, the beginning; in measure 2 it is a continuation and must lead to *b*; in measure 4 it closes off or concludes the theme. This is a good example of *context*: one motive has three different functions and is heard or perceived in three different ways.

THE LARGE THEME

The small theme in Example E is made up of *a b a c*. Note that it ends on a tone other than the tonic, which makes it unclosed and incomplete:

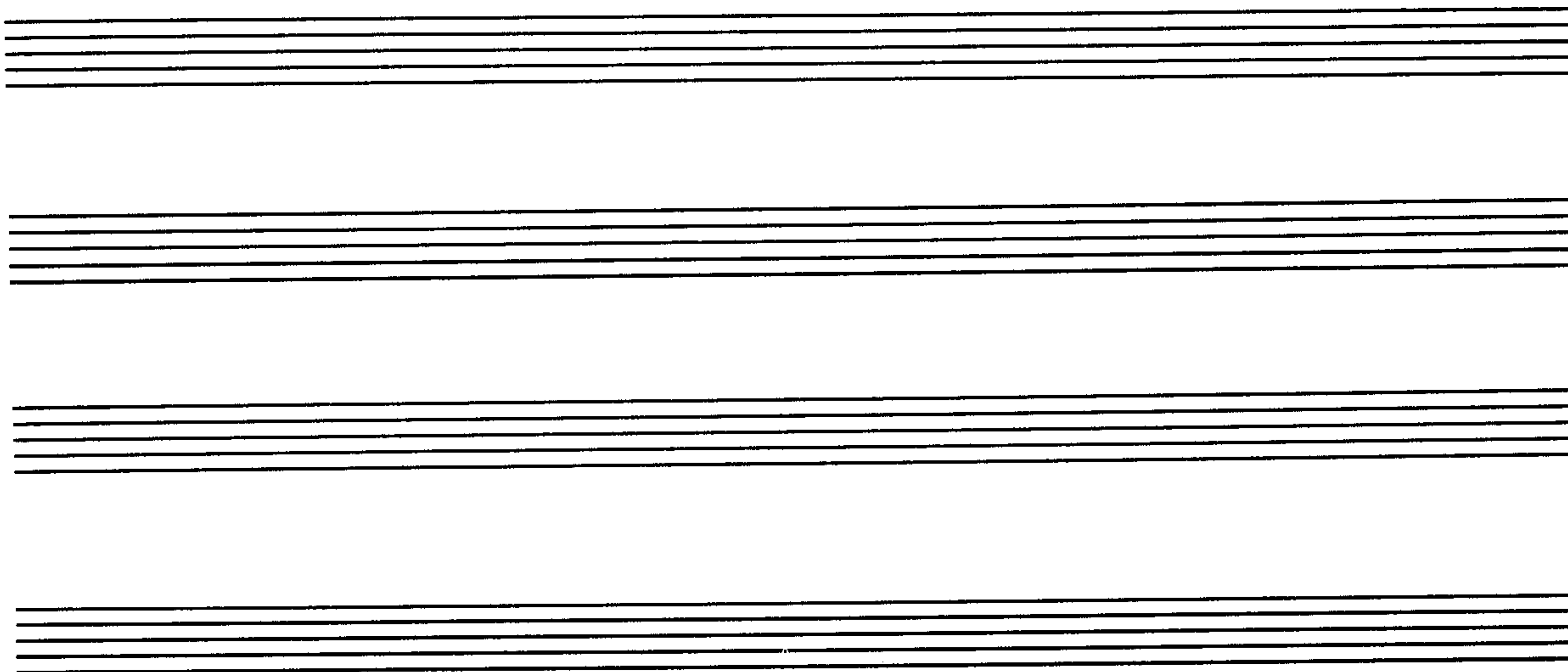

The large theme form, AA, is very useful, and it leads us to the fundamental, numero-uno, large-theme form—ABA. An ABA form is made up of one small theme, followed by another small theme, and a return to the first small theme (perhaps altered toward the end):

THE LARGE THEME, HARMONIZED

These two large-theme forms, the AA and the ABA, are basic to composition, as is the AABA, which is used very frequently in popular music.

The large-theme form can be viewed from the harmonic as well as from the melodic standpoint, using the AABA form and restricting ourselves to the tones of the C major scale, melodically and harmonically (except for the B diminished triad, which will not be used here or elsewhere). The following guidelines will be useful:

Guidelines for Harmonization of the Large Theme

1. Begin each A section with a C chord—the tonic.
2. End the first A section with a C chord, or with D minor, F, or G—the three chords that push back to the tonic.
3. Begin the B section with any of the six available chords, but end it with one of the “pushing chords” (D minor, F, or G).
4. If the B section begins with a C chord, end the second A section with a pushing chord or a C chord.
5. If the B section begins with a chord other than a C chord, you must end the second A section with a C chord.
6. End the last A section with a C chord.

The following example adheres to these guidelines. It is very simple, even more simple than a folk song, but it is a good place to start since it clearly illustrates the relationship between melody, harmony, and form in the construction of a large theme. Note that in this case the motives often begin on the third beat of the measure, whereas until now most motives have begun on the first beat of the measure.

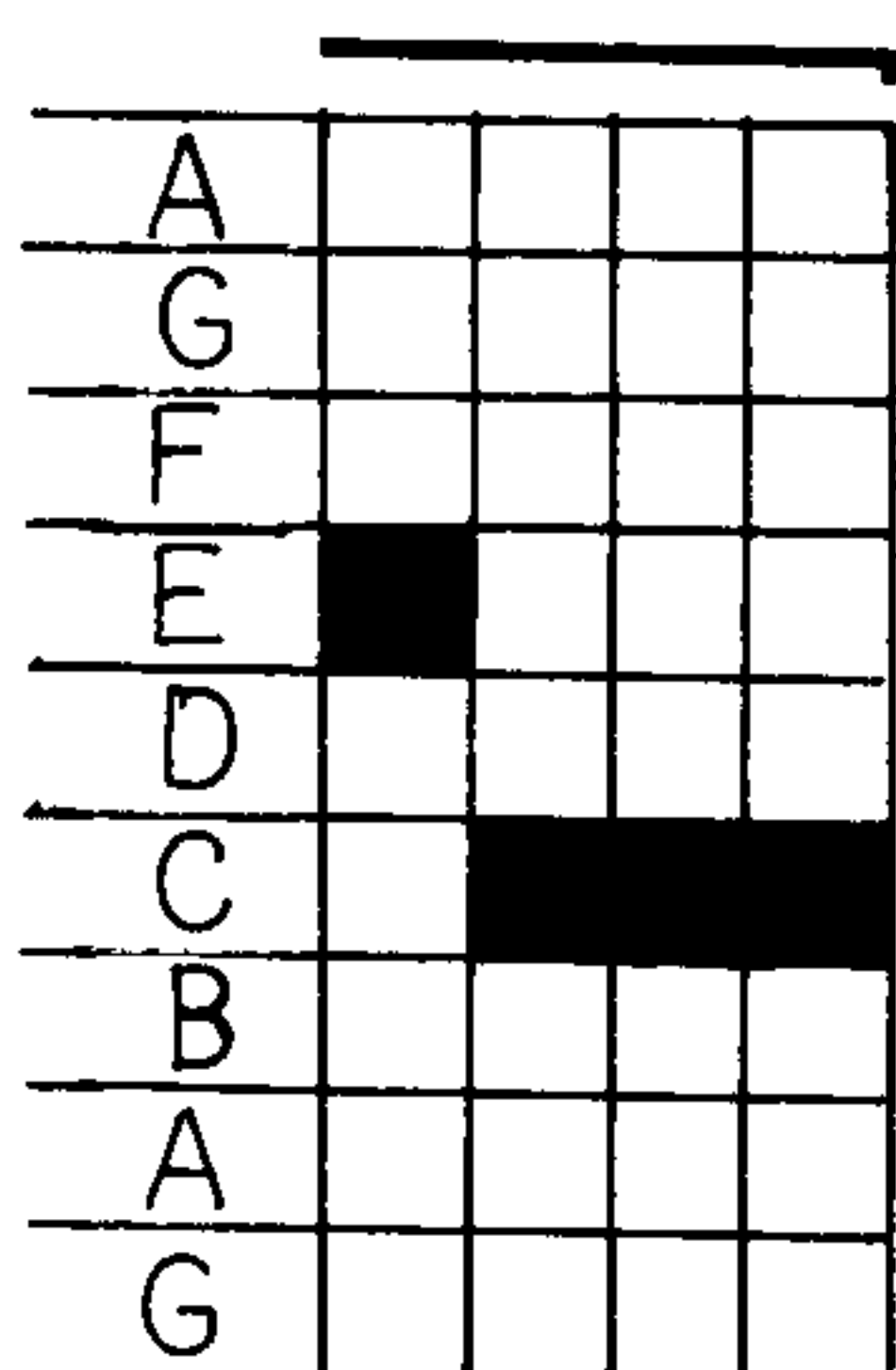
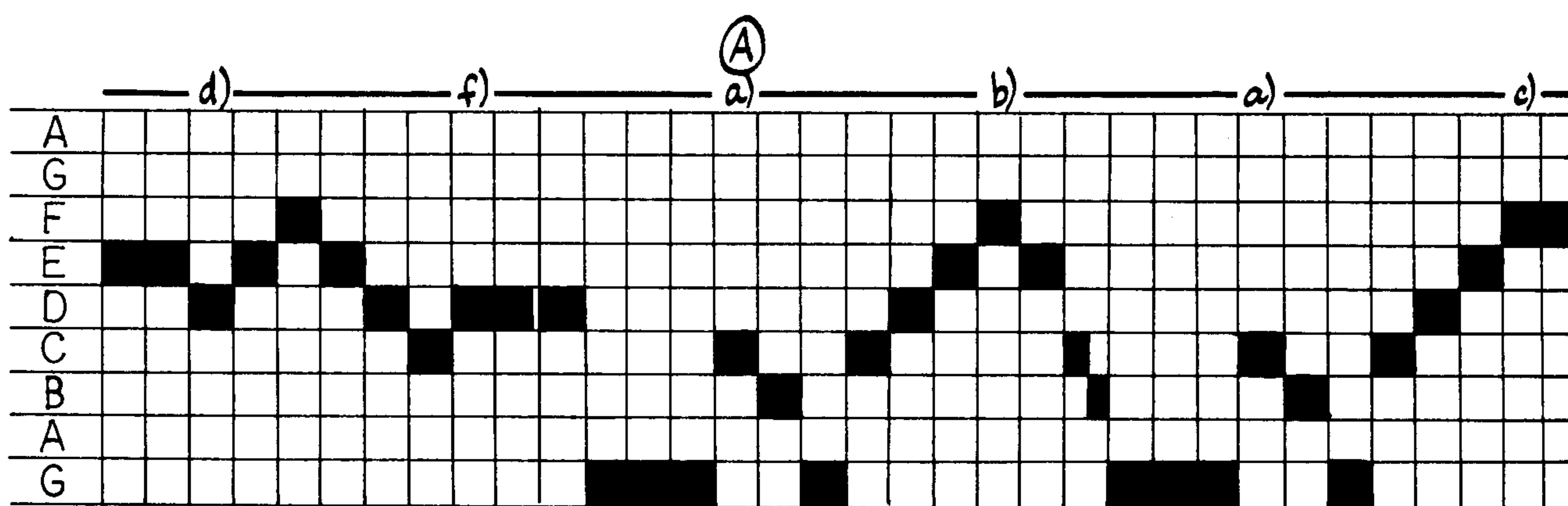
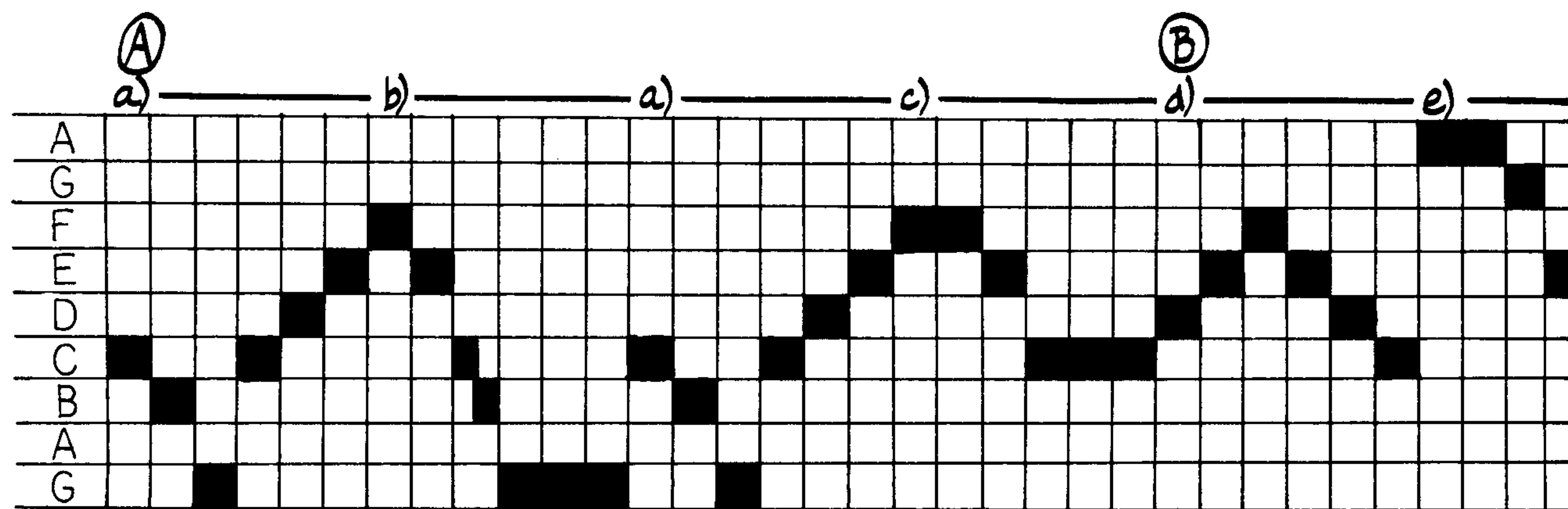
The guidelines for the harmonization of the large theme are designed to keep you tightly reined, so that the relationship between melody, harmony, and form can be controlled carefully. But you should feel free, later on, to use nondiatonic chords, as per the Basic Rules for Mixed Progressions.

When you use these rules, Instead of limiting yourself to the “pushing chords” in C major—D minor, F, and G—you may use any chord that has a pushing function. In other words, you may use any chord derived from the Basic Rules for Mixed Progressions that is built on the tone a major or minor 2nd or a perfect 4th or a perfect 5th above or below the tonic. And you may also use D as the tonic, in D Dorian, and E as the tonic, in E Phrygian.

VISUAL FORMS OF MELODY

Making a graph of a melody is very useful because it reveals something about the shape of the melody. In the following graph, I have shown the melody from Example G.

Example I



A good melody generally has an upper curve and a lower curve. In other words, its highest tone occurs a little after the midpoint. The upper curve is more important than the lower curve. Both curves occur gradually, and you will note that there are smaller curves within the main curve.

These are general observations about melody; not all melodies fit these observations, but they will guide you in composing a melody, and they will help you to improve your melody when it seems as if something is lacking.

The most important thing about melody writing is that it must come from your voice and from your vocal capabilities. You must be able to *hear* what you write, and you should also be able to sing it. If your ear and voice need improvement, this is the time to begin. There is no better way to help your ear and your voice than to sing what you compose and to compose only what you can sing. There is no better way to help your composing.

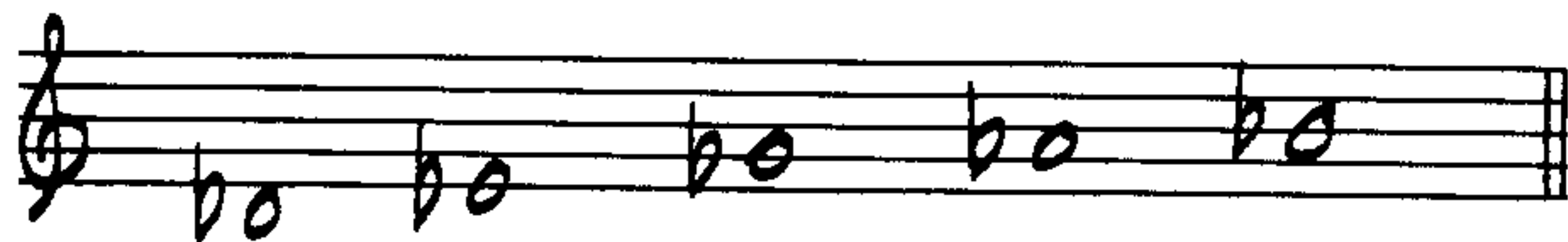

More Scales and the 12-tone Row

THE PENTATONIC SCALE

This is the pentatonic scale, which is made up of five tones. It consists of the black keys on the piano:

Example A



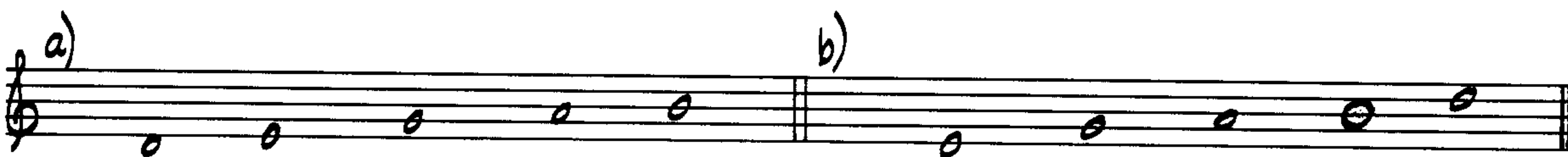
Since this book uses as few flats and sharps as possible, let us raise this scale a minor 2nd by taking away all five flats:

Just as the C major scale may be arranged in more than one order (D dorian, E Phrygian), so may the pentatonic scale:

The most “American” form is the E pentatonic scale, as shown in b, Example C.

THE DITONIC SCALE

THE 12-TONE ROW

The row was introduced in Chapter 1. The 12-tone row was formulated by Arnold Schoenberg early in the twentieth century. Example J shows such a row, consisting of all twelve tones found in the chromatic scale.

To compose a melody from such a row, you must use the tones only in the original order (1 2 3 4 5 6, and so on). However, you may repeat a tone consecutively (1 2 3 3 3 4 5, and so on). You may use tones from the row in any octave. Example K shows a melody based on these simple rules, using the row shown in Example J.

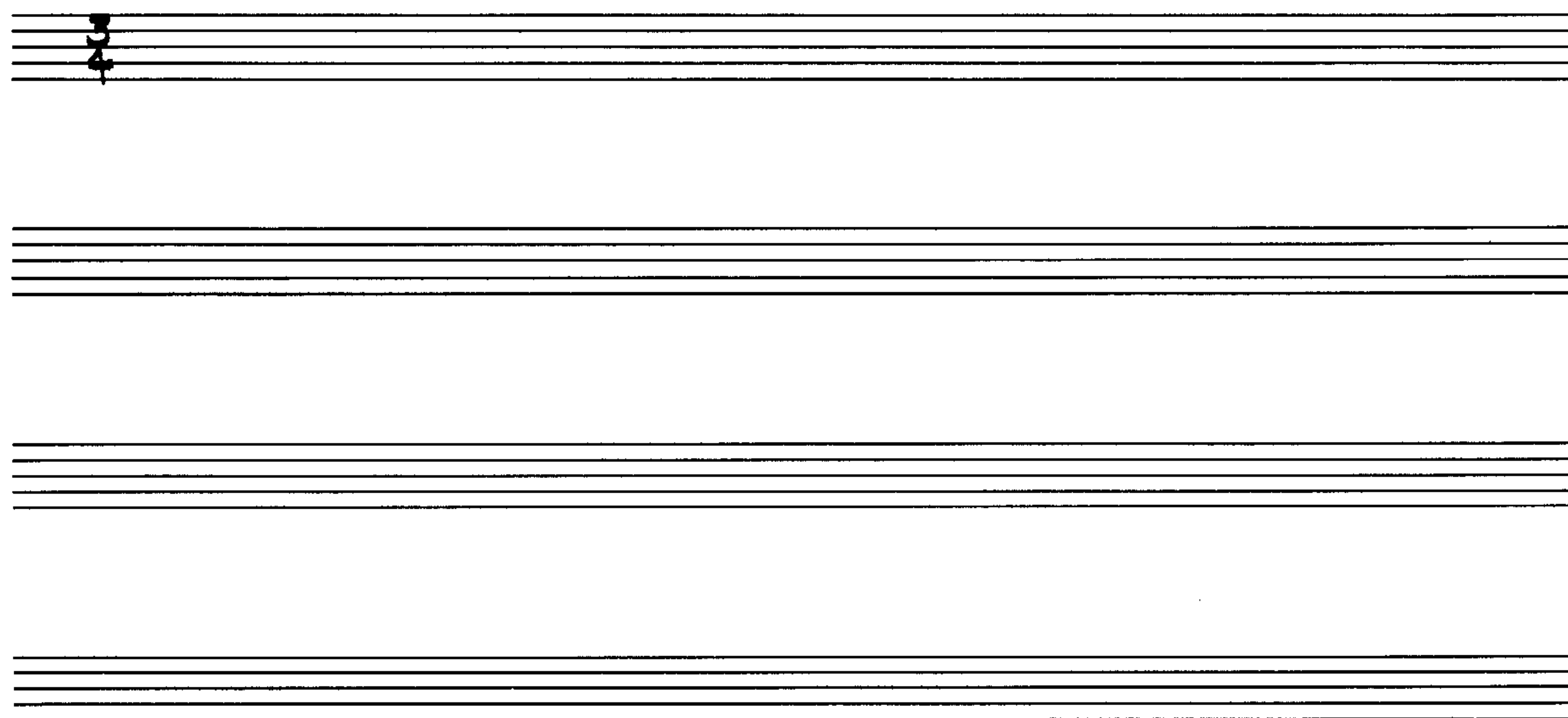

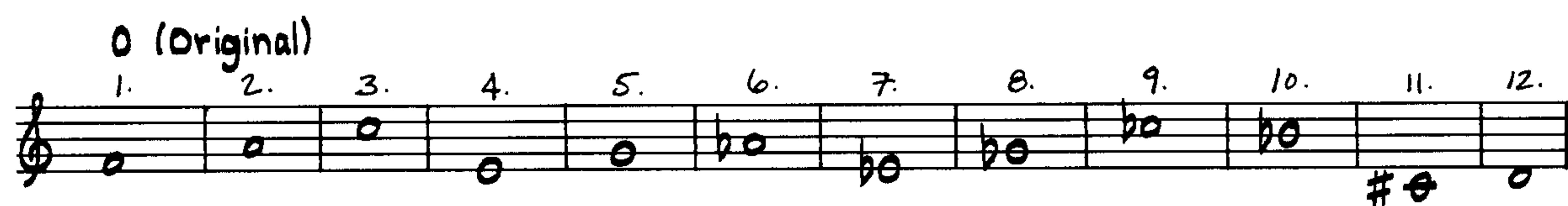

Sometimes these four forms are used consecutively, in a single voice. Sometimes the original is used in one voice, the retrograde in another, and so on. It is also possible to use the row vertically—that is, as chords. This subject is discussed indirectly in Chapter 9.

1. Compose a piece of forty to sixty measures, based on the four forms of the row shown in Example L.
2. Divide the row into four sections, each of approximately the same length. Use a different form of the row in each of the four sections. For example, O I R RI or R RI O R, and so on.

Make sure you are able to hear what you compose and that it sounds right to you.

Isomelody and Isorhythm, Combined

ISOMELODY

An *isomelody* is a series of tones that is repeated one or more times. Example A shows a six-tone isomelody:

Example A



Note that tones 1 and 4 are the same, as are tones 3 and 5. Example B shows a melody that is made up of the tones of the isomelody:

Example B



In an isomelody, one tone may be used more than once, as in Example B, but each tone of the isomelody may be used only as originally given (1 2 3 4 5 6 always; never 1 1 2 3 4 4 5 6). You

may not use octave forms of the tones in an isomelody. In these two respects, the isomelody is different from the row (Chapter 1) and the 12-tone row (Chapter 5).

Exercise 1

1. Compose a theme that is ten to twenty-six measures long, based on the isomelody given in Example A.
2. Use the tones in the order given (1 2 3 4 5 6). Repetition of tones is not permitted (1 1 2 3 4 4 5 6). You may not use octave forms of the tones.

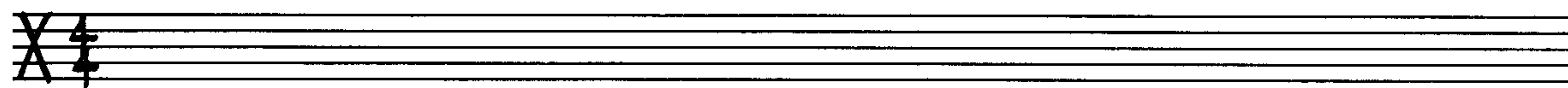

ISOMELODY AND ISORHYTHM COMBINED

If an isomelody of four tones is combined with an isorhythm of four notes exact repetition is achieved; the isomelody and the isorhythm are “in-sync”:

An isomelody and isorhythm that are “in sync,” as in Example D, constitute an *ostinato*—a form that will be dealt with separately in Chapter 7.

If the isomelody and isorhythm are “out of sync,” they form patterns that first change and then come together:

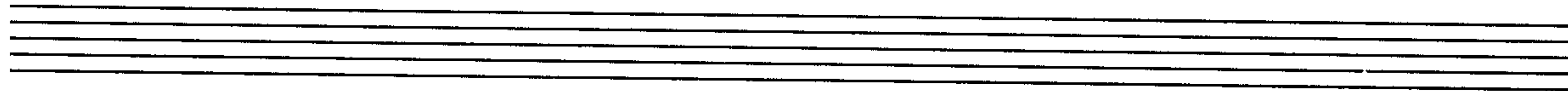

In Exercise 5 the original form of the combined out-of-sync isomelody and isorhythm will come together after twenty beats. 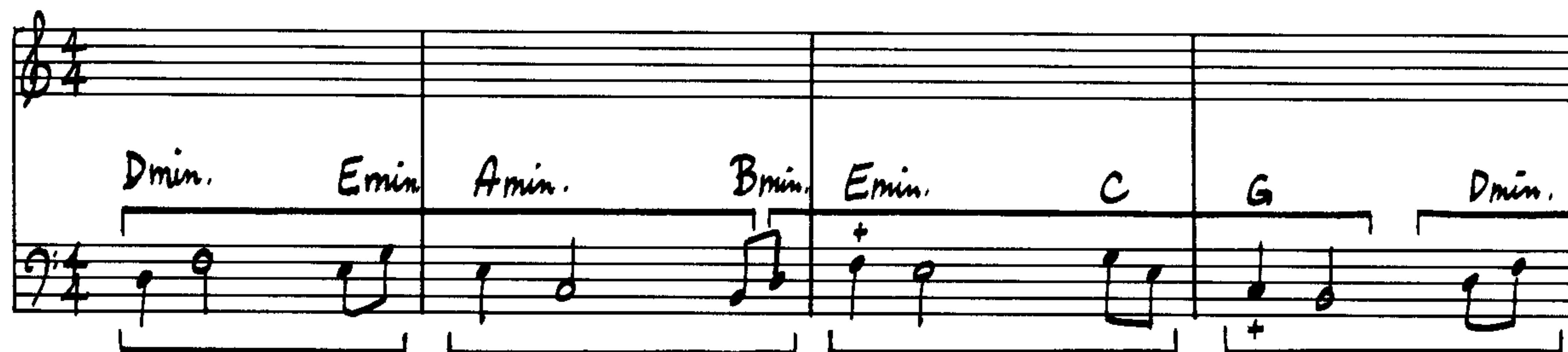

Ostinato

OSTINATO AS ACCOMPANIMENT

The *ostinato* consists of an isomelody and an isorhythm that are in sync.

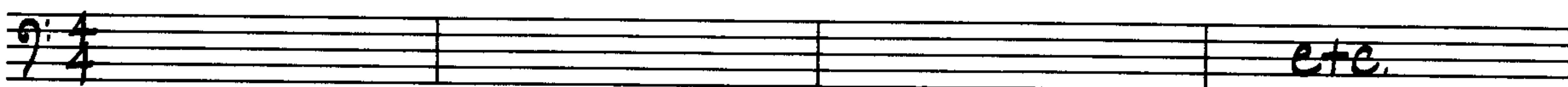
Example A



It is usually—but not always—a lower part, and it is often assigned to a bass instrument, such as the tuba, double bass, or bassoon.

Exercise 1

OSTINATO LINKED TO THE HARMONY

Exercise 4

OSTINATO RESISTING THE HARMONY

Ostinato works well when it resists chords, too; the chords change but the ostinato keeps repeating without change. (Incidentally, *ostinato* is the Italian word for “stubborn” or “obsti-

nate".) Notice that the ostinato seems to sound *different* when the chord changes (another example of *context*) and that the tension increases, especially in measures 5 and 6:

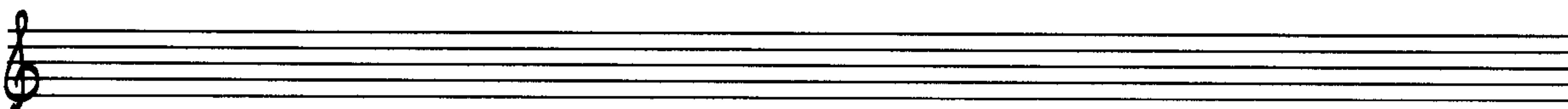
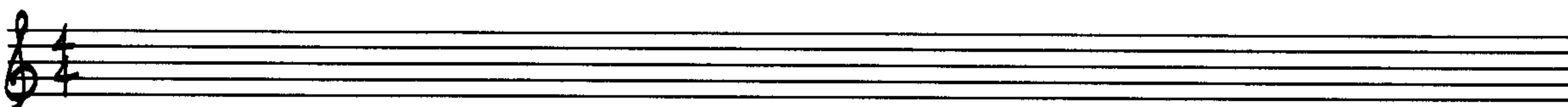
A good way to compose melody and ostinato *without* chords is to use a simple cell, such as the one made up of the notes E, A, and B shown in Example F. This kind of cell produces very little friction between melody and ostinato, and your ear alone should be able to guide you. This procedure does not, however, work with all cells for reasons that are explained in Chapters 11 and 12.

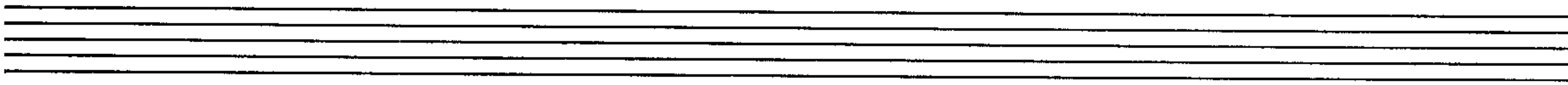
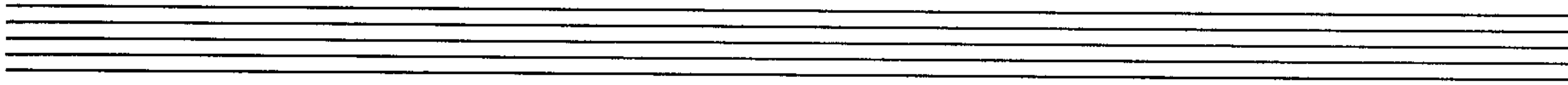

Accompaniment Procedures

FORMS OF THE “OOM-PAH”

A basic accompaniment figuration is the “oom-pah”; it is named after the marching-band style in which the tuba plays the “oom” and the horns the “pah.” (This accompaniment is surprisingly simple, but I didn’t recognize its usefulness until late in my own career.)

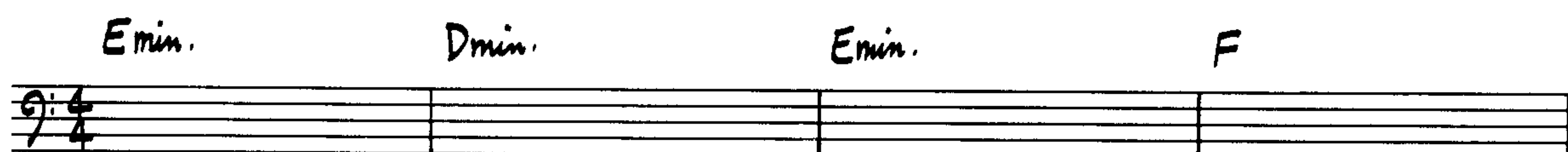

For now, think of it as a piano part, left hand only, with the “oom” as the root of the chord and the “pah” as the 3rd and the 5th.

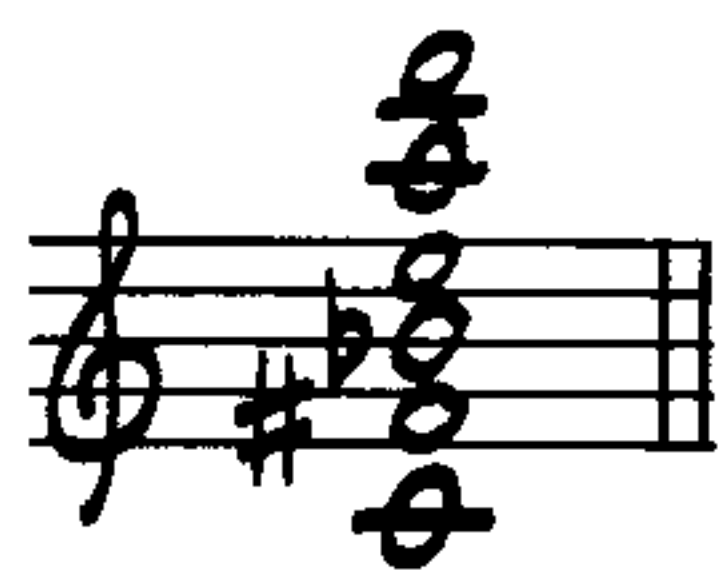
There are two more points I would like to make about accompaniment and harmony. First, sometimes the accompaniment and melody are based on a cell or a scale instead of on a chord (see pp. 79–80 for examples). Second, sometimes the accompaniment is made up of only one chord—a topic dealt with in Chapter 9.

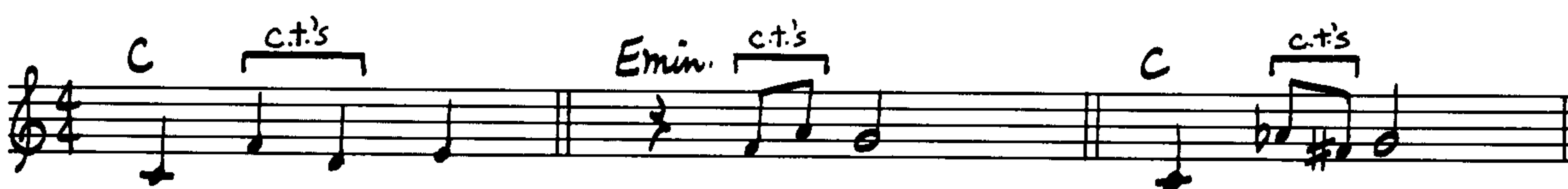
MORE NON-CHORD TONES

The work you have done in the first part of this chapter has been severely restricted to chord tones. Now let us turn to non-chord tones, a topic that was first discussed in Chapter 2.

We have seen how non-chord tones can open up a melody, even within the modest harmonic framework so far developed. A melody made up exclusively of chord tones tends to be solid, but solidity is not always interesting. Non-chord tones add tension and excitement when used carefully; used carelessly they tire the ear.

Changing tones are two tones, neither of which is in the chord, that are built a major or minor 2nd below and above (or above and below) a chord tone, to which they “resolve”:

An *escaped tone* is a non-chord tone that moves from a chord tone by skip and proceeds to another chord tone by skip. It has escaped from the chord and is the *hottest* form of non-chord tone, particularly when it is nondiatonic (as in c in the following example):

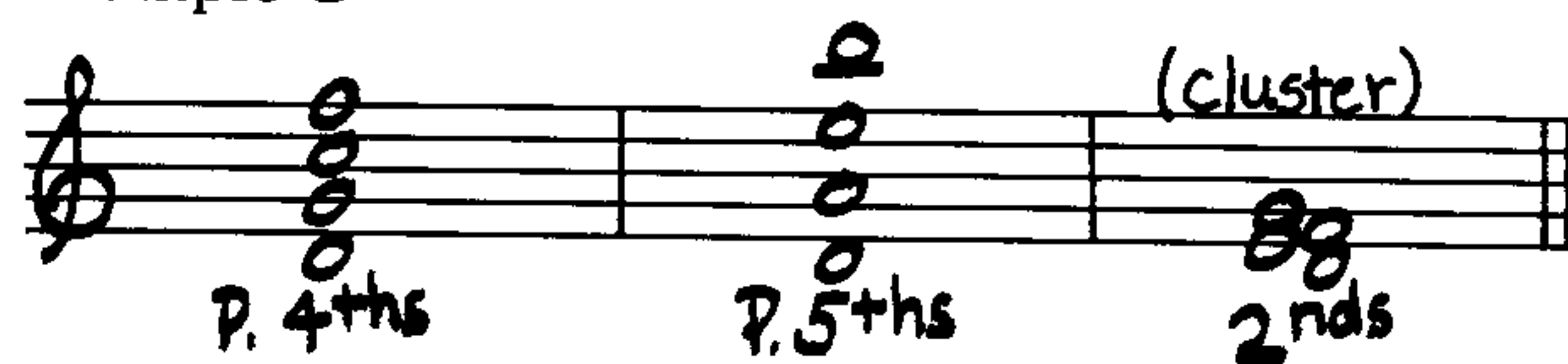
Hint: A non-chord tone should never be longer than a 1/4 note in moderate 4/4. This applies especially to nondiatonic non-chord tones and to changing tones, escaped tones, and reverse neighboring tones, all three of which tend to cloud the harmony.

DIATONIC NON-3RD CHORDS

Early in this chapter I introduced chords constructed of intervals other than 3rds. These chords are called *non-3rd chords*; even though they may contain 3rds, they are not built exclusively of 3rds.

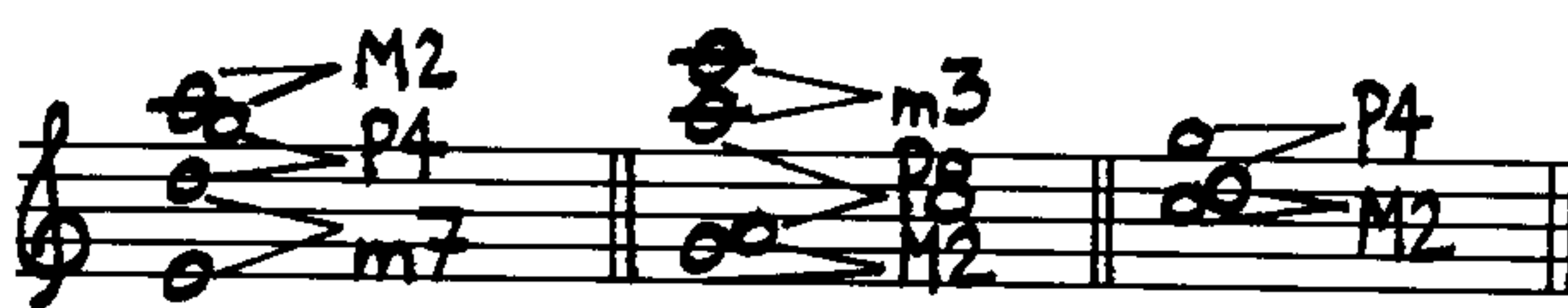
Example G shows chords built entirely of 4ths, 5ths, and 2nds—using tones only from the C major scale. Chords built of 2nds, or mostly of 2nds, are called *clusters*. Play those chords and get a feeling for their uniqueness.

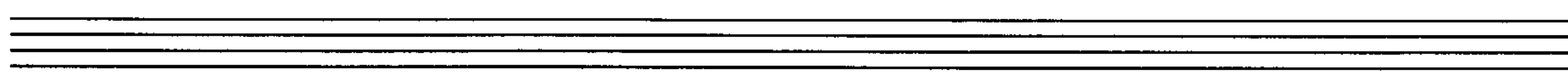
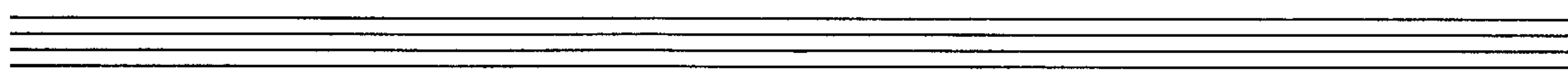
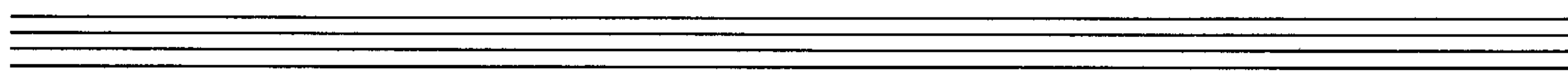
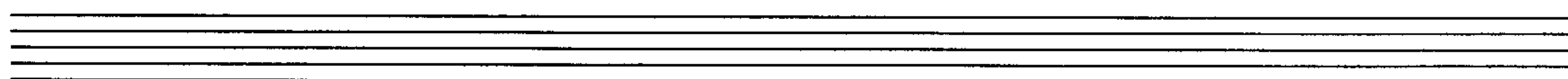
DERIVING NON-3RD CHORDS FROM A DIATONIC MELODY

Sometimes we reverse the procedure seen in Exercises 9 and 10, and we derive the chords from the melody. The melody in Example K is composed of tones from the C major scale; they center around the tone A, which becomes the tonic. The chords, stated in the form of oom-pah, are made up of tones from the melody; they do not contain these few tones marked with crosses, which should be thought of as non-chord tones. Note that the chords in measures 2 and 6 contain tones from measures 1 and 5 respectively, and that all of the chords are made up of three tones, except for the last chord, which has only two tones:

Of course, you may also derive 3rd chords from diatonic melodies, and you may derive a mixture of 3rd and non-3rd chords from diatonic melodies—in any of the twelve keys. This is a subject I can only touch on here.

These procedures—composing melodies and chords that are restricted to one key—are often referred to as “white-note fever.” I like these procedures, and urge you to use them, but this uncharitable phrase will perhaps remind you of the excesses to which they can lead.

DERIVING CHORDS FROM NONDIATONIC MELODIES

The procedure of deriving chords from melody is also applicable to *nondiatonic* melody, as Example L shows. Note that (1) the chords move one to the measure; (2) tones not included in the

chord are a $\frac{1}{4}$ note or less in duration; and (3) tones not in the chord move by major or minor 2nd to ones that are included in the chord.

Counterpoint

1:1 COUNTERPOINT AND CONSONANT INTERVALS

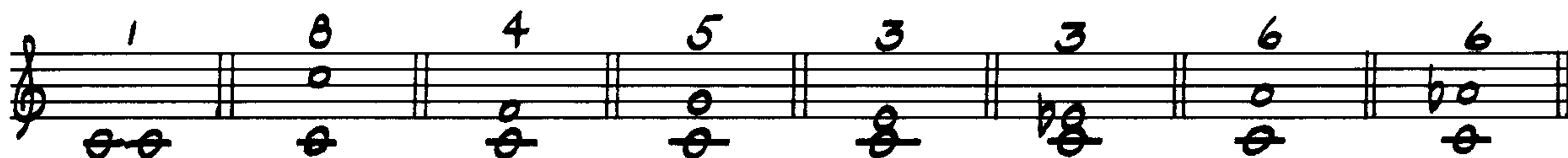
Counterpoint consists of two or more melodies sounded at the same time. The simplest form of counterpoint is made up of two melodies with identical rhythms. This is called one-to-one counterpoint (or 1:1 counterpoint).

When the notes are of long duration, the intervals between the two melodies (or *parts*, as they are called in counterpoint) should be “consonant.” The consonant intervals are:

- perfect unison
- perfect octave
- perfect fourth
- perfect fifth
- major or minor third
- major or minor sixth

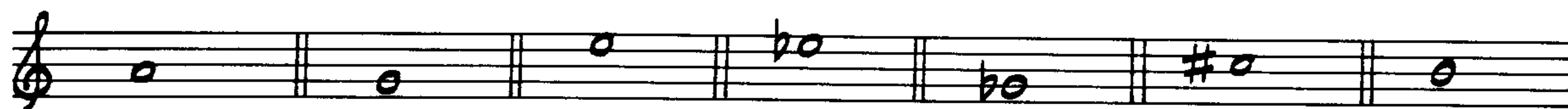
In the music, the intervals are labeled by number:

Example B shows 1:1 two-part counterpoint in C Lixian. Even though the two melodies have identical rhythms, each has its own curve and is modestly independent of the other. In measure 4, note that the intervals of a 10th and a 12th are labeled as 3rd and 5th; this is the common procedure for intervals larger than an octave.

TYPES OF MOVEMENT BETWEEN VOICES

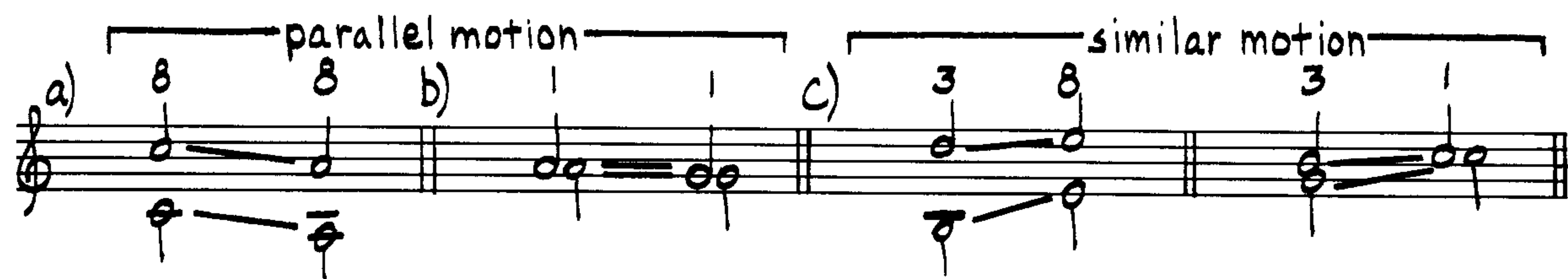
Movement from one interval to another has four classifications: *parallel motion* (a in Example C)—both parts moving in one direction by the same interval; *similar motion* (b)—two parts moving in the same direction, but not by identical intervals; *oblique motion* (c and d)—one part remaining on the same tone while the other moves up or down; and *contrary motion* (e and f)—two parts moving in opposite directions.

Example C

All four classifications of movement in Example C are usable, although you should note that the parts will have more independence with oblique and contrary motion than with parallel and similar motion; two parts in parallel 3rds from beginning to end will sound more like harmony than counterpoint. This is not to say that parallel and similar motion are to be avoided, but that they are less like counterpoint. (See Chapter 11 for a fuller discussion of two or more parallel parts.)

There are a few formations that definitely should be avoided, and they all involve the perfect unison and the perfect octave. These two intervals tend to stand out excessively in two-part counterpoint and consequently need to be treated with care: successive octaves (a, in Example D), successive unisons (b), and similar motion from any interval to a unison or octave (c). However, all these formations are acceptable as the last two intervals of a section of a piece.

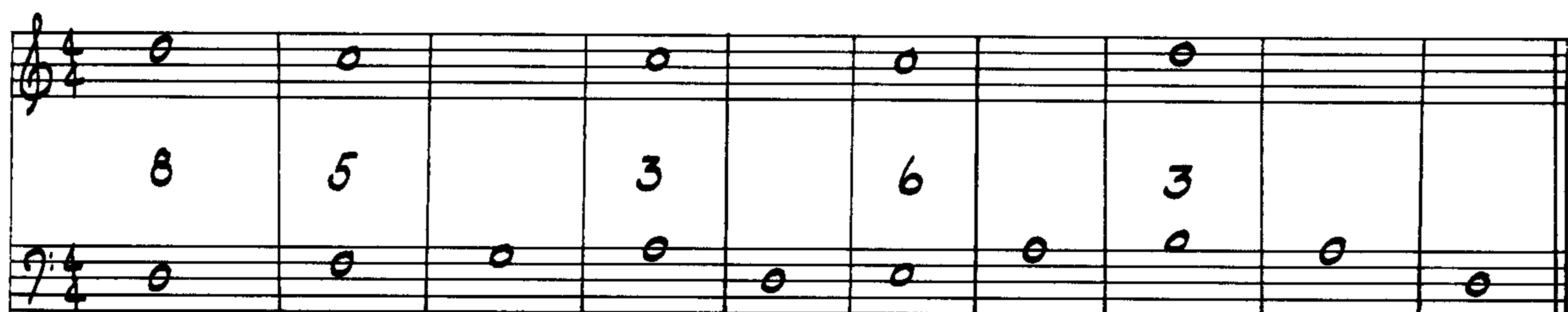

TWO-PART COUNTERPOINT WITH CHORDS

Up to this point, we have dealt with counterpoint intervallically—from one interval to another. Counterpoint may also be thought of *harmonically*, as seen in Example I, which consists entirely of chord tones. In counterpoint with harmony, let us assume that a multiple-note instrument, such as piano or guitar, states the chords; this relieves us from the responsibility of representing the harmony through the counterpoint, which is another topic altogether and one that goes far beyond the scope of this book. Example I is written in C Dorian (C D E^b F G A B^b), for which you may use the key signature of B^b major (the Dorian scale is built on the second tone of a major scale) or write in the flat signs, as I have done:

The relatively small number of dissonant intervals in the pentatonic scale suggests that it lends itself readily to two-part counterpoint.

The pentatonic scale also lends itself well to 3:1 and 4:1 counterpoint, and also to counterpoint in which there is no rhythmic ratio between the parts. It is also relatively easy to write good counterpoint of more than two parts with the pentatonic scale. These topics are beyond the scope of this book, except for some isolated examples to be found in Chapter 16.

**CONTRAPUNTAL ASPECTS OF
MELODY AND ACCOMPANIMENT**

Although the relationship between melody and accompaniment is not counterpoint as such, it is like counterpoint in some ways: the ear hears the melody as one part and the accompaniment as another part or parts. The chief concern for us in this relationship is similar and parallel motion to a unison or octave, as seen in Example N. The parallel octaves between the melody and the accompaniment in *a* are better avoided; *b* is the preferred version.

When you listen to melody with harmonic accompaniment, your ear hears the outside tones first and most clearly. In a passage like the one shown in Example P, your ear hears the highest tone (the melody tone) and the lowest tone (the lowest tone of the

chord) more immediately and more clearly than the other tones; consequently, there is a special relationship between the outside tones. The parallel octaves in *a* should be avoided in favor of the distribution in *b*:

One very general rule is to be careful with *all* octave formations that occur at the beginning of the measure since these formations tend to draw too much attention to themselves. It is always satisfactory to end a piece or section, of course, with an octave built on the tonic.

Organum

TWO VOICES IN ORGANUM

Organum is the name for two or more voices traveling the same road—locked together in the same rhythm and moving by the same interval. In Example A the lower part exactly duplicates the upper part a perfect 5th below:

Example B is also organum: the lower part duplicates the melody a major 3rd below, which results in parallel major 3rds. In measure 2, note that the lower part has a D^b and the upper part a D^\sharp ; conflicting accidentals often occur when two parts share the same staff, especially in organum. You must be careful to write exactly what you mean.

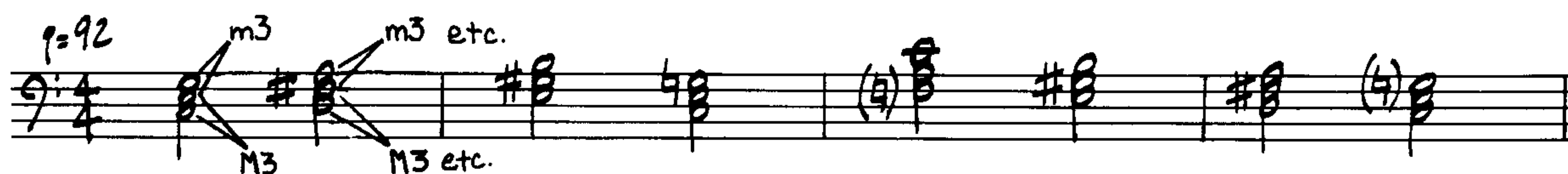


3RD CHORDS IN ORGANUM

It is possible to have organum with more than two voices. Example D consists of organum in three voices. The second part is a minor 3rd below the melody (the top part), and the third part is

a major 3rd below the second part. The result, of course, is a series of major triads in exactly the same position. Play this example very slowly and note its richness.

In Example E, a, the second part is a perfect 4th below the melody, and the third part is a minor 3rd below the second part. ORGANUM AS A SOURCE

Organum can also be used to generate entire pieces. Example G shows such a piece. (Also note the natural signs in measures 11, 14, and 15; these tell the trumpet player not to worry about the conflicting sharps in the trombone part.)

Example H (not based entirely on Basic Note Values) shows how a small theme consisting of eight measures can be made into a short piece of twenty-six measures by means of organum:

1. Measures 1–8 make up the small theme, which is divided between the clarinet and the bassoon.
2. Measures 9–12 show an organum of the lower 6th. Notice that the organum is *inexact*; some of the 6ths are major and some are minor, in accordance with the tones of the D Dorian scale.
3. Measures 13–14 are in octaves.
4. Measures 15–16 show the bassoon in perfect 5ths (12ths actually) below the melody.
5. Measures 17–20 show an added part *above* the melody; the clarinet moves in parallel major 3rds (10ths, actually) above the bassoon.
6. Measures 21–22 show the clarinet a major 6th above the melody.
7. Measures 23–24 show the melody (played by the clarinet) in a higher octave with an added part a minor 7th below.
8. Measures 25–26 are “free measures,” in which reference is made to the original motive and the piece is rounded off.

ORGANUM AS ACCOMPANIMENT

An excellent way to use organum is for accompaniment. Parallel 5ths played by bass guitar are often heard in rock and roll. For example:

Example J shows parallel 5ths that will become an accompaniment later. Note that the passage forms an *a a* (the second *a* is slightly altered at the end):

Using this same organum accompaniment, I have composed a melody compatible with it in the treble clef. The melody consists of tones found in the organum (think of these as “chord tones” even though there is no “chord,” strictly speaking) and non-chord tones (these are labeled the first time they occur). Note that I use non-chord tones of a $\frac{1}{4}$ note’s duration or less and that measures 4 and 8 contain a reverse neighboring tone, a variety of non-chord tone that requires great delicacy to use.

Exercise 13

AFTERTHOUGHT

The material in this chapter has been examined more thoroughly than material in other chapters because the procedures of organum are very large in scope. Other material in this book lends itself to similar extension, and you might very well decide to delve further by yourself. For example, it would be easy to invent exercises, even pieces, based on the material concerning melody and ostinato from simple cells (see Chapter 7), especially if you were to transpose the cell from time to time.

Imitation: a Useful Game

THE GAME

A few years ago, when I was the director of the Chicago Free Theater, I invented a game for percussion instruments. It is a very simple game, and here are the rules.

1. Three, four, or five players stand in a circle.
2. Each player has a hand-held percussion instrument.
3. When the group is ready to begin, one of the players introduces a simple figuration of one or two measures. This figuration must clearly suggest the tempo and must have *shape*, so that it can be recalled easily.
4. During the course of the piece, each player may *introduce one* such figuration (and only one).
5. Each player may *imitate* any of the figurations (his or others) at any time (and not necessarily consecutively).
6. Each player may rest at any time (remember: silence is music).
7. The piece may end either by a signal from one of the players or by a group consensus that the piece has finished.

This game, which I call “Imitation” because of rule 5 above, is a very useful way to learn how to pass material from one instrument to another. Using only simple one-measure figurations, I have written an example of how a piece evolved from these rules might sound. Play this, if you are in a class:

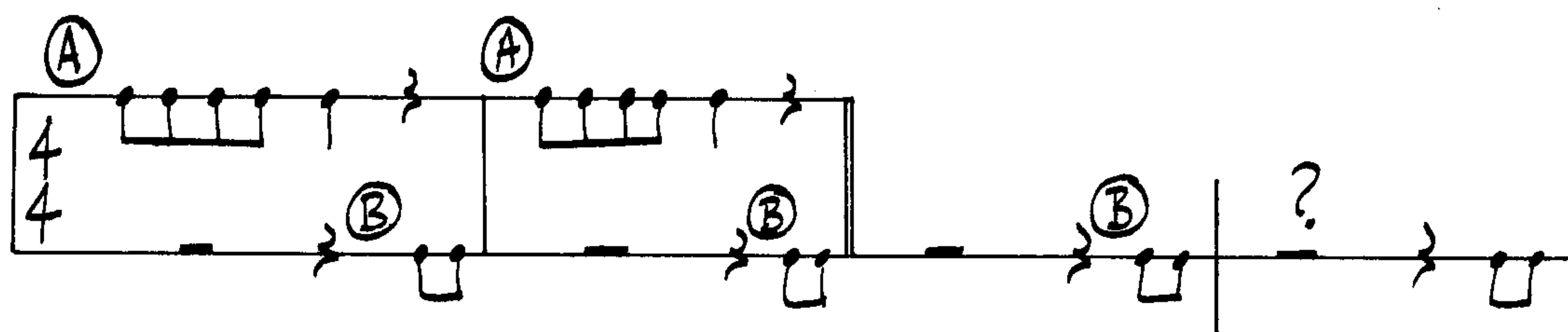
Also note that player A (tambourine) never lets up—he starts in measure 4 and then plays in every measure.

Exercise 1 (for three players)

Improvise a piece based on the rules of Imitation (as given above), using three hand-held percussion instruments that are available to you. Use one-measure and two-measure figurations and avoid figurations that are hard to imitate or that are unsupported (more about this later). Listen carefully to one another and don't try to be stars.

OVERLAPPING

When you use two-measure figurations, the possibility of overlapping occurs—that is, the imitation of a two-measure figuration might begin before the figuration is complete, as in measure 4 of Example E.

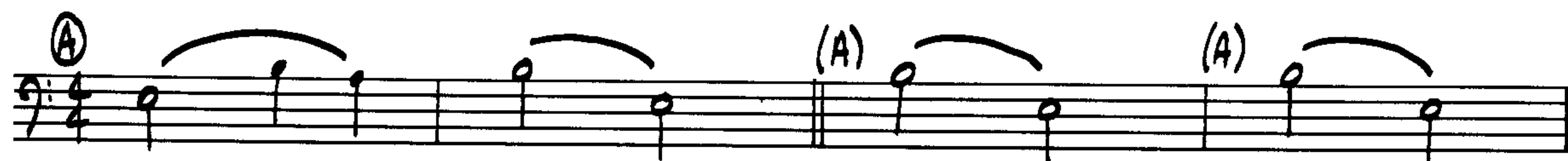

FRAGMENTATION

When a portion of a one- or two-measure figuration is *palpable*, you may separate it from the main figuration and use it by itself. By a *palpable portion*, I mean a portion that makes sense by itself, that is easily identified by the ear, and that bears repetition. In Example F both the first and second measures are palpable portions; note how the second measure can be separated from the first:

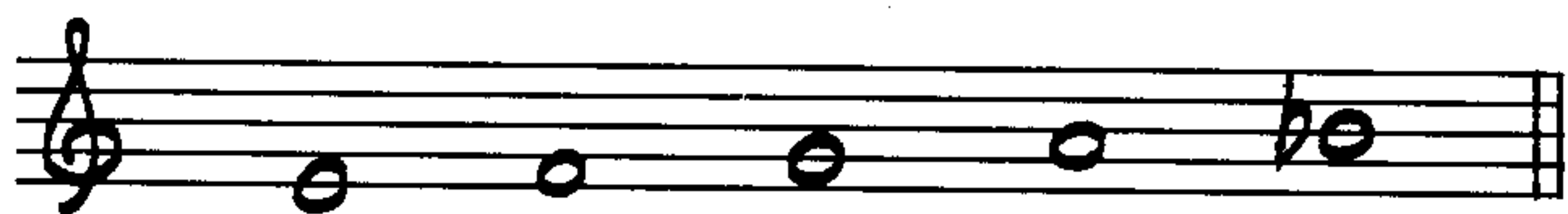
Exercise 5

1. Develop four one-to-two measure figurations using only the tones of the E pentatonic scale: E G A B D.

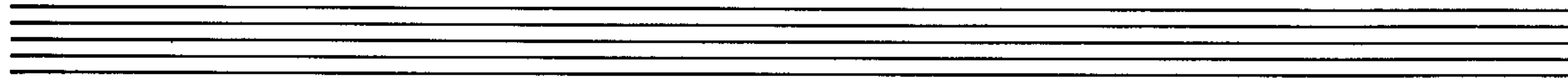

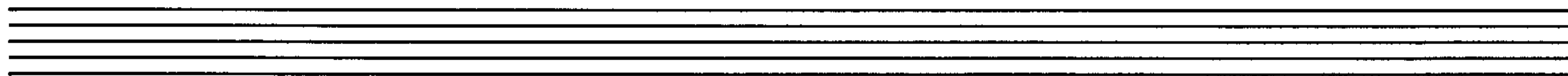

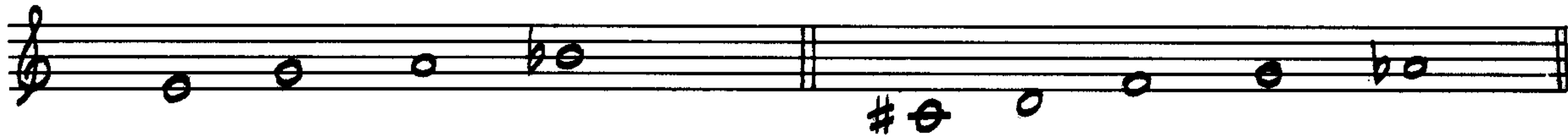

Note that the first interval forms a minor 6th *enharmonically*, which is permitted in counterpoint based on cells and rows but is to be avoided elsewhere.

Words and Music

THE PREMISE

This chapter deals with the relationship between words and music. Using only the materials available to you in this book, I shall attempt to show you how to put words and music together and how to start a song.

I base the procedures outlined here on the songs and arias of Mozart, Schubert, and Verdi among the classical masters and of George Gershwin, Richard Rodgers, and Cole Porter among the popular masters—with one exception, which is *melisma*, used by the classical masters. Melisma is the use of more than one tone for one syllable. (Please sing all the examples in this chapter.)

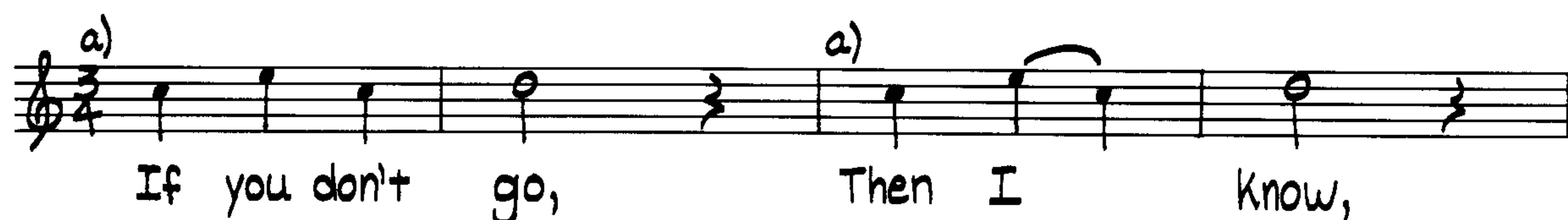
Example A



Melisma is used very frequently in classical music. In addition to showing off the beauty of the human voice, it allows the composer to regularize lines that are irregular. For example, if the first line has four syllables and the second line has three syllables, the composer is able to use the same four tone motive

for both lines by writing two tones for one syllable in the second line:

Example B



However, I feel that melisma gets in the way of understanding the words and it provides easy ways out of problems that you should learn to solve without its use, so I have excluded it here.

TEXT AND LYRICS

The usual name for words set to music is *text*. In popular music, the words of a song are called the *lyrics*. As a general rule, in classical music the text is written before the music; in popular music the music often comes first. Give and take between the word writer and the music writer is often possible, and, of course, there are many different ways of writing a song. In teaching this subject, it is more practical if the words come first, and therefore this is the approach we will use.

Before going further, I want to point out some important differences between text and poetry (especially the kind of text found in the work of Gershwin and other popular composers). The following list should help you understand these differences:

Sung Words

Short lines of regular length

Short words, often of one syllable

Short sentences and phrases, which usually correspond with the line

A regular rhythm in the line, sometimes extending over the entire lyric

Simple, concise thoughts

Poetry (especially of the Twentieth Century)

Long and short lines irregularly mixed

Long as well as short words

Sometimes very long sentences and phrases (even extending the entire length of the poem) often not corresponding with the lines at all

Irregular rhythm

Abstract thoughts, sometimes expressed at great length

In short, song texts are written to be heard—and heard without time to reflect on complex lines or phrases. To make this clear, here are two examples written by my long-time collaborator Jon Swan. First is an example of words written to be sung:

*Nothing’s big as mama.
Take a look at me.
Nothing’s big as mama.

Just you wait and see!*

And here is the first stanza of a poem, “Conjuring Blues in the Surf at Nantucket” by Jon Swan:

*There are no bluefish. Only
stories about bluefish. Like unicorns they thrive
in the imagination, the mother-wit sea
out of which we stepped originally,
not this one we drive
to each evening. We park the car on the bluff.
We take our shoes off.
Holding long rods, we walk down
to the dividing line between two kingdoms to join
the other dreamers
already casting their lures.*

Your job as a composer is to find melody and harmony that reflect the character or meaning of a text and at the same time make the meaning clear to the listener. Although you may be tempted to highlight an unimportant word or distort a meaning for the sake of a good melody you must resist this urge, and find a good melody that works with the words.

THE RHYTHM OF THE WORDS

There is rhythm in a line of text and in poetry. This rhythm comes from the way you would speak such a line—the *normal* accenting of the syllables in a line. In Example E accented syllables are marked “ — ,” and unaccented syllables are marked “ ◡ .” Say these words aloud and see if the marks are adequate:

DURATION

One of the best ways to express the rhythm of a line is through *duration*; long notes are given to accented syllables and short notes to unaccented syllables. Read the words in Example F aloud in tempo (this is called *chant*). Only two note values are used— $\frac{1}{4}$ notes and $\frac{1}{2}$ notes.

Oh, what joy to be a-lone.

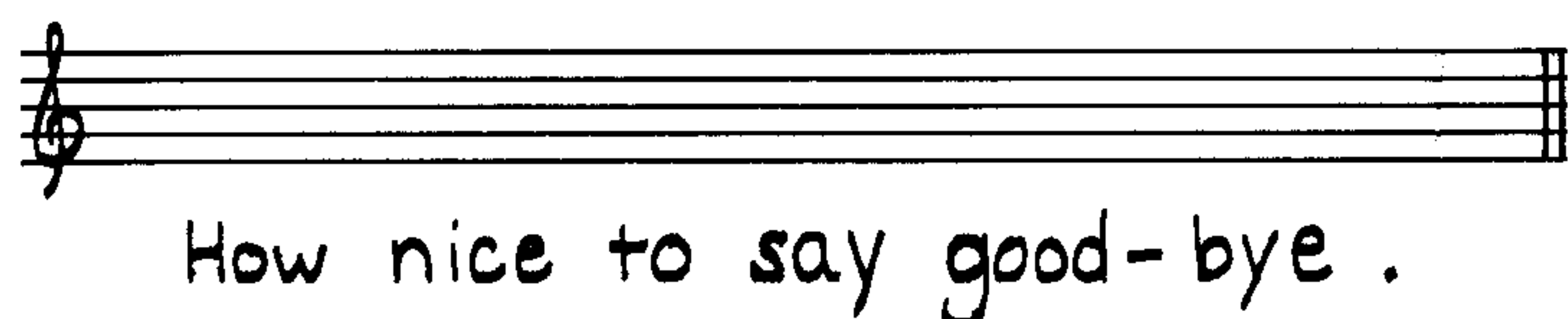
In addition to duration, another important consideration in setting words is *pitch*—the choice of tones for a given syllable. Using a two-tone cell, I have set the following line with $\frac{1}{4}$ notes only. Note that the accented syllables are given the higher tone and the unaccented syllables are given the lower tone. Remember to sing all these examples.

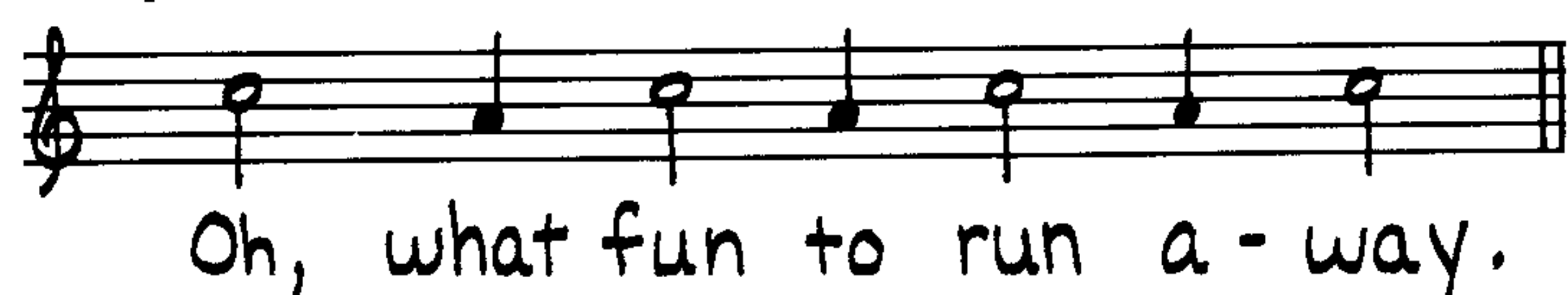

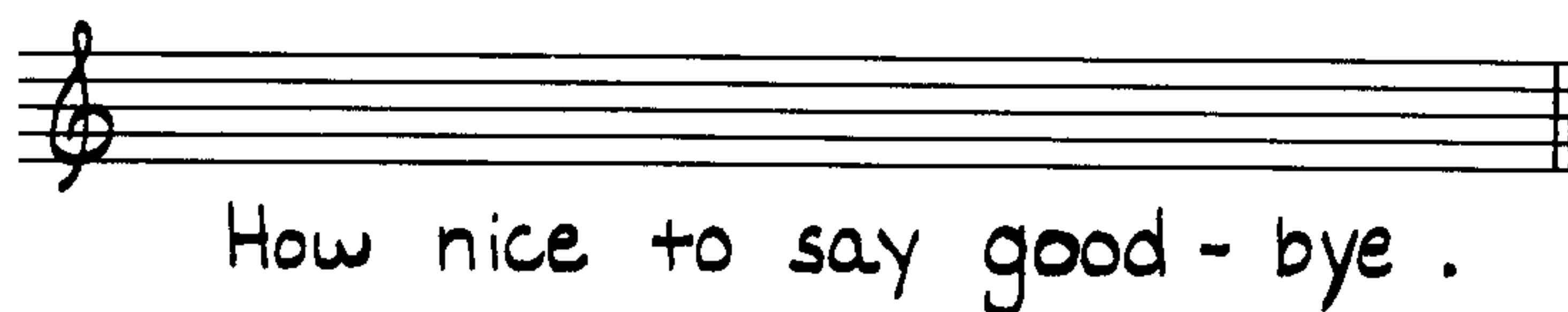
Example I is not entirely satisfactory; it is true that “Oh,” “fun,” “run,” and “-way” are the accented syllables, but “Oh” is far less important than the other three. With two pitches and two durations, distinctions between important and less important accented syllables can be made:

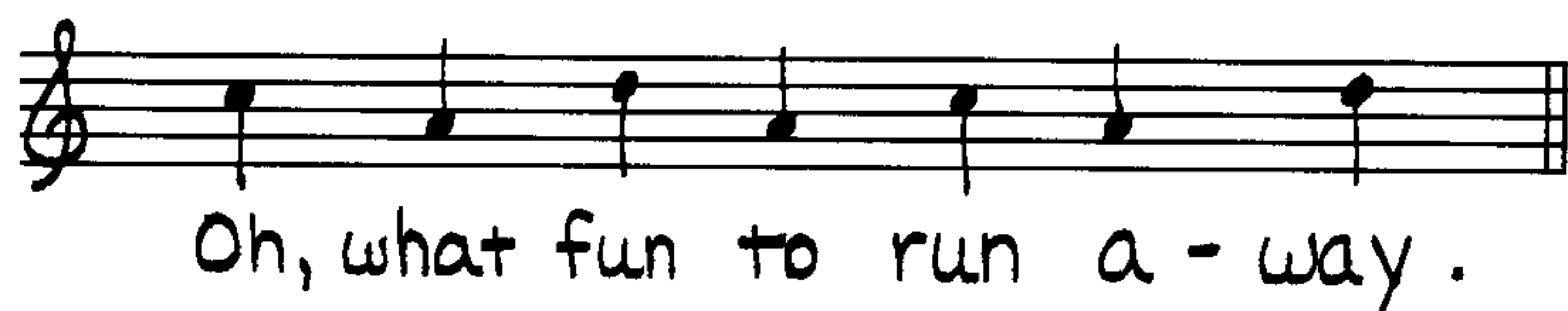

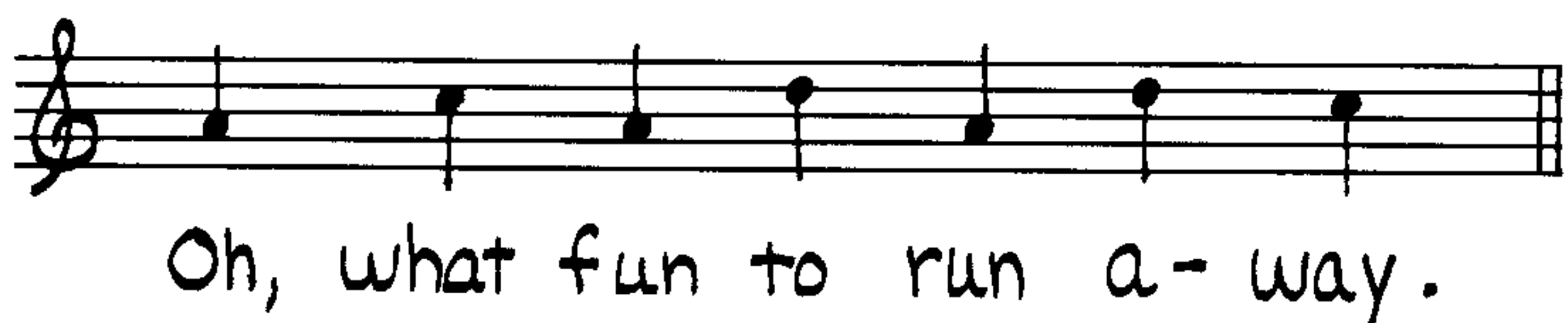
Using a 3-tone cell and $\frac{1}{4}$ notes is another way to find the normal accent of the line while at the same time presenting the distinction between important and less important words, as Example K shows. (Also, bear in mind that identical groups of words may have different meanings, according to the context, and that your job is to find the meaning that is most nearly correct.)

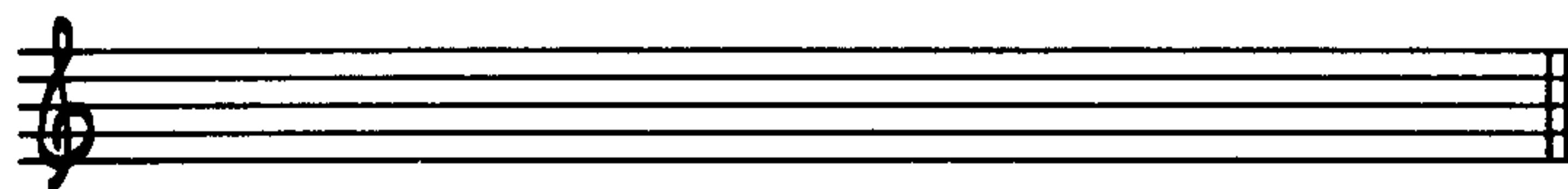

Note that “Oh,” a relatively unimportant accented syllable, is given the lowest of three tones but a longer duration. Note that “what,” an unimportant word, is given the middle tone, with a $\frac{1}{4}$ -note duration, rather than the lowest tone.

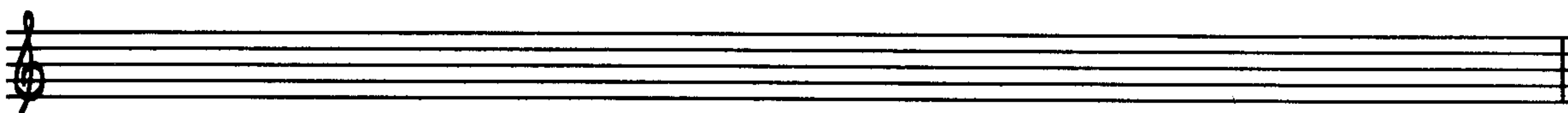

THE BAR LINE

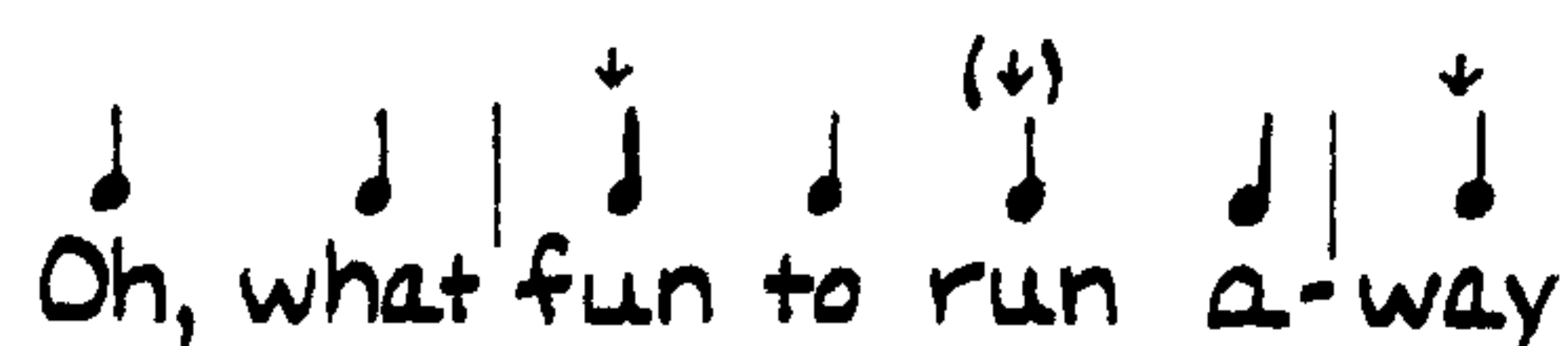
Now let us discuss the bar line. A series of $\frac{1}{4}$ notes will inevitably be performed with a slightly greater emphasis given to the first $\frac{1}{4}$ note in each measure:

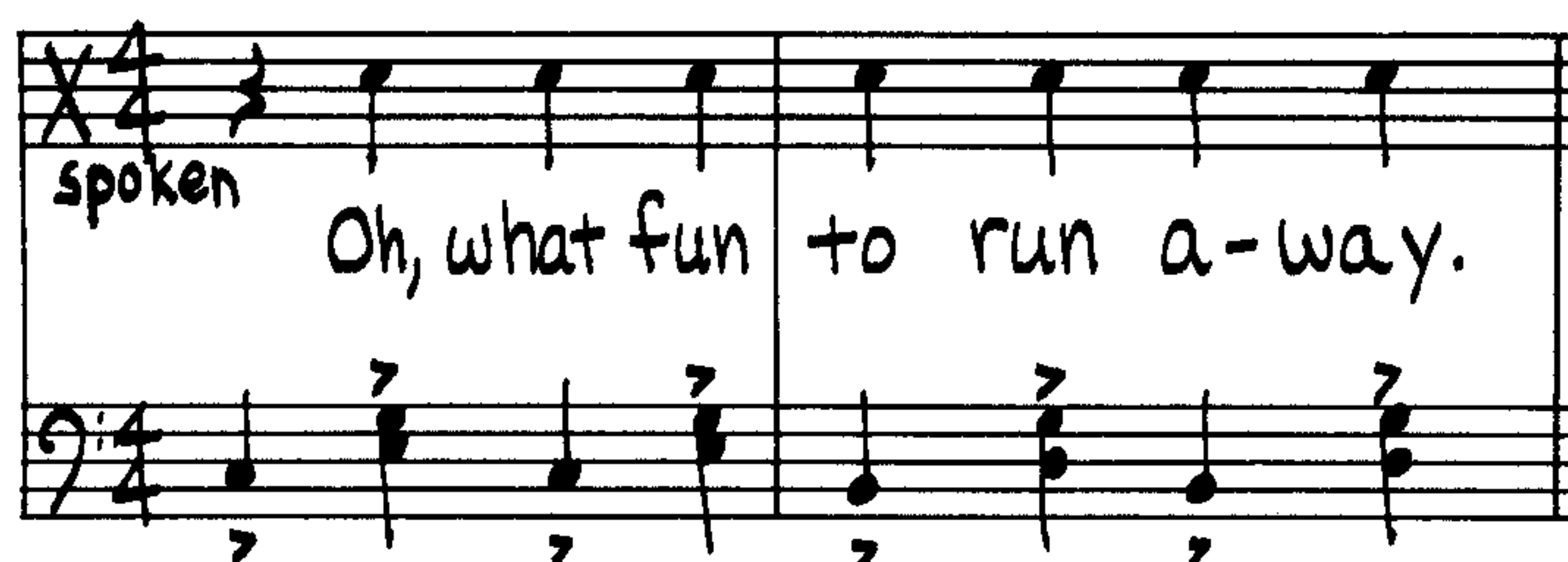
Consequently, if the duration of each syllable is the same, the syllable following the bar line will receive more accent than the others. (And in 4/4 the third $\frac{1}{4}$ note will receive a secondary accent.) In Example O “fun” and “__way” receive the chief accents, and “run” receives a secondary accent:

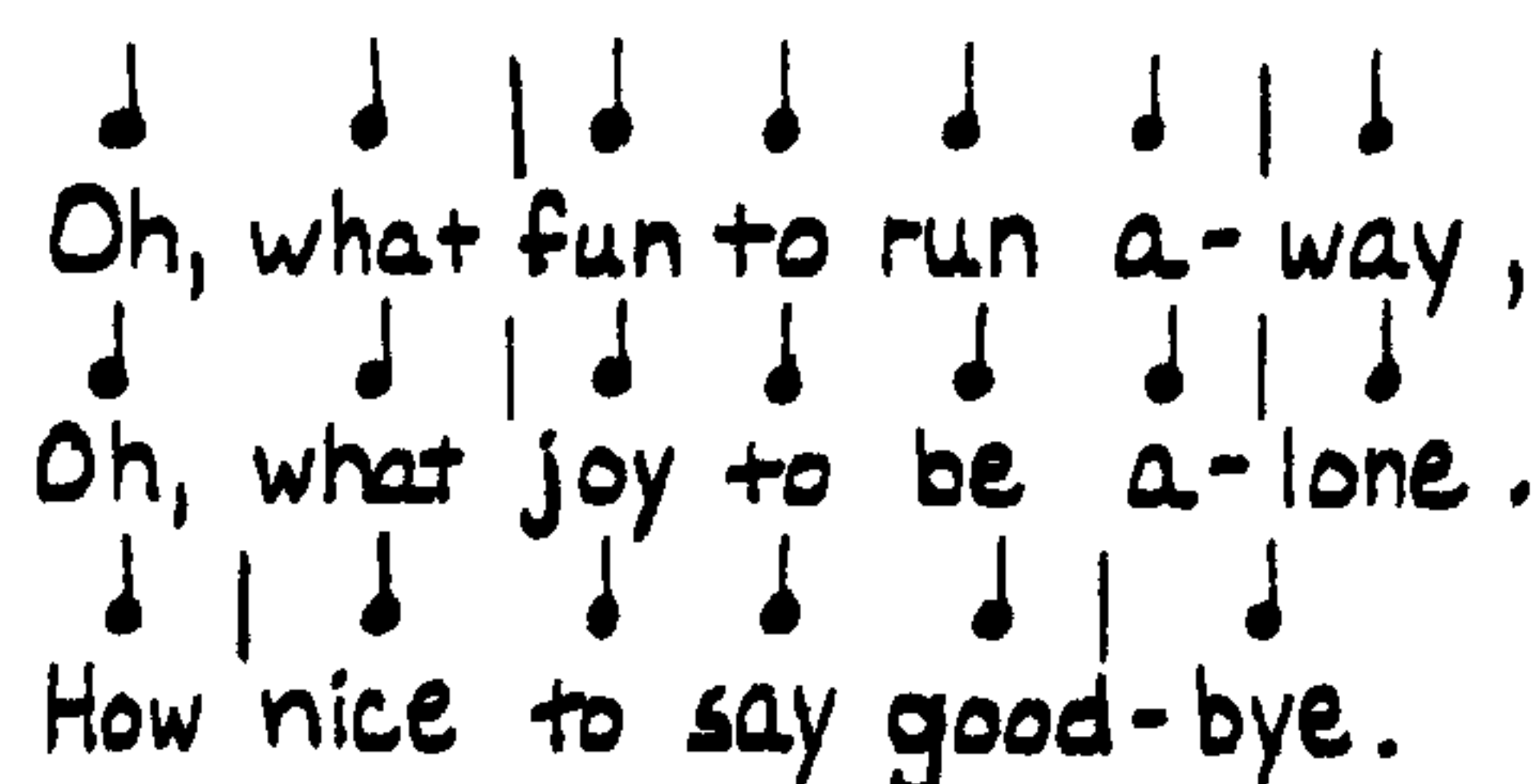
The bar line is badly placed in the following example; by chanting and playing it, you will see what I mean.

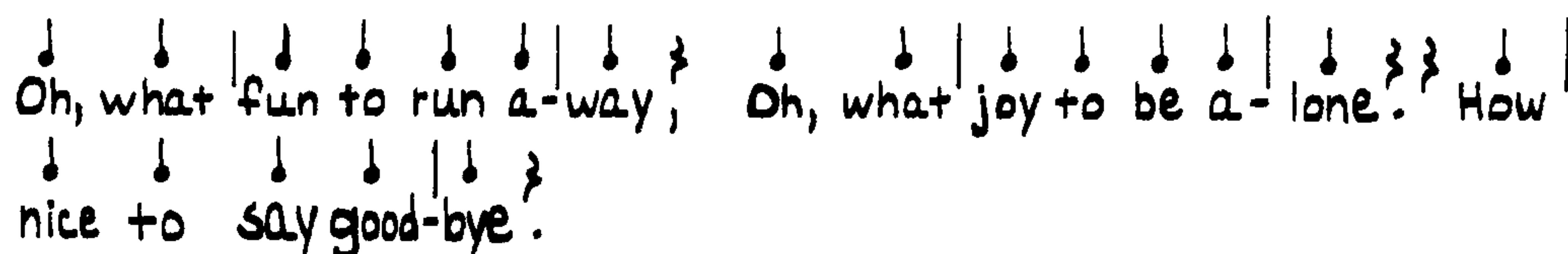
One way to begin setting words to music is to place bar lines before the accented syllables in important words, without regard to meter:

After finding the bar line, see if you can use a regular meter—either 3/4 or 4/4. If we add rests at the end of the first and second lines of Example Q, it falls nicely into 4/4:

In Example Q the words “Oh” and “what” are clearly preparatory, so the first full measure is labeled measure 1.

If we combine our use of $\frac{1}{4}$ notes and $\frac{1}{2}$ notes with the intelligent use of bar line and meter, we might come up with the following (based on the same words that we have used for several examples now):

Example S

Oh, what fun 1. to run 2. a-way 3.
 Oh, what joy 4. to be 5. a-lone 6.
 How nice 7. to say 8. good-bye 9.

For several reasons, however, the solution in Example S is unsatisfactory. First, it does not express the comma at the end of line 1: line 1 runs into line 2 and the sense of separation between the two lines is lost. (The comma after “Oh” in both lines 1 and 2 indicates no separation; it is merely decorative.) It is also unsatisfactory with respect to the number of measures per line—lines 1 and 2 are three-measure lengths; what you must strive for in basic songwriting is even measure length—lines of two, four, six, or eight measures.

In Example T the $\frac{1}{4}$ -note rests in measures 3, 4, 7, and 8 express the punctuation at the end of the first two lines. The addition of these rests results in four-measure units for lines 1 and 2 (line 3 is incomplete).

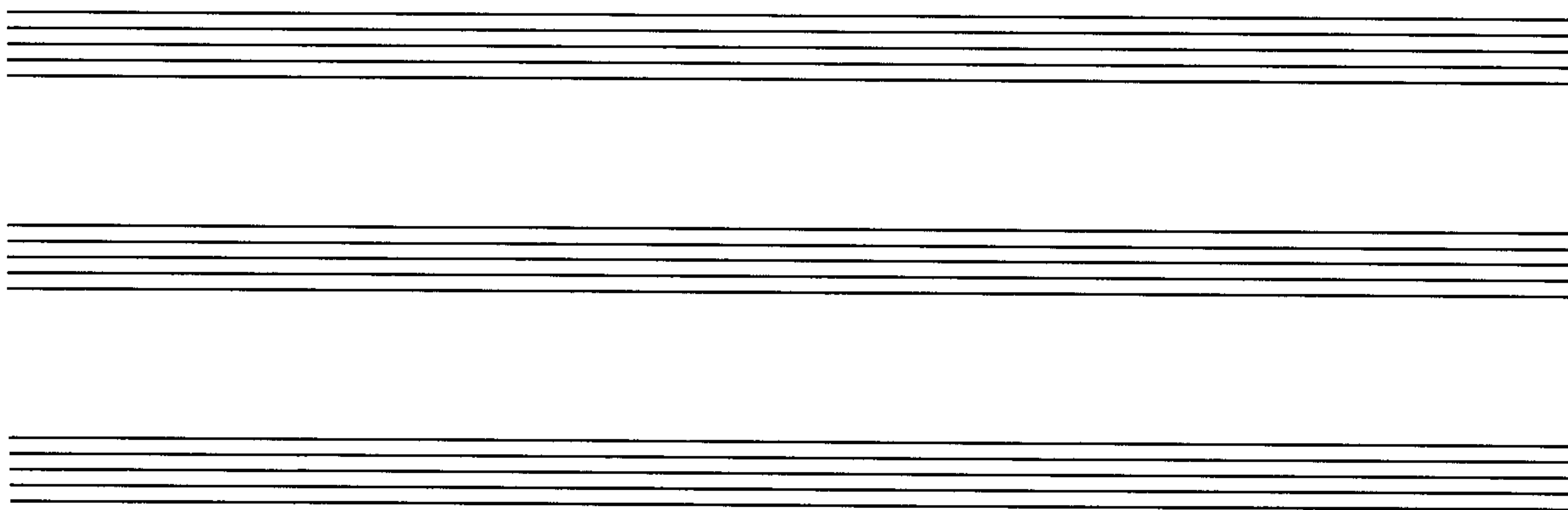

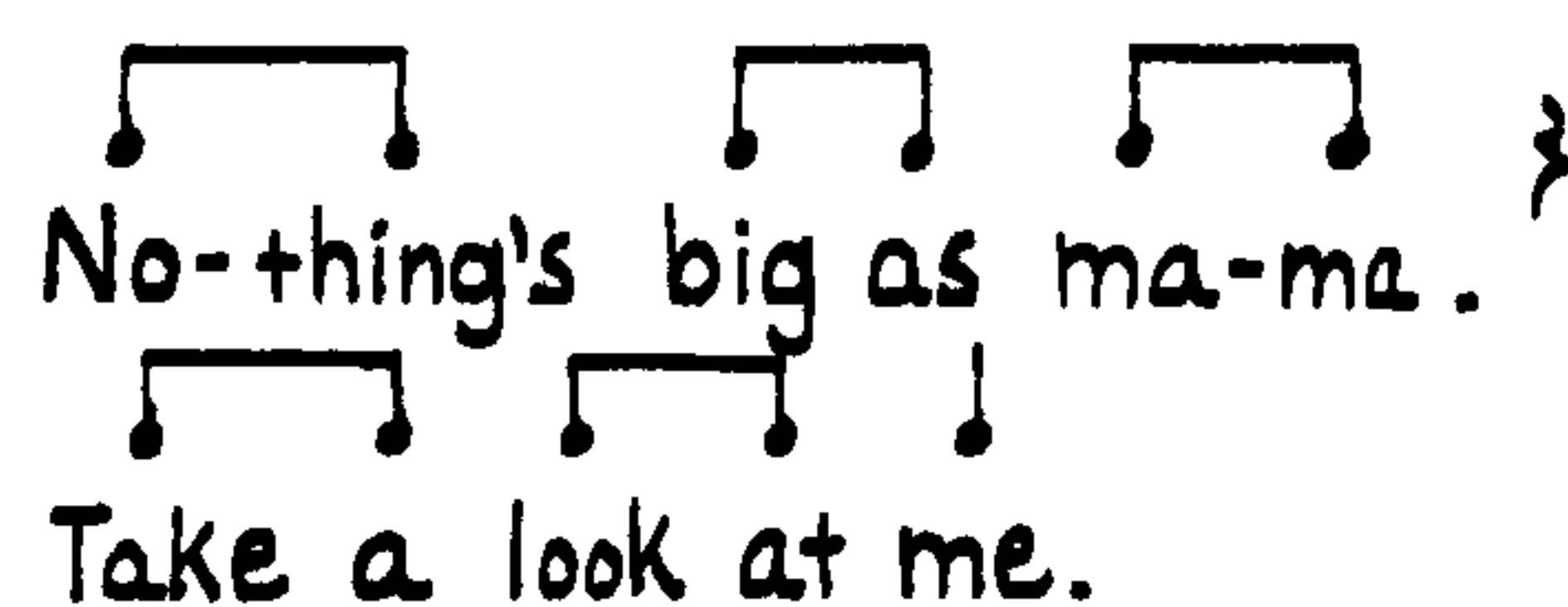

DOWNBEAT AND UPBEAT

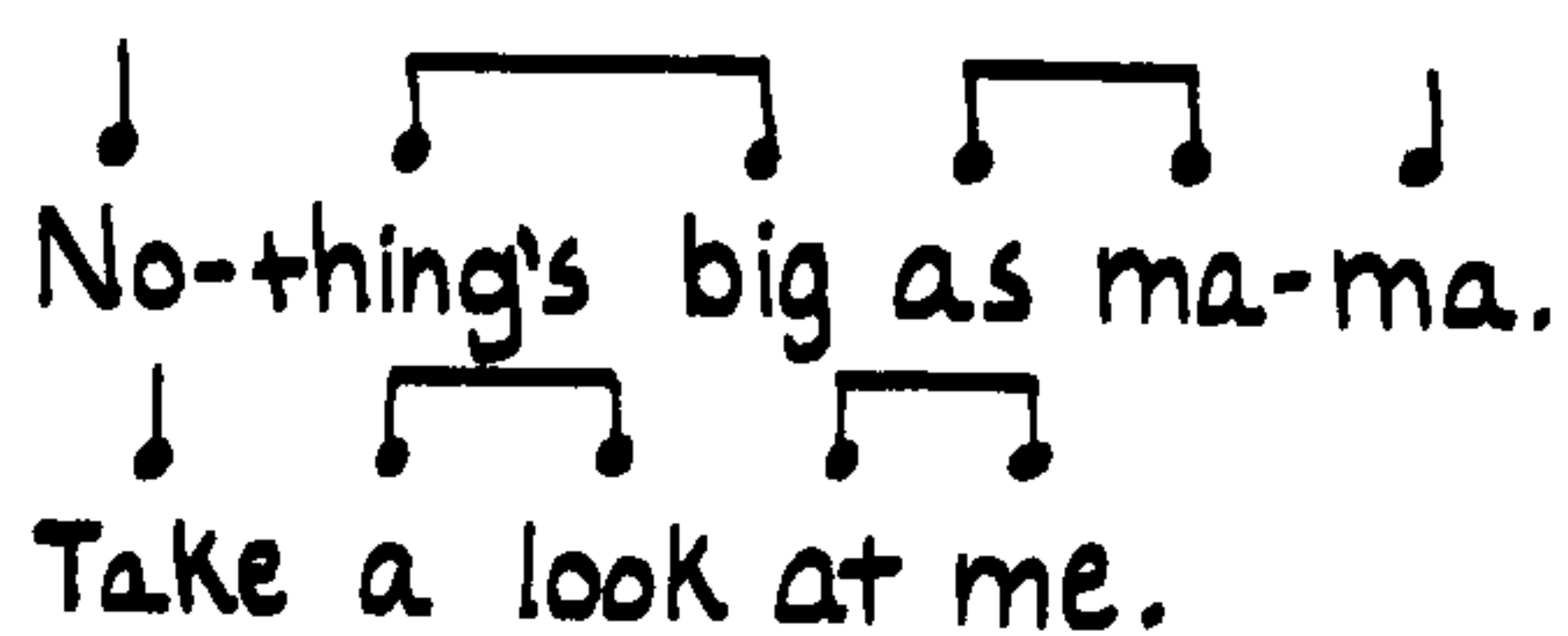
Another consideration when setting words to be sung is successive $\frac{1}{8}$ notes in 4/4 or 3/4 (time signatures in which the lower numeral is 4). The first of two successive $\frac{1}{8}$ notes is like a $\frac{1}{4}$ note in accent and weight. The second note, the *upbeat*, is extremely weak, and is best used for unaccented syllables:

To use accented syllables on the upbeat and unaccented syllables on the downbeat, such as those shown in Example V, is courting disaster.

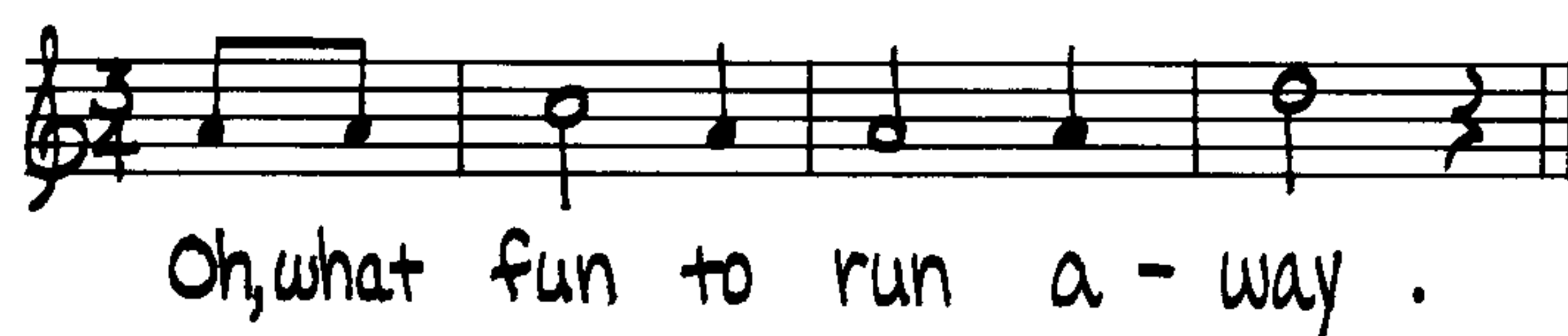
COMBINATION OF THE ABOVE FACTORS AND SOME CURIOUS CONSEQUENCES

These are the factors that we worked with, one by one, which you must deal with when you set words to music:

1. The bar line
2. Meter
3. Duration
4. Pitch
5. Downbeat versus upbeat
6. The rest
7. The number of measures in a phrase

When these factors are combined they modify each other. The word “run” in Example W is important: it is placed after the bar line and is given a longer duration. But note that it is also given the lower of the two pitches. In other words, an accented syllable of an important word does not have to be verified by *all* the factors at once, which I attempt to demonstrate in the following examples. Please sing all these examples.

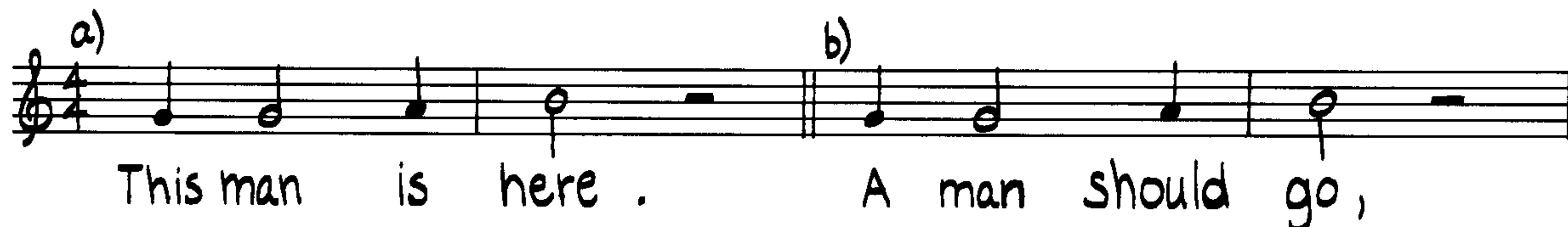
In Example X a rest is used after “fun,” even though there is no punctuation. This use of a rest serves to emphasize the word preceding it.

In the simple syncopated pattern shown in Example Y, it is possible to set two accented syllables on the first two notes (as in a) or even to set an unaccented syllable right after the bar line (as in b):

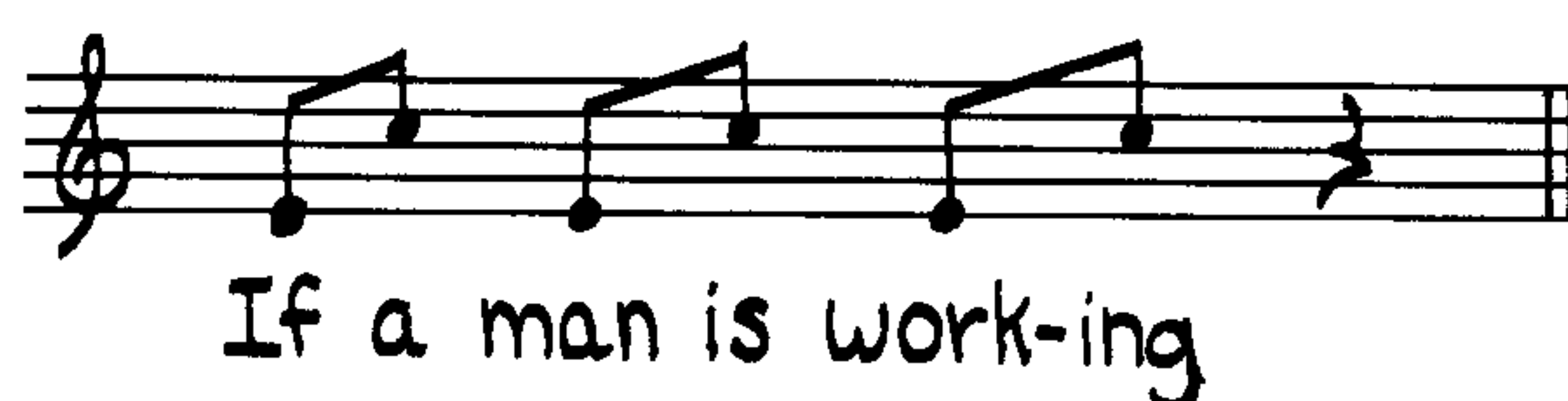
When the second of two $\frac{1}{8}$ notes is a *high* tone, it is sometimes possible to give it an *accented* syllable:

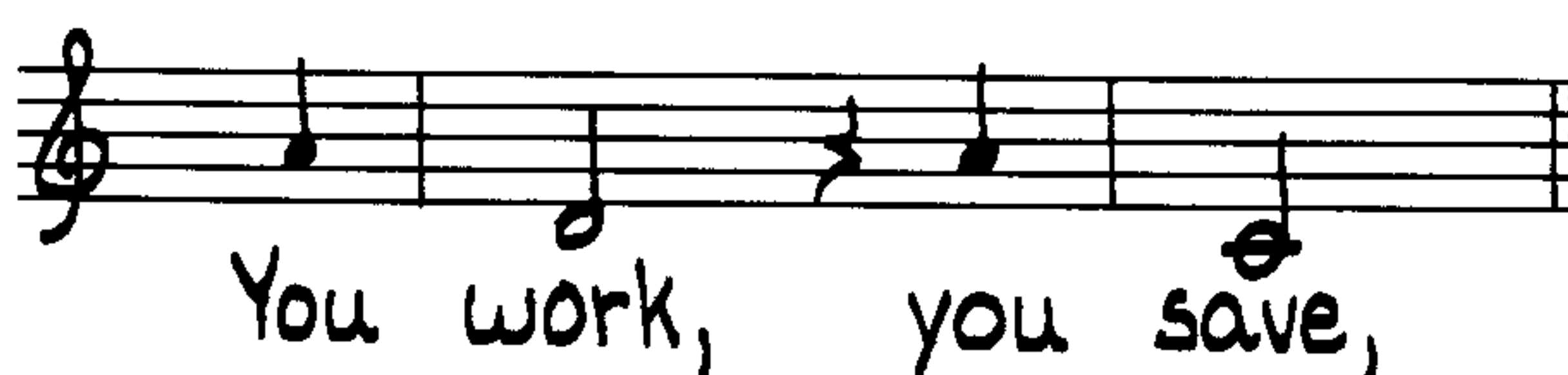
In Example BB the $\frac{1}{4}$ -note rest emphasizes the word “stop” by stopping at the rest.

Another way to accent an important word is to use a *lower* pitch, which is especially effective when it is preceded by a *skip*, as in Example CC. (Note that the lower pitch has a $\frac{1}{2}$ -note duration and that it is preceded by the bar line).

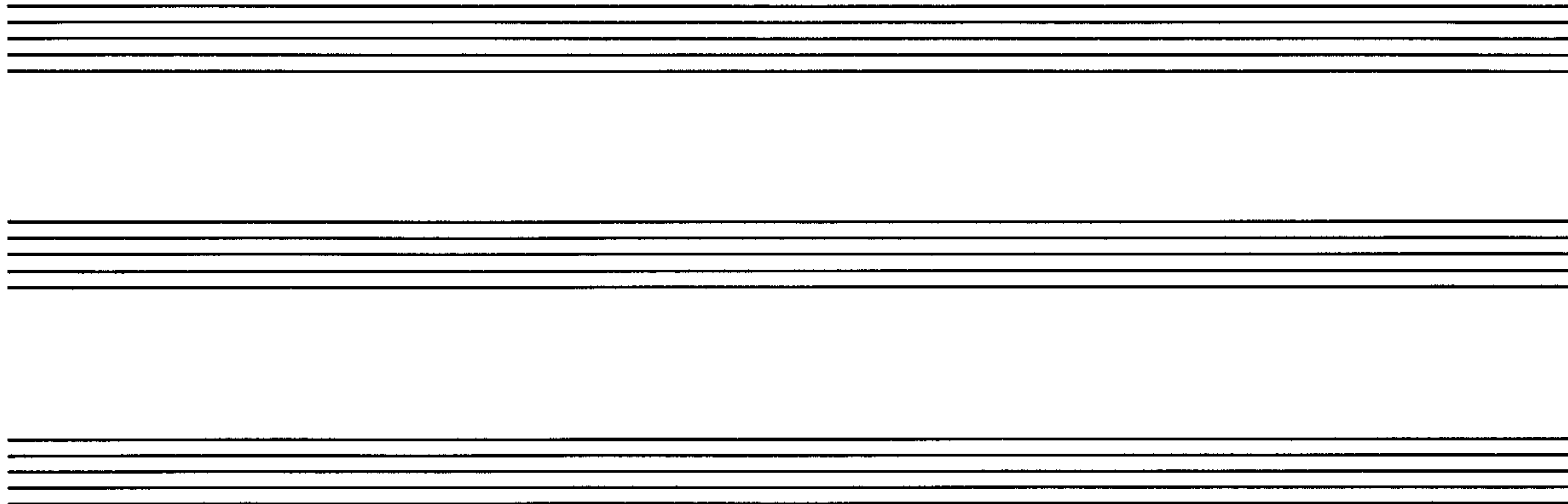

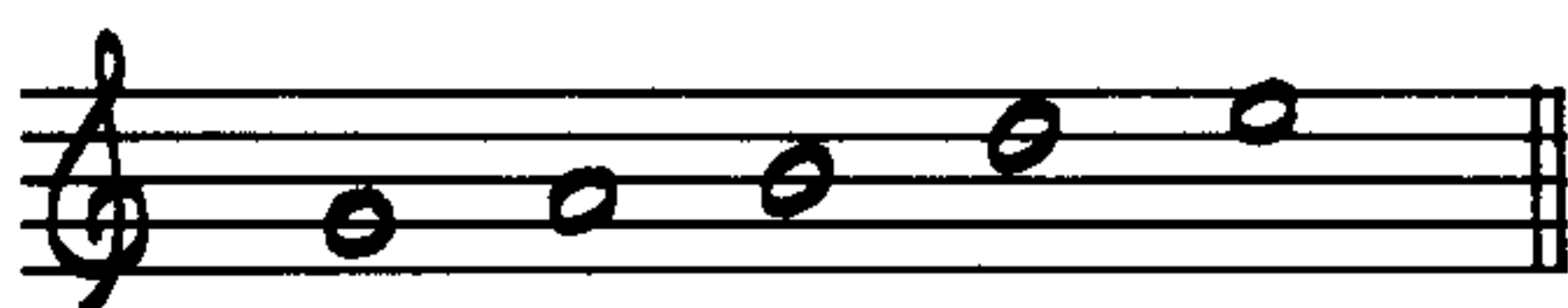

WORDS AND THE SMALL THEME

Now we are ready to turn to the small theme—the A (see Chapter 4). For this purpose, let us use the pentatonic scale, which we have used starting on the tone E. For songwriting, however, it is better to arrange the tones differently, starting on the tone G:

But this scale would better suit our purposes built on the tone C, since it can then be harmonized in the key of C major, using the Basic Rules for Diatonic Progressions or the Basic Rules for Mixed Progressions:

The lyric in Example FF is suitable for a small-theme procedure. All of the lines have the same number of syllables, and the first three lines have the same rhythm:

Example FF

Lord, what a day.
Look at the sun.
Blood in its eye.
Too hot to run.

From the rhythm of the words, we could construct a small theme of *a a a b*, *a b a c*, or *a a b c*. Since lines 1 and 2 are closest in meaning and rhythm and line 3 is quite different in meaning from the first two lines, the best form is *a a b c*:

Harmony and accompaniment can improve a melody and can also affect the meaning of a text in different ways.

1. Harmonize the melody in Example GG according to the Basic Rules for Mixed Progressions. Be sure that the harmony is compatible with the text.
2. Use alphabetical chord symbols and place them above the staff precisely at the point in the measure where they are to take effect.
3. Use no more than two chords per measure. (Remember that all tones must be chord tones.)
4. Start and end with a C major triad.

In the *aa* of Example GG the words of the two lines are parallel: they have the same rhythms, and the important words fall in the same places. In Example HH below, the two lines have the same rhythm, but the important words fall in different places. (I have put arrows over the important words.)

I have met my love in dreams,
He has held me close in dreams,

In order to write identical melodies for these two lines, you must work very hard at finding a melody that will fit each line equally well. One approach is to emphasize “Dreams” and slightly suppress both “met” in line 1 and “close” in line 2:

WORDS AND THE “AA”

Now we turn to composing the same melody for two matching stanzas. In the lyric in Example KK lines 1 and 5 have the same number of syllables and the same accents, as do lines 2 and 6, 3 and 7, and 4 and 8.

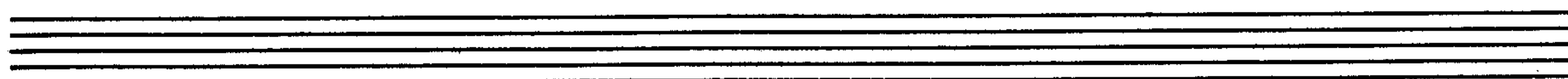
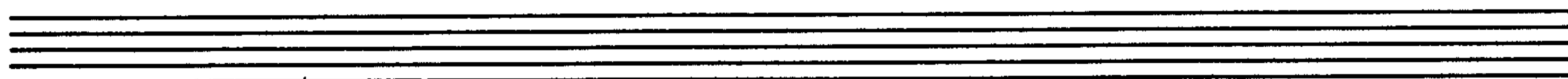
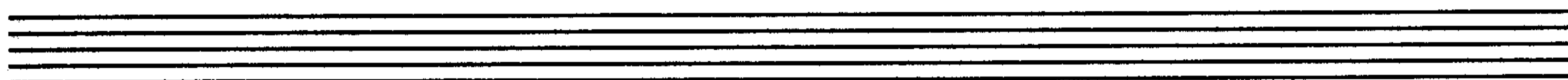

Hint: Write both sets of words beneath the staff and then find tones that fit both sets of words equally well.



MORE ABOUT SINGABILITY

In the previous pages, I have touched on singability in the literal sense—what is easy to sing. Here are a few more suggestions on this topic:

1. Long notes are best sung on a vowel without an ending consonant, as in the words “go,” “pray,” or in the second syllable of the word “mama.” There are two reasons for this: first, if the word ends with a consonant, the listener doesn’t get its meaning until the word is concluded. Second, singers often ignore ending consonants, which they regard as an interruption to the flow of the vowel sound or because they don’t know how to sing them properly. For either of these reasons, the meaning of the word is kept from the listener, and the point of music with words is the word.
2. High notes are also best on a vowel without an ending consonant.

3. But there are two vowels that are hard to sing high, especially loudly: i (as in “sift”) and e (as in “free”).
4. It is easier to sing high tones when they are approached gradually; this admonition underlies the physical basis for the curve in all melody, vocal and otherwise.
5. Beware of repeated tones, especially several tones of short note value, which tend to sound too much like ordinary speech:

Example MM



6. Long, sustained notes also reduce the intelligibility of the words; by the time you get to the last word you hardly know what it refers to:

Example NN



I sometimes think of the type of song that has been discussed in this chapter as *ordinary song*. Ordinary song reflects the words both in their meaning and in their rhythms: The words are understandable as sung and they derive from speech rhythms. Sometimes the same syllable will be of greater duration when used in ordinary song than when used in speech, but the general emphasis will be the same. Another characteristic of ordinary song is that the phrase lengths are regular—all four-measure or all eight-measure lengths, for example.

Strive to compose ordinary song in its most beautiful form. Strive for melodies that are shaped and memorable—that stick to the ears. Above all, strive for an elevated blending of words and music in which the two become one.

TWO INVALUABLE EXERCISES

Exercise 13

1. Find the sheet music for a standard popular song with an AABA structure by one of the song masters of the thirties or forties (Gershwin or Rodgers, for example). You should not be familiar with the song.
2. Study the way the words and music have been matched and write a paraphrase of the music line; in other words, compose your own melody but stress the words and syllables that the original composer stressed and follow the same AABA structure. (It is not important whether the words came first or the music came first in the original song.)
3. Base your melody on one of the scales used in this book.
4. Harmonize your setting according to the Basic Rules for Mixed Progressions. (You may use any of the non-chord tones we have discussed in this book.)
5. Study your versions and the original version carefully, both melodically and harmonically:
 - a. Have the words and phrases been made clear or obscure?
 - b. Do the two versions peak at the same point?
 - c. Is the character of the lyric reflected in both settings?
 - d. How have rhymes been handled in the music of the two versions?
 - e. Is the music compatible with the lyrics of *all* the A's?

Exercise 14

1. Locate the lyric of a standard popular song written by one of the lyric masters of the thirties or forties (one by Ira Gershwin, Frank Loesser, or Lorenz Hart, for example). As in Exercise 13, the lyric should be from a song that is not familiar to you, and it should have an AABA structure. You must also find the sheet music for this song.
2. Do not look at the music before you set the words. Get the lyric from a lyric collection (the Ira Gershwin book listed in the Bibliography has several lyrics) or have someone dictate it to you. (In the latter case, make sure the person who dictates is able to distinguish between the intro, the A's, and the B.)
3. Set the lyric, following the principles outlined in this chapter. Speak the words out loud to find the natural rhythm. Note the important syllables, words, and phrases, and reflect these in your setting.

4. Parallel the AABA structure of the words in the melody and harmony (see Chapter 4). Determine the emotional curve of the lyric. As in music, a lyric will often peak near the end of the B.
5. Base your melody on one of the scales used in this book.
6. Harmonize your setting according to the Basic Rules for Mixed Progressions. (You may use any of the non-chord tones we have discussed in this book.)
7. After you have set the lyric, carefully compare your version with the original.

Hint: In some lyrics, a line or two may seem to have been added at the end of the song. This may be matched in the melody by a few related free measures that act as a *tag* to close off the song.

Exercise 14 is an extremely helpful one and periodically I do it myself.

AFTERTHOUGHTS

The main problem in writing ordinary song is finding the right text.

1. Try to find words that fit the characteristics of sung words in the left hand column of the list on pp. 144–45.
2. Look for stanzas that have repeated rhythms and meter. This gives you the possibility for repetition of small themes, especially of AA, which leads to AABA, the principal song form.
3. If you can't find such stanzaic correspondence, you can always repeat both *the words and the melody* of an A, thus achieving AA (see Schubert).
4. Make the B and the A contrasting in tone and mood (see Chapter 4), and, as I said before, let the B *sail back* into the A.
5. Find a poet or lyricist to whom you can explain some of the ideals of words for music.

Words humanize music. They keep music from becoming intellectual and remote. They keep music in touch with an audience. Remember that music with words allows you to tell a story—to express a specific idea or emotion in addition to what the music alone is expressing. Music alone can of course be very expressive, but lyrics and music together can reach a level of expressivity rarely found in any other art form.

Picture Music

Picture music includes all music that is written without actual tones (see Example A). Sometimes this type of music looks more like a drawing than a piece of music, as you will see later in this chapter.

Composing picture music is like playing tennis without the net; there are no rules, only procedures. Your intention is expressed in broad strokes because you cannot be as precise as in conventional notation.

I believe in rules and in guidelines; this workbook is filled with them. Rules and guidelines help you to focus your creative energy by defining the task. You will find this to be true even later, when you have graduated from the rudimentary procedures outlined here.

In place of rules, picture music offers something else: you will begin to rethink the entire process of music. You will get a new perspective through the *visualization* that picture music offers, and thus your conventional music making will be improved.

It must be admitted that picture music is inadequately notated, but I should like to point out that conventional notation is very limited itself and owes more to the performance than is generally realized; a good piece often sounds entirely unlike what the composer had in mind.

Example A is for *found* instruments: key chain, wastepaper basket, and rubber band. Get together with two other people and “perform” this example. Be sure to study the characteristics of each “instrument.” Take this seriously and you will be amply repaid. (All the exercises and examples in this chapter should be performed, when possible.)

Exercise 1

To make picture music, you need picture equipment: several different-color felt-tip markers (“Marko” by Flair is very good, as I noted earlier) and art paper (from 15 inches by 18 inches to eighteen inches by twenty inches).

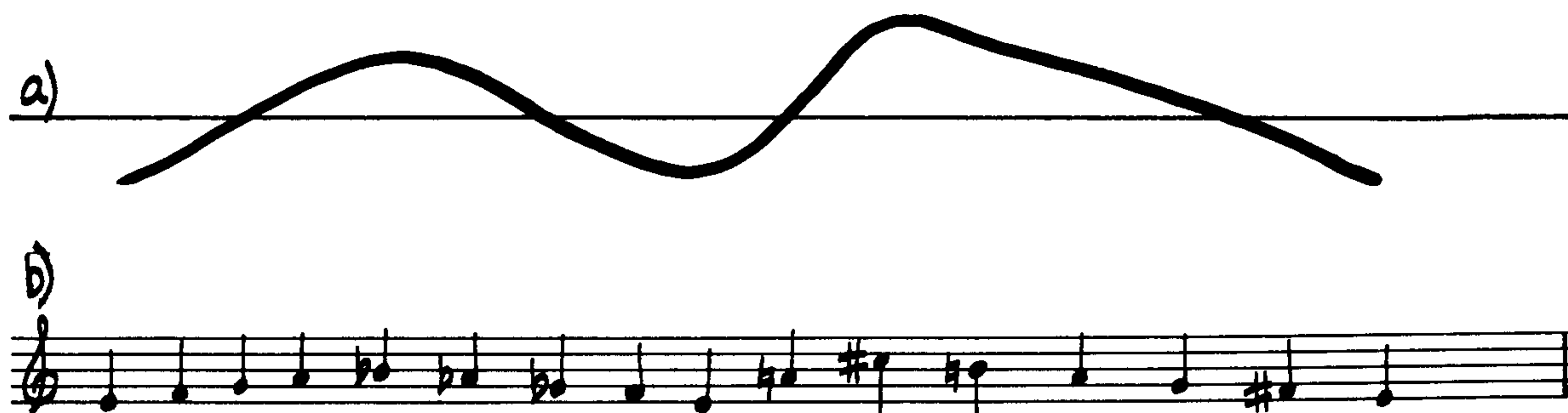
1. Write a short piece for three found instruments. Look hard for good ones and investigate the sound possibilities of each.
2. Write lengthwise on the paper. When you reach the right-hand margin, go to a second sheet of paper. This will give you a better idea of the piece than trying to write the whole piece on one sheet.
3. This piece should be from thirty to sixty seconds in length.
4. Specify the tempo in a general way (we are not using a regular pulse or beat here, but the order of events from left to right can move quickly or slowly).
5. *Line up the three parts* so that events that occur simultaneously are exactly lined up vertically.
6. Use a different-color marker for each instrument and black ink for all indications (dynamics, name of instrument, and so on). The players will do a better job for you if the part looks like you invested some time in it.

7. Express some idea or mood and stick to it. Use a title that captures this idea or mood. Perhaps you will want to make these works portraits of someone you know or of a historical figure.
8. Have the players enter at different times so that each part will stand out.
9. Refer to the General Rules that are applicable (pages 1 to 3), especially with reference to titles.

THE HUMAN VOICE

Now let us turn to the voice. Musical pitch (up and down) is expressed by a curved line: In Example B, a could be interpreted in actual notes as at b:

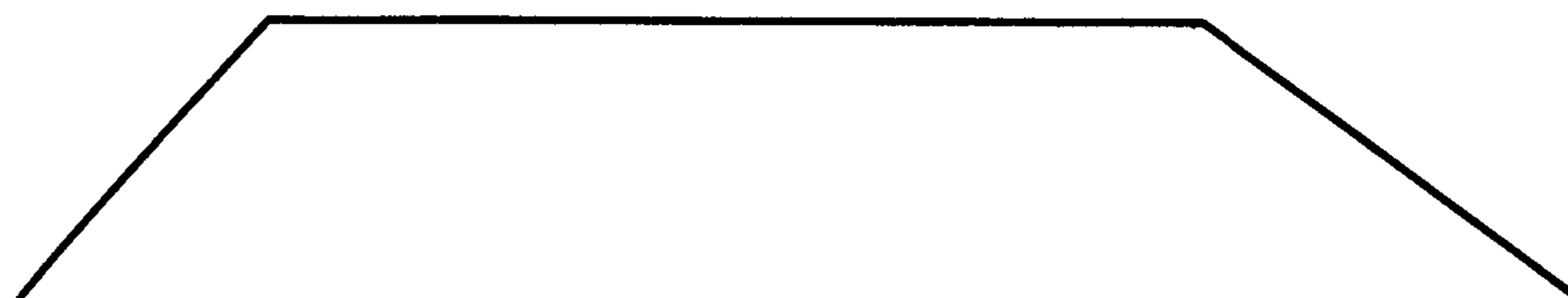

The higher the line is on the paper the higher it is in pitch, and, conversely, the lower the line the lower the pitch. Try to preserve distinctions: if the line goes a *little* lower at one point than another, the tone you sing should be a little lower too. For this reason, I recommend the use of a *guide line*—the horizontal straight line in Example B above. The guide line should be black.

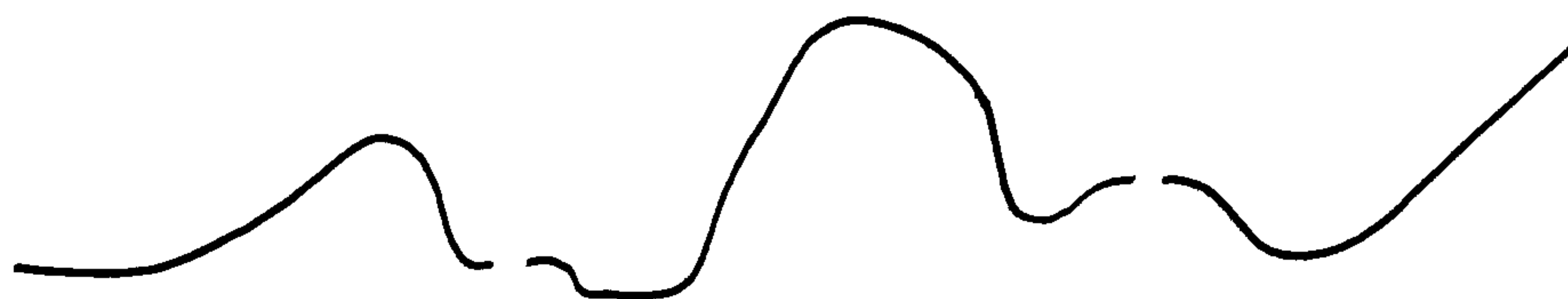
An ascending or descending *straight* line at an angle indicates a glissando:

To indicate a rest (perhaps for breath), leave spaces in the line.

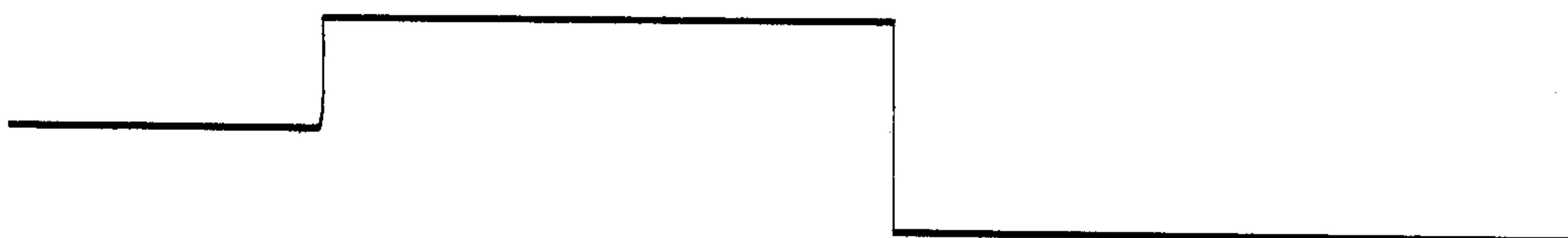
Short notes are indicated by dots and longer notes by dashes (the length of which may vary):

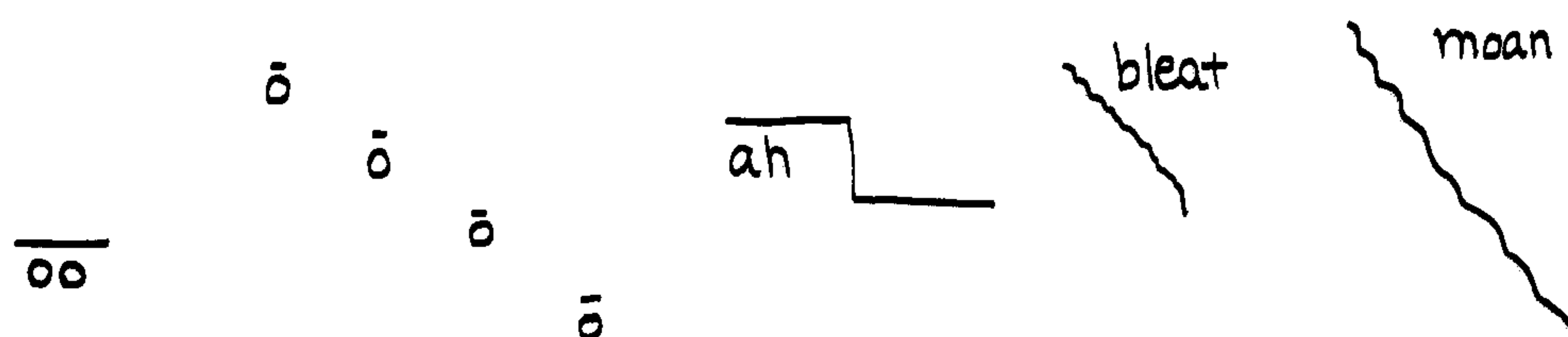

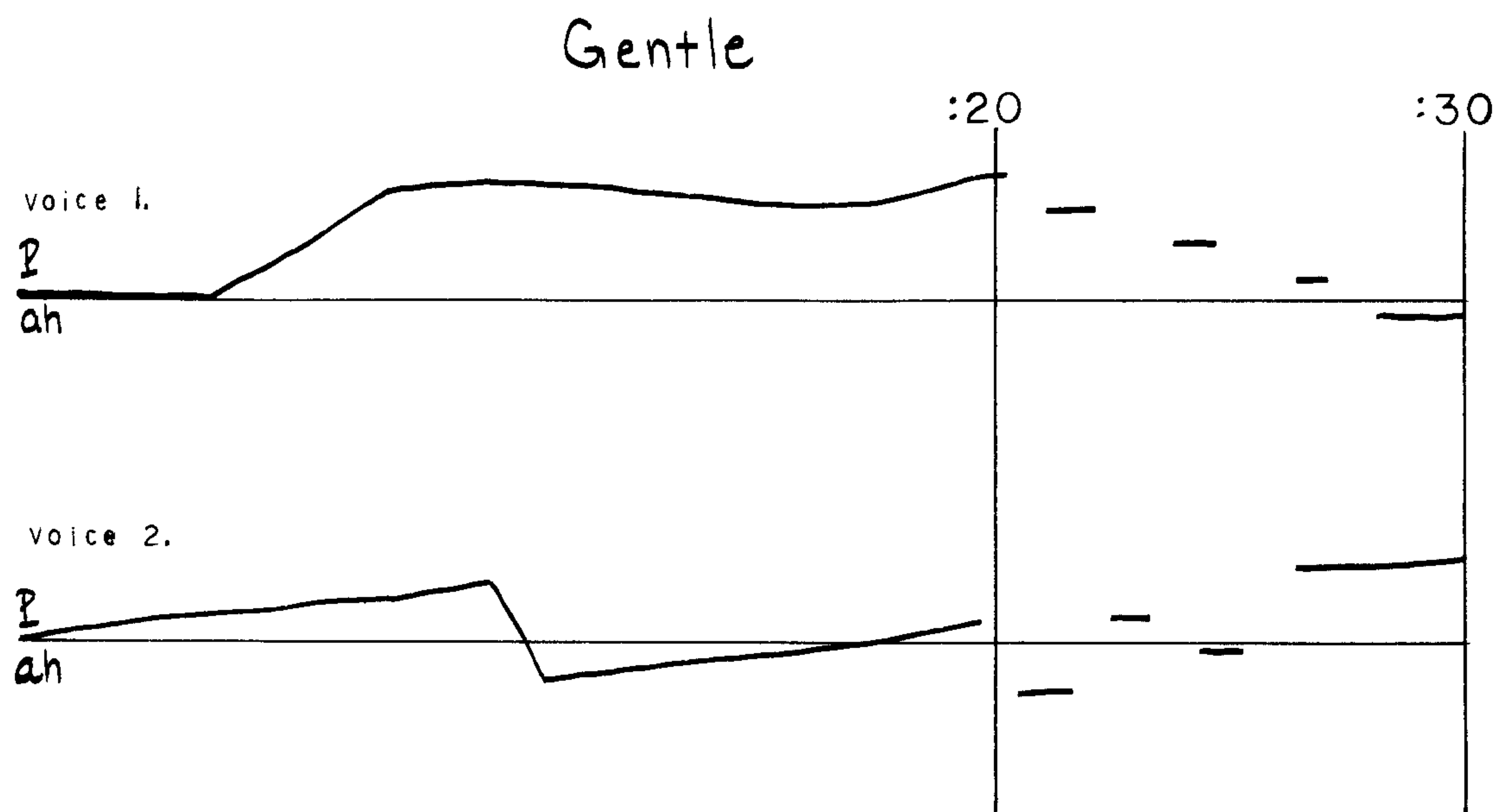

TWO VOICES

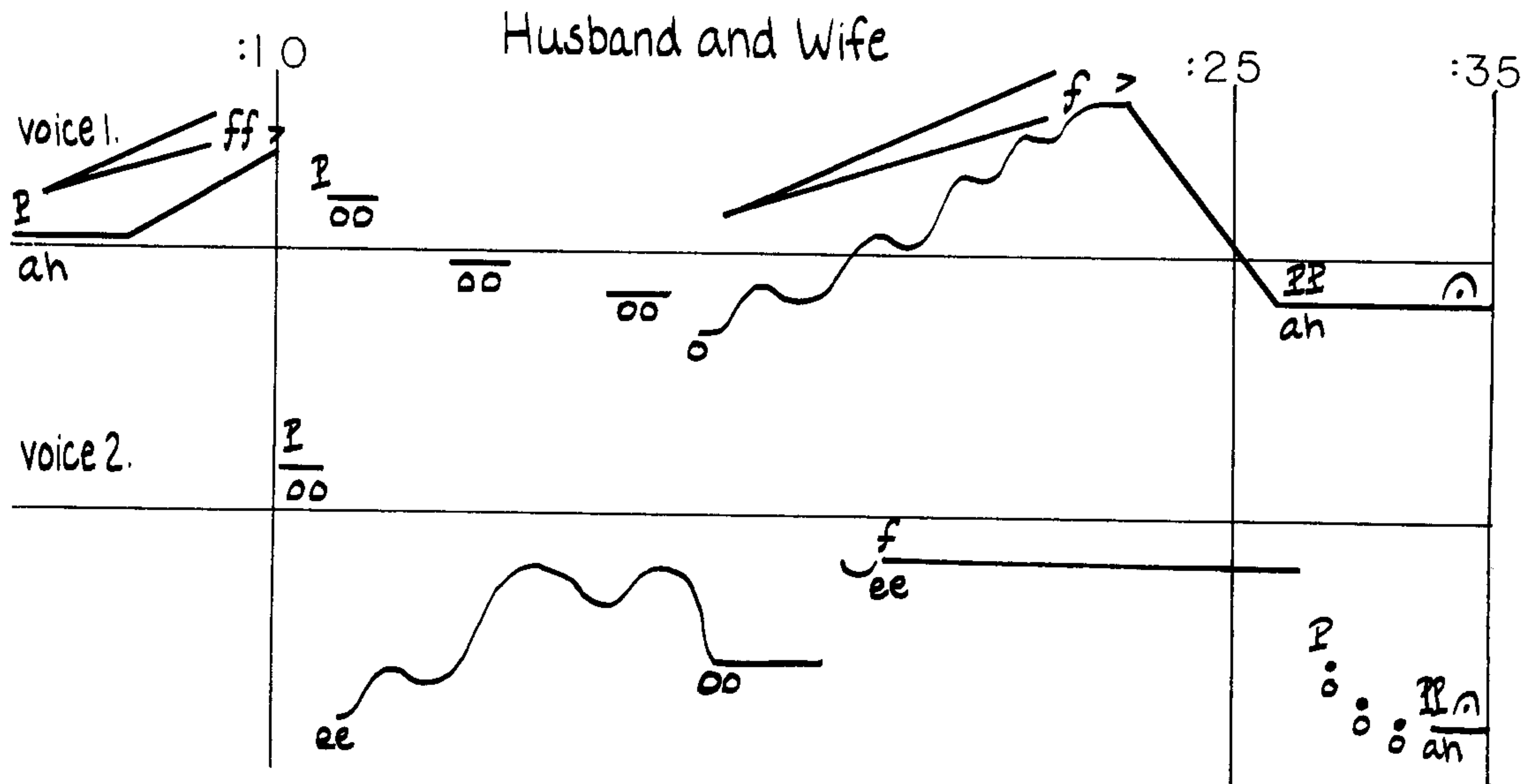
In Example I, I have written for *two* voices. Note the two vertical lines (which should be black, like the guide line) that serve to show the performers the coinciding points for the two voices and also give either a general idea of duration or a specific duration, as shown here. Pieces for more than one player may be “conducted” (that is, the vertical lines may be designated by a conductor) or self-conducted. In either case, everybody will have to pay close attention to everybody else to see how each part is progressing. When timings are used, a large sweep second clock is necessary if the pieces are to be self-conducted.

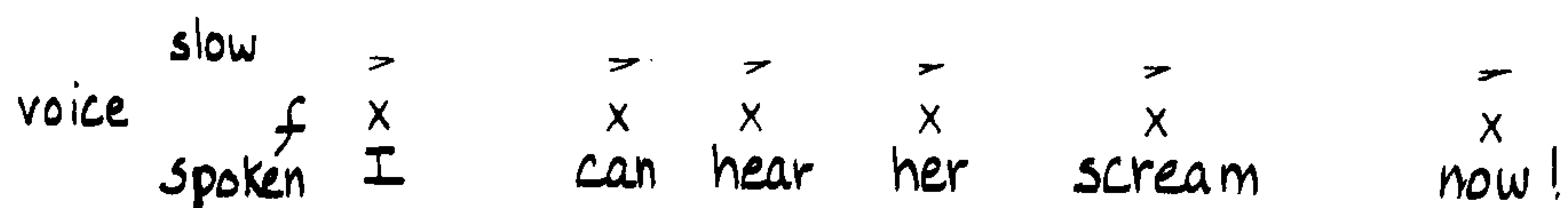

THE VOICE AND WORDS

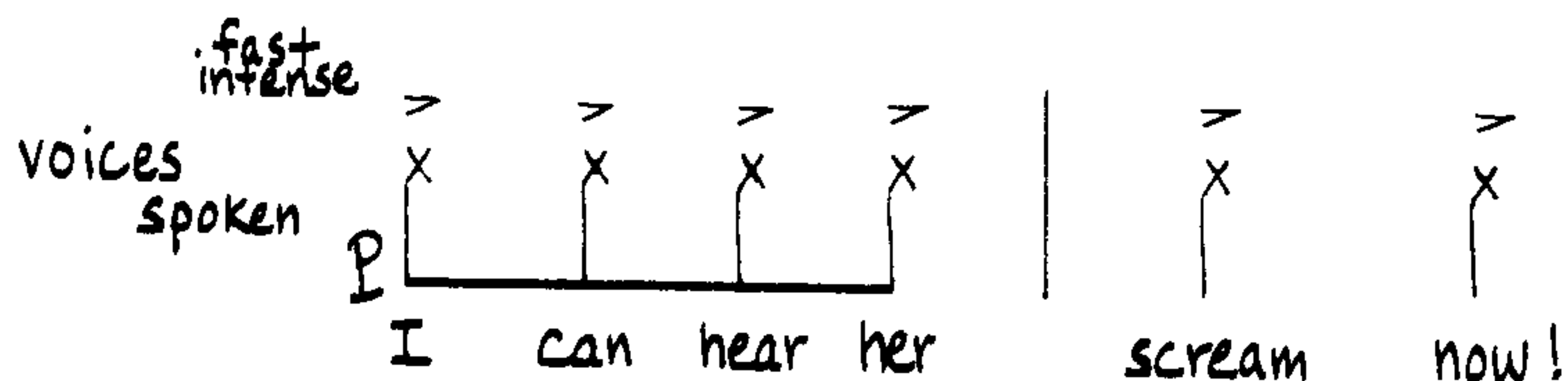
The use of words is the special and greatest resource of the voice because words express concrete ideas and feelings. Let us begin with spoken words, which are indicated with an x:

In Example R, which is for violin and cello, I have made use of some special characteristics of string instruments—pizzicato and slap pizzicato:

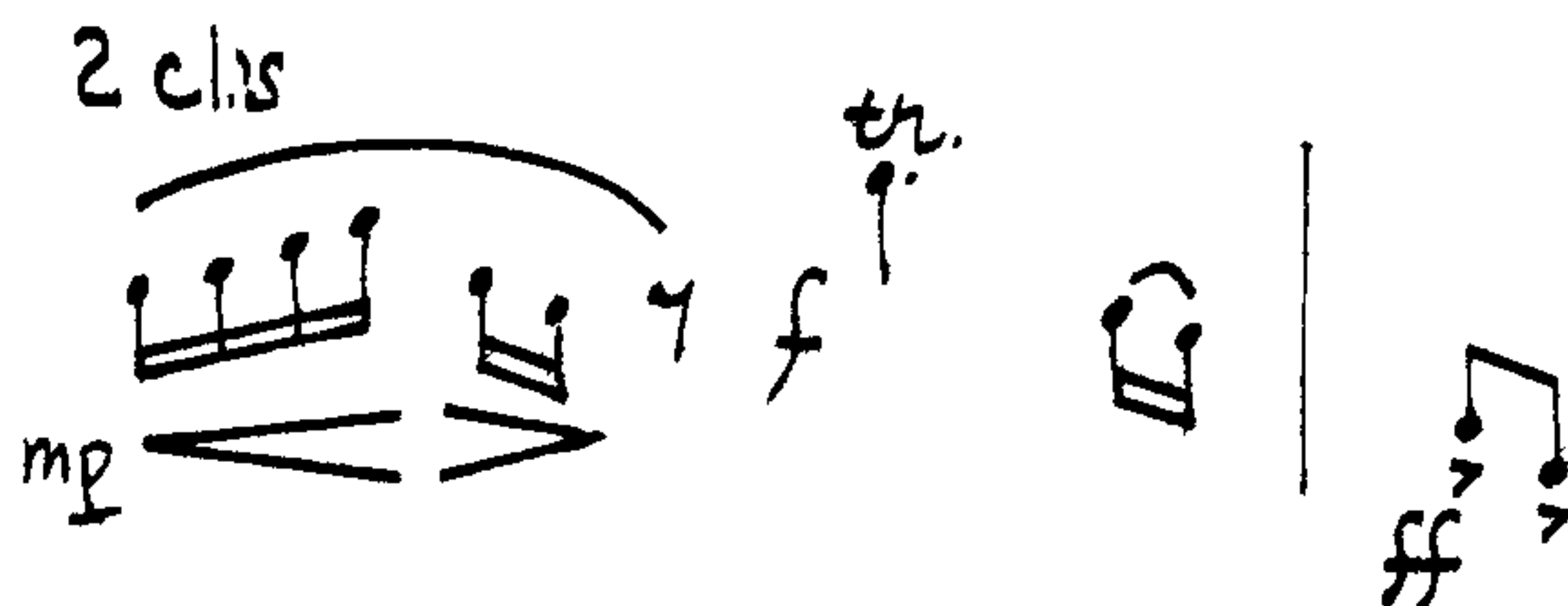

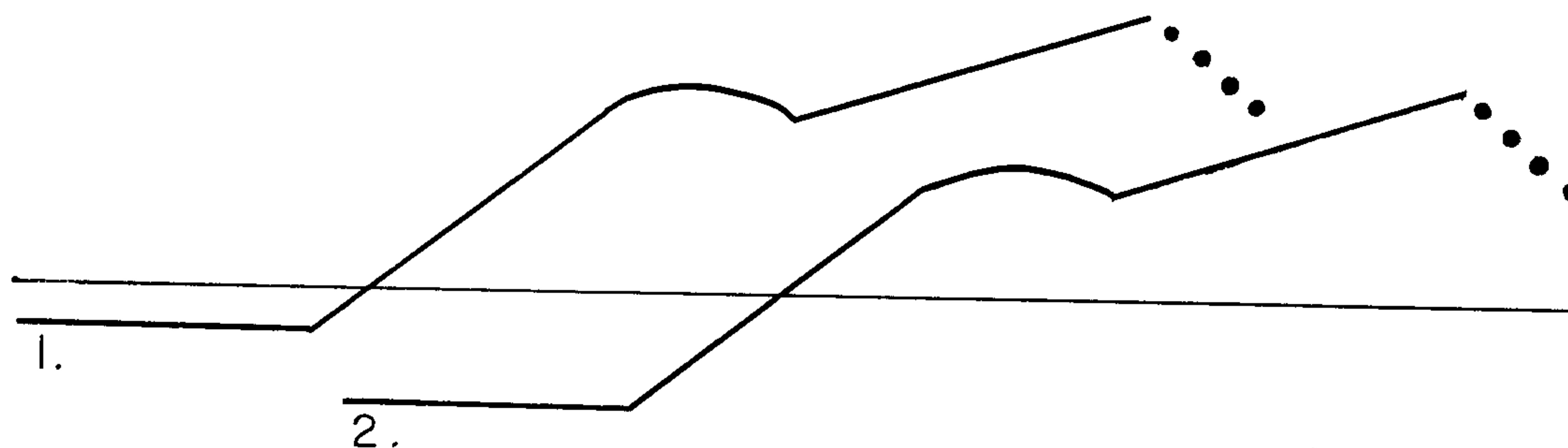

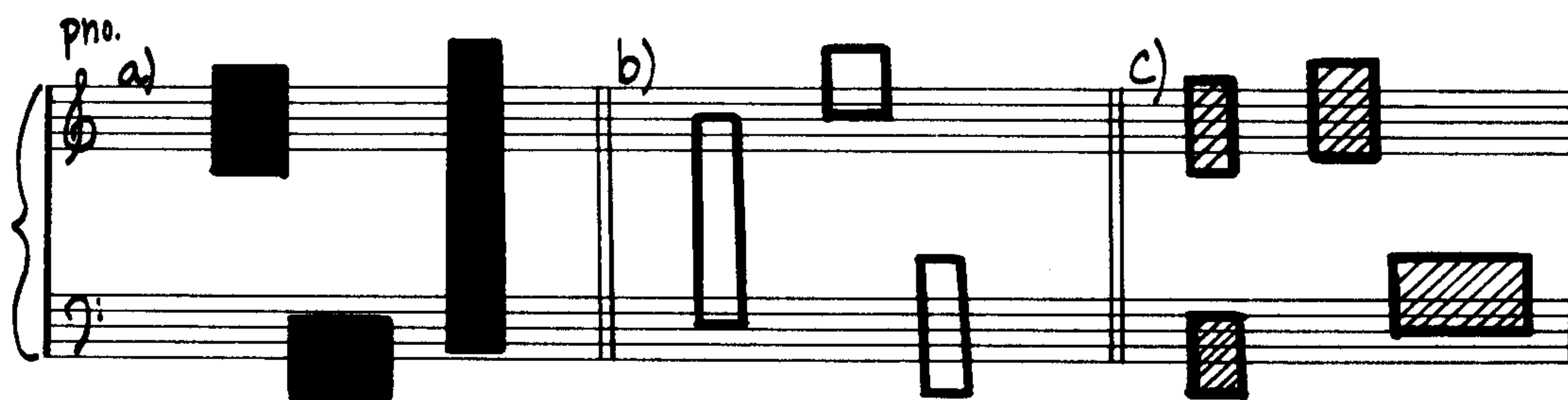

KEYBOARD INSTRUMENTS

When writing for a keyboard instrument, you might want to use clusters, which are bunches of keys hit with either or both hands or forearms. The process in Example X differentiates between black-note clusters (a) and white-note clusters (b). At c I have shown a method of indicating clusters of mixed black and white notes. I have used treble and bass clefs here, but feel free to use only a guide line if you wish. The duration of the cluster is indicated by the width of the box.

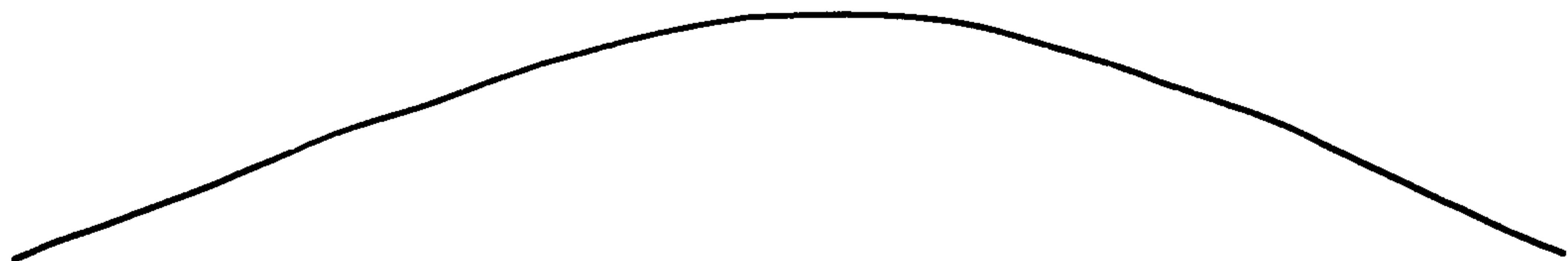

MORE ON THE CURVE

By this time it should be clear to you that picture music will help you to compose conventional music, that picture music is a visualization of conventional music, and that good pictures lead to good pieces. As an example of this, let us return to the subject of the curve, which I discussed in an earlier chapter.

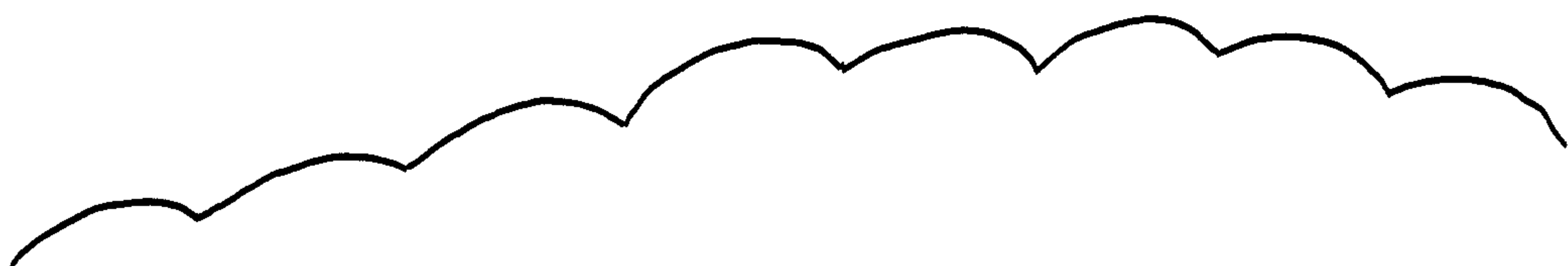

PERCUSSION INSTRUMENTS

In addition to wind and string instruments and piano, percussion instruments can also be used in a picture piece. Either by themselves or with the other instruments, they offer an enormous number of resources.

Popular Music as a Source

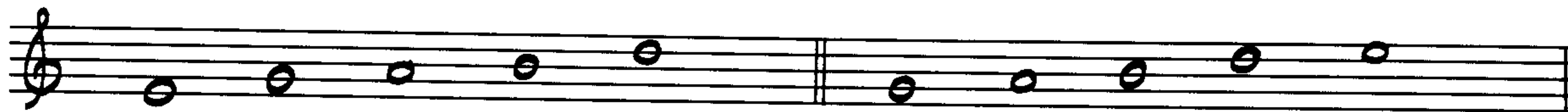
Popular music has invigorated art music through the centuries. All composers of art music have drawn on popular music as a source. “Art music” is the best phrase I can think of to describe music in which humanitarian aims coincide with well developed craft. Sometimes this is called “serious music”—a term that I dislike because it suggests a disapproval of popular music.

Popular music has helped to keep composers in touch with their audience—that is, until the mid-twentieth century, when composers turned away from their audiences (and from popular music), with disastrous results. As the tone of this book suggests, I am concerned with maintaining *good relations* with the audience; I see the composer as a moral force, as an instructor, and as an essential contributor to the good life. So it should come as no surprise that much of this book points toward beauty and simplicity and that we now turn to popular music as a source for art music.

ART MUSIC WITH POPULAR ELEMENTS: SCALES

One way to use popular music as a source is to draw on it in part, to use elements of it. For example, popular music through the ages makes abundant use of the pentatonic scale, especially the forms built on E and G:

In Example B, I use the E form of the pentatonic scale to construct a folk-like melody.

The G form of the pentatonic scale is also very rich in source material. Let us transpose it to C, as we did in Chapter 13.

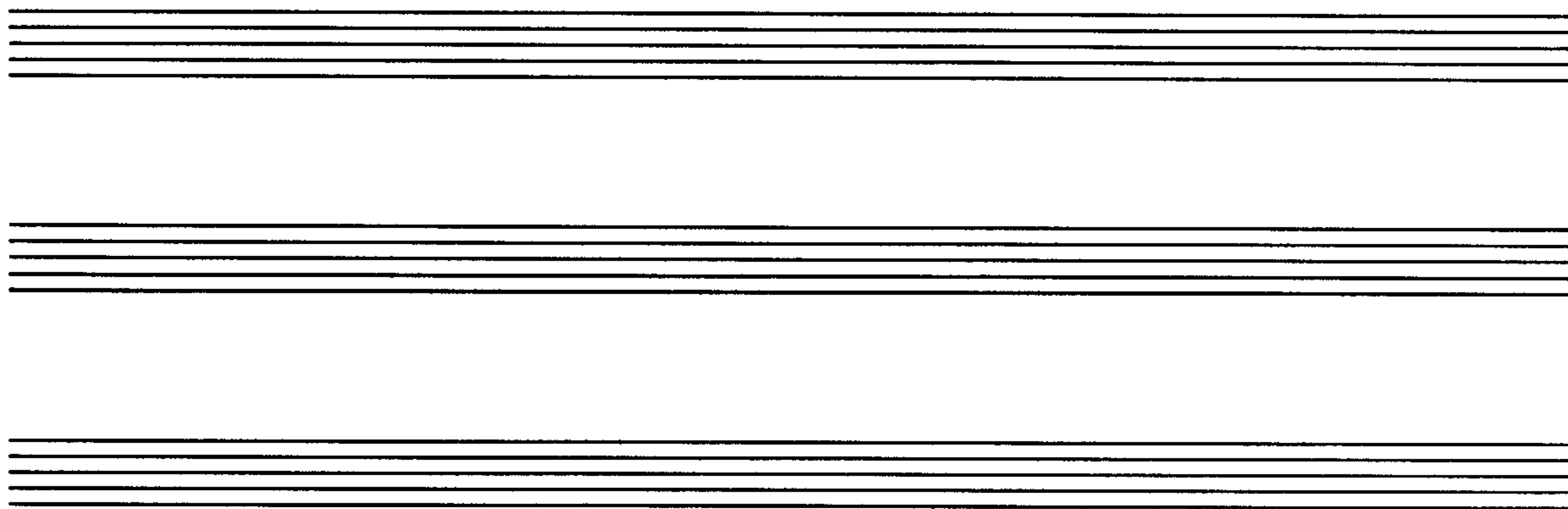


This is the scale that Dvořák used in his famous symphony *From the New World*. The transposed form allows us to use C major harmonizations, as in Example D:

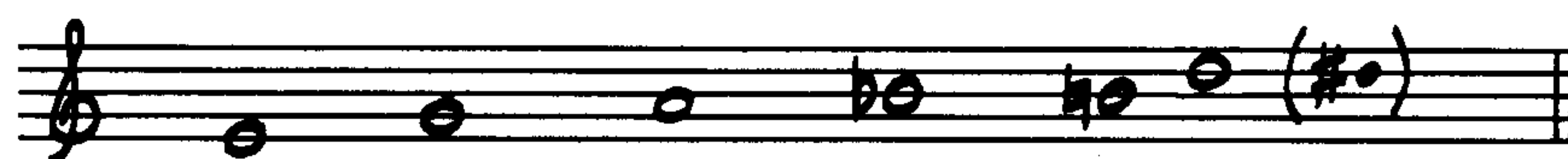

Note the use of neighboring tones on strong beats that resolve up a minor 2nd; this use of neighboring tones is quite distinctive and is employed relentlessly, which serves to unify the passage:

The blues scale is used again in Example H. Here the melody and the chords hardly seem to fit together, since so many tones in the melody are non-chord tones. However some of these non-chord tones are *blue notes*—the minor 3rd and minor 7th of a major triad; because of blues and jazz, the ear perceives these as almost legitimate chord tones when used in a blues or jazz style, as is the case here.

ART MUSIC WITH POPULAR ELEMENTS: MELODY


Earlier we looked at the use of melodic characteristics such as blue notes, the pentatonic scale, and the blues scale. Other sources that popular music offers are the melodies themselves. (Here it is better to restrict yourself to public-domain songs, which are not covered by copyright and may be used freely.) Let us take "I'm a Wayfarin' Stranger," a well known folk song. Here are the first eight measures:


In Example R we see this same succession of tones, the durations of which have been altered by irregular diminution and augmentation. Note that the melody, which is in D Dorian, has been harmonized with chords from D Dorian. Also note the reverse neighboring tones in measures 4 and 8 and the long neighboring tone in measure 9; such uses work best in simple, diatonic passages.

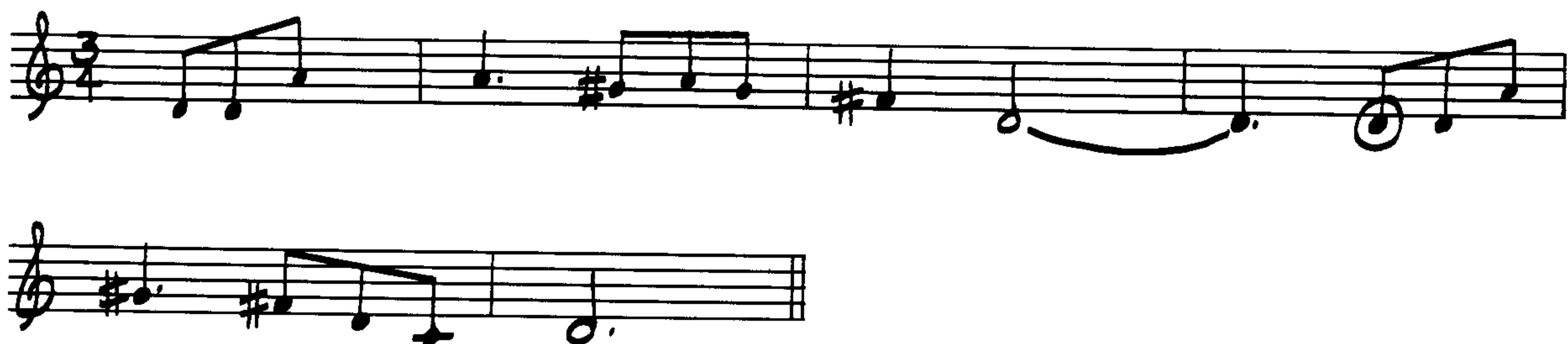

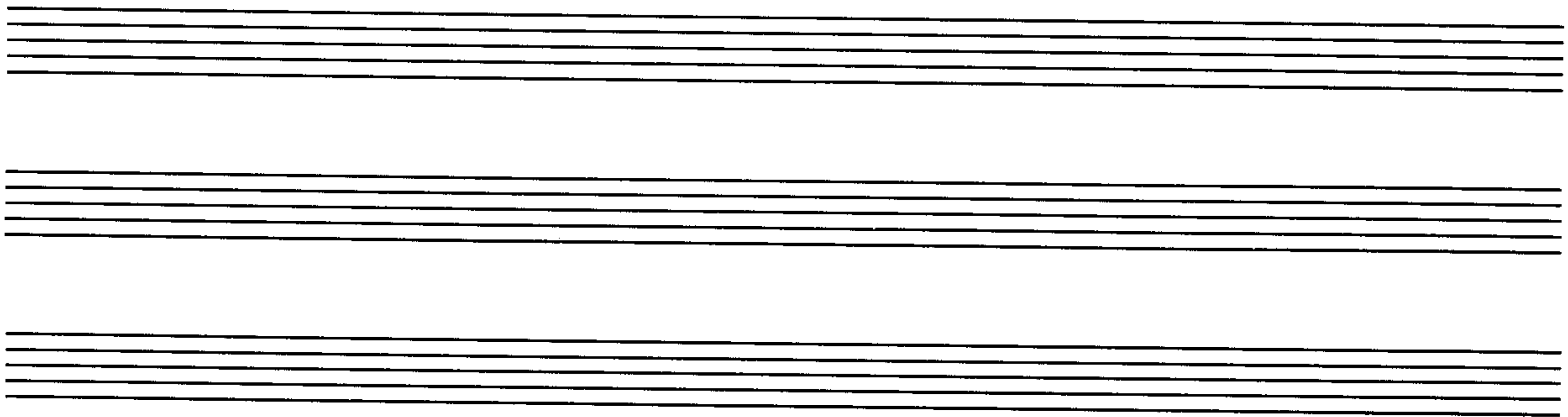

It must be clear by now that a song like “I’m a Wayfarin’ Stranger” lends itself to countless procedures, whether you use the entire melody or only a portion of it, as we have here. If you use the entire melody, apply the theme and variations techniques, which are laid out in Chapter 3.

Some of you may fear that the procedures described in this chapter will lead to pieces that lack originality. Don’t worry. If you have talent, it will emerge. Borrowing creatively is good for you—and good for music too. If it “sounds like I’ve heard it somewhere before,” the chances are that you’re getting the point.

ART MUSIC WITH POPULAR ELEMENTS: ACCOMPANIMENT

In this section, we turn to popular sources for accompaniment, which popular music offers in abundance. The bass line in Example T is a good example. It is drawn from the blues; I found it irresistible to work with (it is used throughout the third movement of another blues work of mine, *Three Pieces for Blues Band and Orchestra*).^{*} To this ostinato, I composed a melody for the violins. Note that all of the non-chord tones except the first can be thought of as members of the blues scale. (Transpose the blues scale from E down a major 2nd to make this clear; however, you should be able to hear it when it is played.)

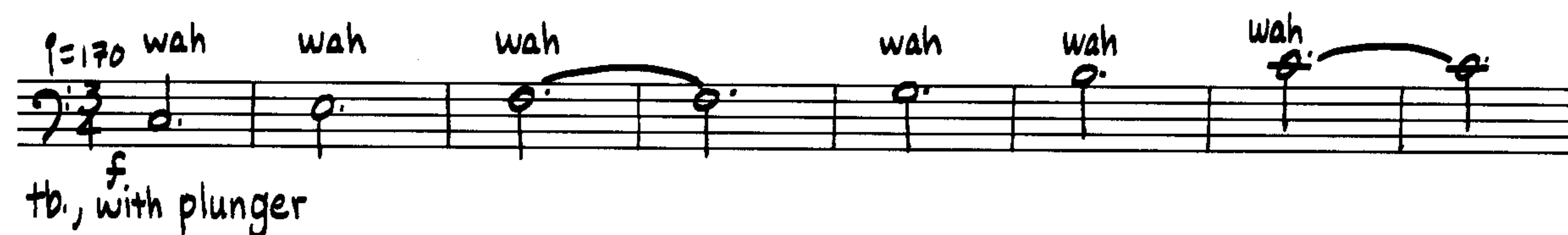

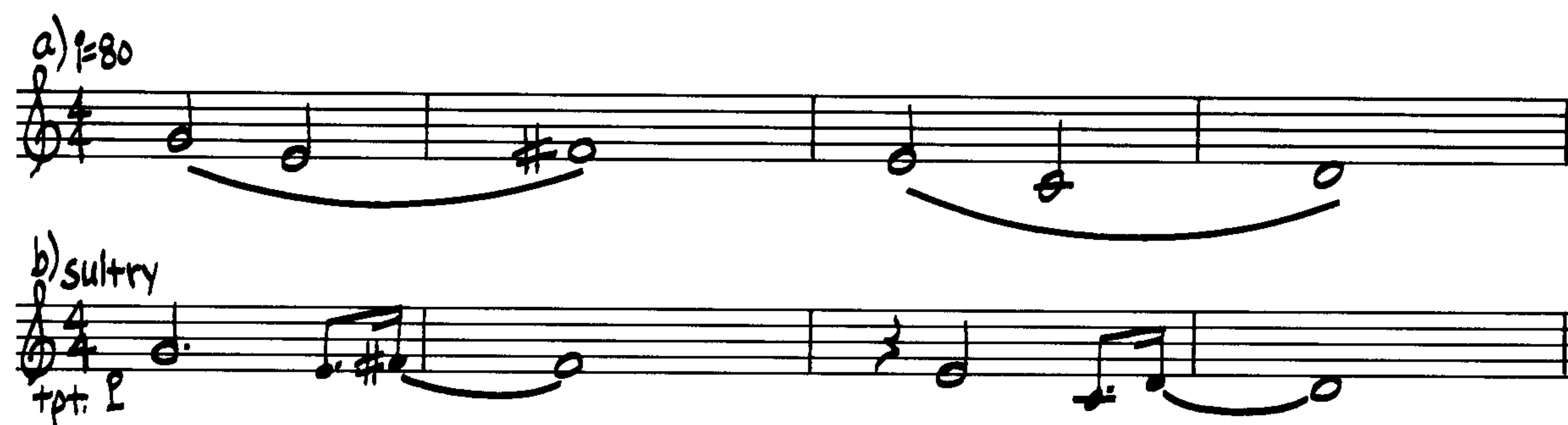

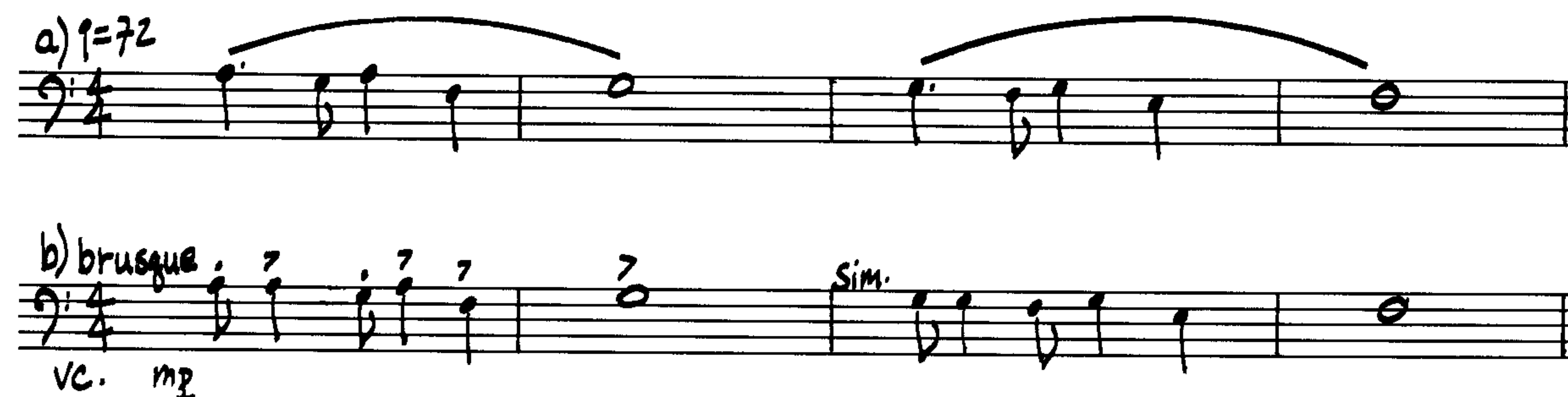

ADDING A POPULAR ACCOMPANIMENT

Earlier in the chapter I talked about writing a non-pop melody to a pop accompaniment. Here again you can reverse the process. In Example U the melody (in the bass) came first and the bluegrass-style accompaniment was added to it. Note the blue notes in the accompaniment:

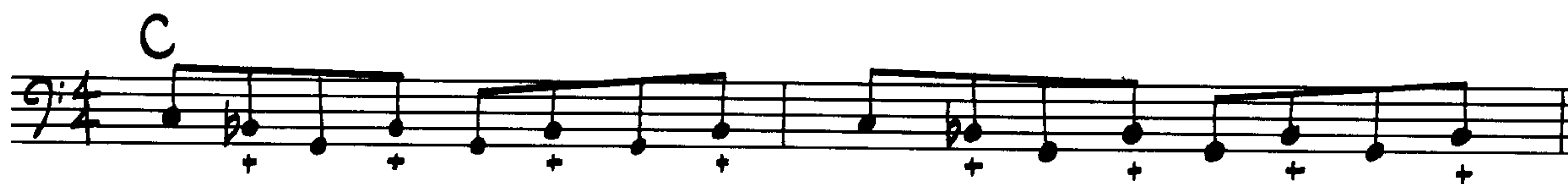

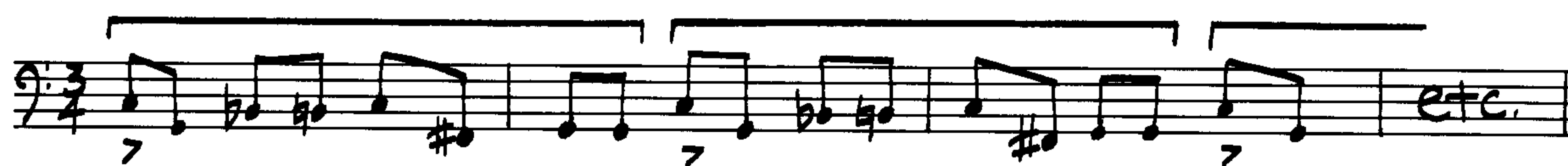

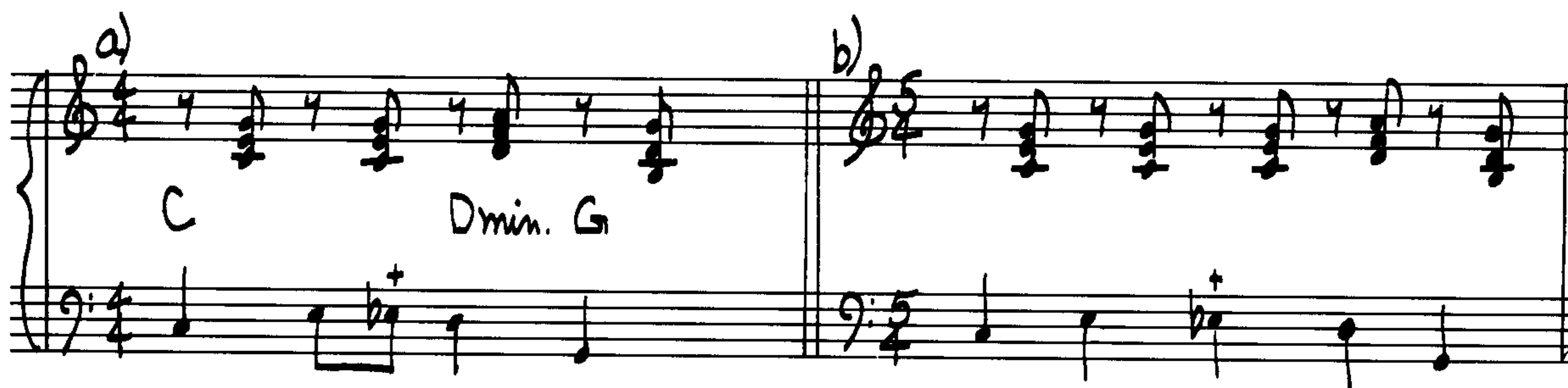

JUXTAPOSITION OF ART MUSIC AND POPULAR MUSIC

So far I have discussed the *blending* of popular music and art music. It was only recently, however, that I discovered how easily music can move from one style to another—how two or more styles can be juxtaposed. Part *a* of Example BB shows a melodic theme that was the basis for the processional at a Columbia College commencement. This theme is severe and dignified—

very non-pop. We were just about through playing the piece when the stage manager signaled me that we had to fill in with ten minutes of music. I indicated to the pianist that he should improvise upon the theme; he did so, eloquently. Then a burst of inspiration hit me, and I asked the bass player to add a jazz bass line; the pianist moved into a jazz improvisation, and it worked wonderfully, continuing with several improvised solos by other instruments. As the last of the graduates moved to their seats, I brought the orchestra back into the processional as originally conceived (as a “serious” piece), and the juxtaposition between the pop and the non-pop was a complete success.

Since then I have worked with juxtaposition between non-pop and pop styles in many of my pieces, and I am happy to report that it is a procedure that holds a great deal of promise. To go much further in discussing this procedure would be beyond the intention of this book, but I want to plant the idea in your mind.

One last word: You must *always* believe in the popular music you draw on, or what you write will be self-conscious and false. These exercises will open you up to the immense possibilities that stylistic mixtures offer you, but you must be honest in using these possibilities.

Minimalism

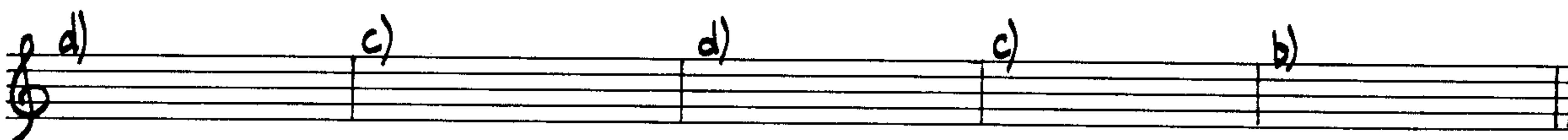
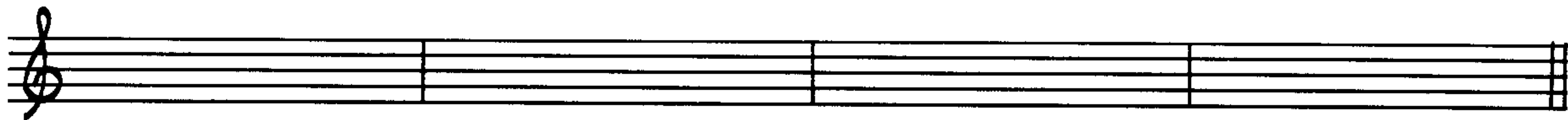
ISORHYTHM REVISITED

Minimalism means using less to achieve more. Much of this book is based on minimalistic procedures: the cell, the row, and the use of Basic Note Values, for example. Minimalism also has stylistic and aesthetic implications, which I will discuss after developing minimalistic procedures further.

POINTILLISM

In Example A the melody has been divided among four instruments. Note that the horn and the trombone are muted, making them more similar in tone color and volume to the flute and clarinet. Also note that each of the parts is *playable*—that the parts do not contain awkward rhythms, such as two $\frac{1}{8}$ notes followed by a rest. This procedure of dividing a melody between two or more instruments is called *pointillism*.

THE FALSE SECOND VOICE

In Example B I show a simple melody in D Dorian, harmonized with chords from D Dorian. (Note the double passing tones in measure two; these are acceptable because they are of short duration and because the harmony is diatonic.)

Example B



Example C shows the melody of Example B divided between two instruments pointillistically. However, there is one principal difference between this example and Example A: tones are held over, creating the illusion of two-part writing. This process can be applied only when the held-over tone belongs to the chord. It is not a good idea to hold a tone over when it is *above* the melody unless the instrument that is holding over is the weaker of the two instruments, as in measure 2. Also note in measure 3 that I have created a *false second voice* by adding a tone to the oboe part; such added tones must be *beneath* the true melody so that the true melody is not obscured. (The true melody is marked with vertical arrows.)

HETEROPHONY

Another form of minimalism is shown in Example D. It is called *heterophony*, two forms of one melody played simultaneously. In this example the lower part is the original melody and the upper part is an embellishment of the original melody.

Exercise 7

MORE ON BUILDING BLOCKS

Exercise 9

1. The bass-clef accompaniment to the melody is to be filled in with the building blocks labeled a) and b). These are like the building blocks in Exercise 2 in that they work well in almost any order. But note that they are used simultaneously as well as consecutively.
2. Fill in these building blocks as indicated. The last measure may be freely composed to round off the piece.

TWO OR MORE OSTINATOS AT ONCE

I would now like to develop the simultaneous use of more than one ostinato pattern (as employed in Exercise 9) a little further. The simultaneous ostinato accompaniment patterns seen in Example F, a, can be transposed down a major 2nd, as at b.

When constructing an entire piece of music, you might begin with a section ten to twenty measures long built on a. It could

be followed by a ten-to-twenty-measure section built on *b*, using either the same theme for both sections (transposed down a major 2nd for part *b*, of course) or two different themes. Either way, you could return to the first section built on *a*, using the first theme or a new theme.

Hint: Note carefully that non-chord tones occur only in one part at a time. Also, since all tones in this example are from the pentatonic scale, in which there are only three slightly dissonant intervals (see Chapter 10), serious clashes are less likely.

Exercise 10

Write out *a* in Example F down a perfect 5th:

This type of accompaniment is so basic and so powerful that it will bear large-scale repetition. But you may wish to modify such large-scale repetition by means of transposition, as shown in Example F, or by a different process, as shown in Example G: here, each of the patterns is altered slightly, one at a time, and very gradually over a substantial number of measures. (A changed pattern is shown by an arrow.) This procedure will hold up for as long as five minutes, depending on how good the materials are and also on how deeply you wish to delve into the experience of Eastern “timelessness,” from which this type of accompaniment is derived.

KALEIDOSCOPIC OSTINATOS

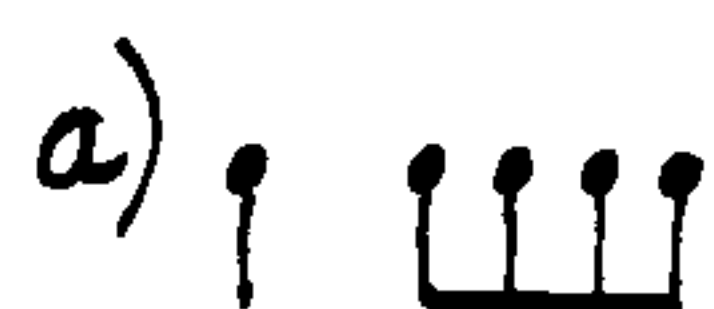
An excellent minimalistic accompaniment procedure is to compose two simultaneous ostinatos, each with a different number of beats (not divisible into each other), as shown in Example I, where the relationship between the two patterns keeps changing until they come back together in measure 4. Compare this to out-of-sync isomelody and isorhythm, which takes place within one voice (see Chapter 6):

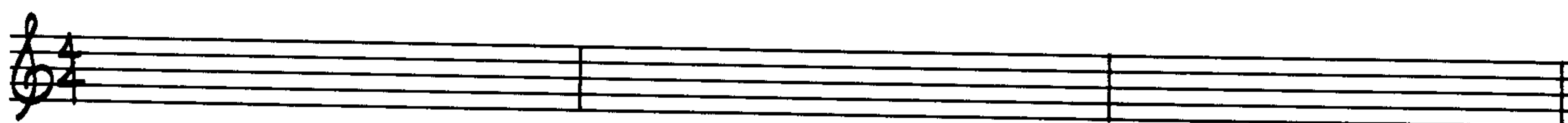

I refer to this procedure as *kaleidoscopic*: two or more ostinatos of unequal length out of sync with each other. Example J is based on the E pentatonic scale (E G A B D), and it consists of four ostinato patterns: *a* is twelve beats long, *b* is three beats long, *c* is one and a half beats long, and *d* is two beats long. These four patterns come together every three measures.

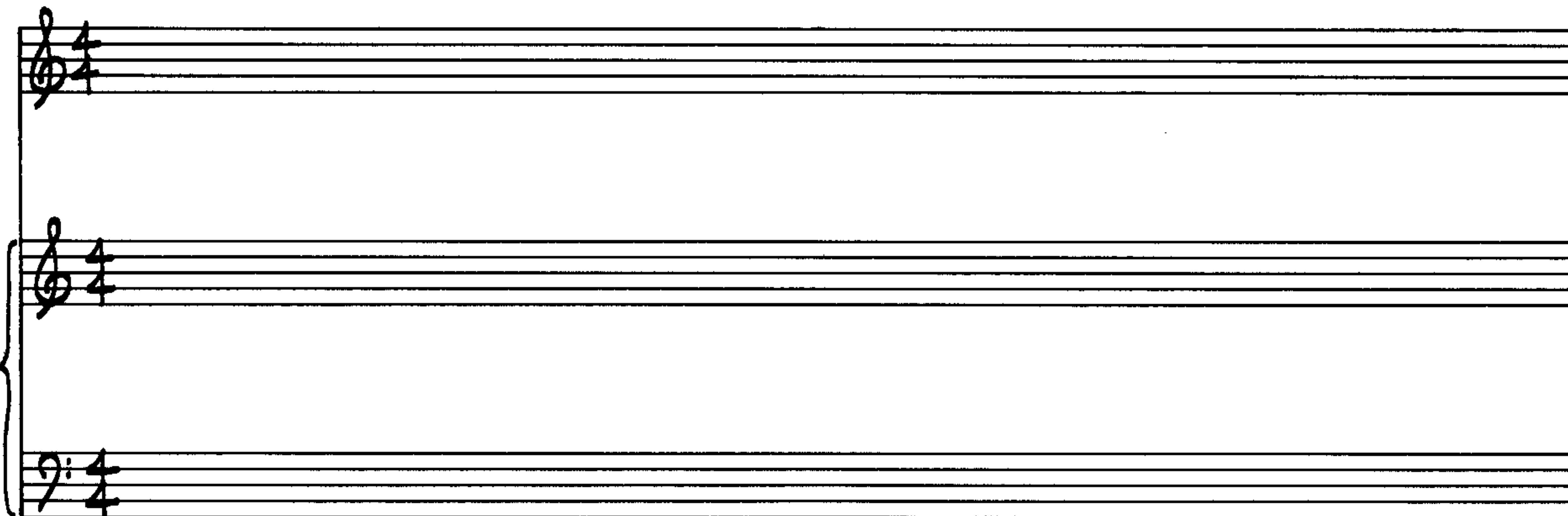

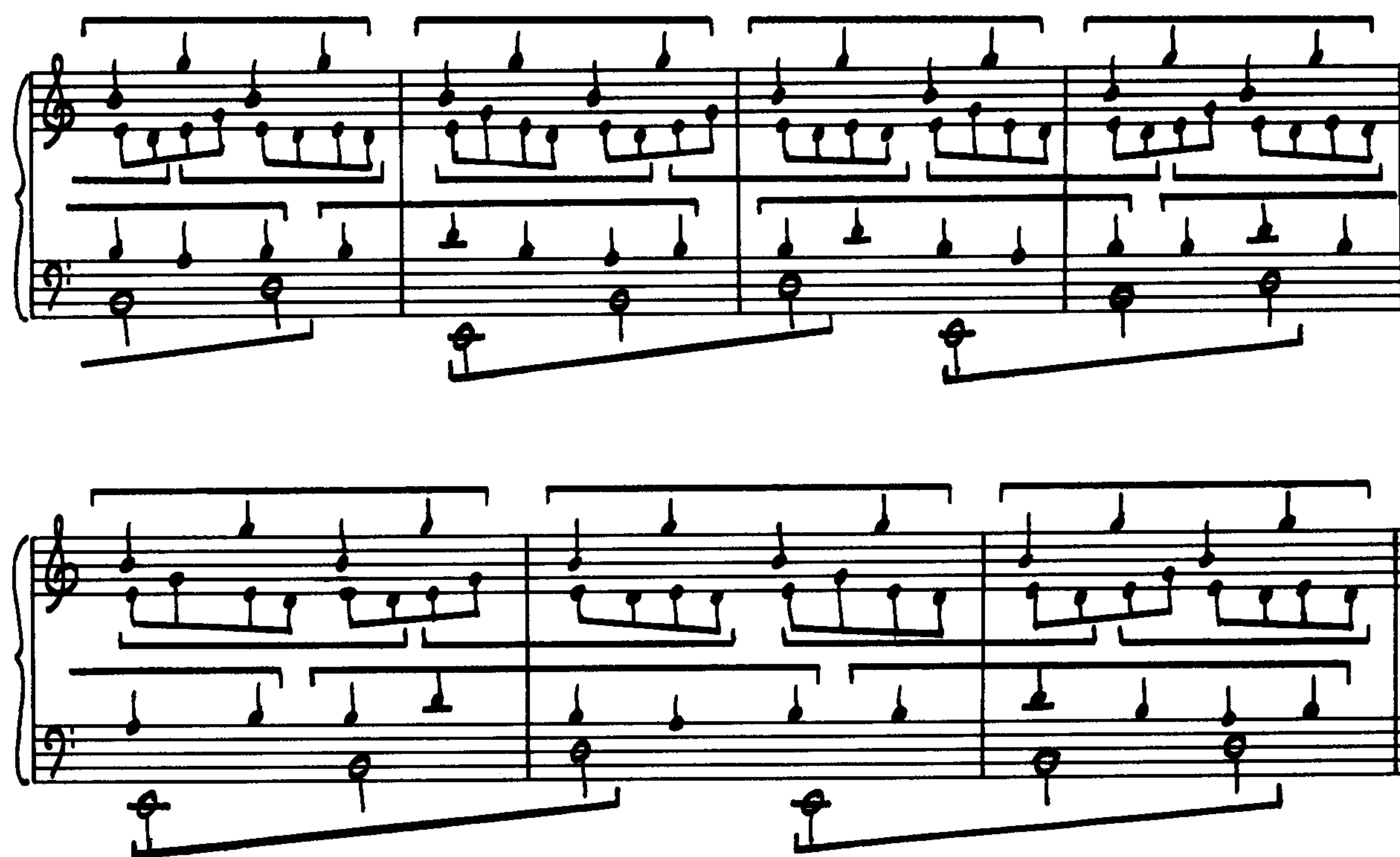




A more extensive use of the kaleidoscope principle is seen in Example K, in which the patterns come together after fifteen measures: *a* is four beats long, *b* is three beats long, *c* is five beats long, and *d* is six beats long. In this example I have based all of the patterns on tones from the E minor 7th chord (three stacked thirds), which you can also think of as E G B D from the E pentatonic scale.

VOICE CROSSING

Another way of making more out of less is through voice crossing. In the repeated-tone accompaniment shown in Example L, a, instead of giving one instrument the upper tones and another

the lower tones, you can alternate each instrument between the upper and lower tones, as shown in *b*. Even when played by two identical instruments (two trumpets, for example) *b* will sound different from *a*:

Apply voice crossing to *a* employing two identical instruments or two instruments of similar range and weight (horn and trumpet, for example):



The voice-crossing process is an integral part of the gamelan music of Indonesia, in which it is often applied to more than two voices.

A further procedure derived from gamelan music is the distribution of a single melody among several instruments, each playing the entire melody, but in different tempos or rhythms. Example M uses a single three-note melody. Note the reiteration in the clarinet part. (It is possible to use more than one melody at a time. Also, you may want to investigate combining this gamelan procedure with voice crossing.)

AFTERTHOUGHTS

As I have said several times now, minimalism is a way of getting more out of less: for example, voice crossing, pointillism, heterophony, and so forth. Minimalism also suggests ways of keeping going, of spreading out material over a long stretch of time as seen in the ostinato (especially the modulating ostinato and the kaleidoscope ostinato). It is also minimalistic to derive chords from the melody (Chapter 9), construct a melody from the tones of organum (Chapter 13), and so forth.

But the essence of minimalism is limitation of resources as seen in the cell, the row, isorhythms, and the use of specific scales (major, Phrygian, Lixian, pentatonic, among others). Such a limitation of resources serves two purposes: first, it unifies the material, it holds the material together, and leads to the wholeness that all composers strive for; second, it acts as a stimulus to creativity. The reason why limitation of resources acts as a stimulus is not known, but it is undeniably true. Nothing is worse than sitting down to compose with the *limitlessness* of music stretching out before you. It is of great value to reduce this limitlessness, to know that you will compose a piece of three-minutes duration for flute and clarinet, using only the C Lixian scale and its transposition, such-and-such an isorhythm, and the small theme forms. With limitation of resources, you will feel safer, you will know what the limits of the task are, you will feel challenged, and you will want to make these meager materials into something of value.

Another supremely important aspect of minimalism is *stylistic*: for one thing, minimalism can lead you to avant-garde music or to popular music. How is minimalism avant-garde? The most obvious example would be in a melody drawn from the 12-tone row, with all harmonies derived from the melody. But you can compose avant-garde music even with a simple scale if you severely restrict all its elements. For example, you can compose a piece based on the pentatonic scale with two rhythms for pizzicato violin and muted trumpet used only as solo instruments or in organum with each other.

Minimalism also leads to popular music in ways almost too obvious to be listed, such as a small theme for flute based on the C pentatonic scale with an oom-pah accompaniment based on major and minor triads drawn from the C major scale.

My own interest in minimalism is that it can lead to what I call *populist* music, music that uses all the minimalistic procedures, but with more heart and passion than in avant-garde music, and more wit and wisdom than in popular music. At its worst, avant-



















garde distances itself from the audience, and popular music at its worst reaches out to its audience almost excessively, is too obvious and literal, and tells us nothing about the universe.

I hope that you are led to populism, if not now, perhaps sometime later. Regardless of how these ideas strike you, however, it is indisputable that you must find your own voice and obey it, and in this pursuit minimalism will be enormously helpful. Seek out the limitations and procedures that are most congenial, with which you are most at home, and that allow you to express the deepest part of your being.

Appendix A: Instrument Ranges

Here are the ranges of instruments you may be writing for in this book. The ranges are shown at actual pitch (except for the double bass, which always sounds an octave lower than written). This means that for some instruments you may have to consult the player you are writing for or an orchestration book for the correct transposition.

The range of each instrument is shown by open notes, and *practical* limits for most players are shown by black notes. (Individual players may have a wider or narrower range than shown, and you should always ask the players you are writing for about their particular abilities and limitations.)

Appendix B: Musical Symbols

Here are some useful symbols and their usual placement. These symbols are invaluable in helping a player make a piece come to life. In addition to using these symbols, you should indicate how a piece, or section of a piece, is to be performed (“sweetly,” “sneakily,” “dirge-like,” and so on).

DYNAMICS

These are usually placed below the staff.

pp *pianissimo* (very soft)

p *piano* (soft)

mp *mezzo-piano* (moderately soft)

mf *mezzo-forte* (moderately loud)

f *forte* (loud)

ff *fortissimo* (very loud)

sfz *sforzando* (suddenly loud)

fp *forte-piano* (loud and immediately soft again)



cresc. (crescendo) gradually increasing the volume

dim. (diminuendo) gradually diminishing the volume

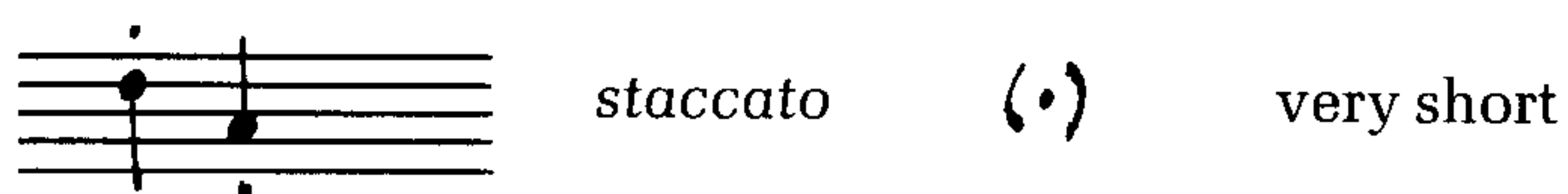

Note that dynamics are placed just *before* the first tone they affect.

ACCENTS

These are always placed outside the staff and near the head of the note.

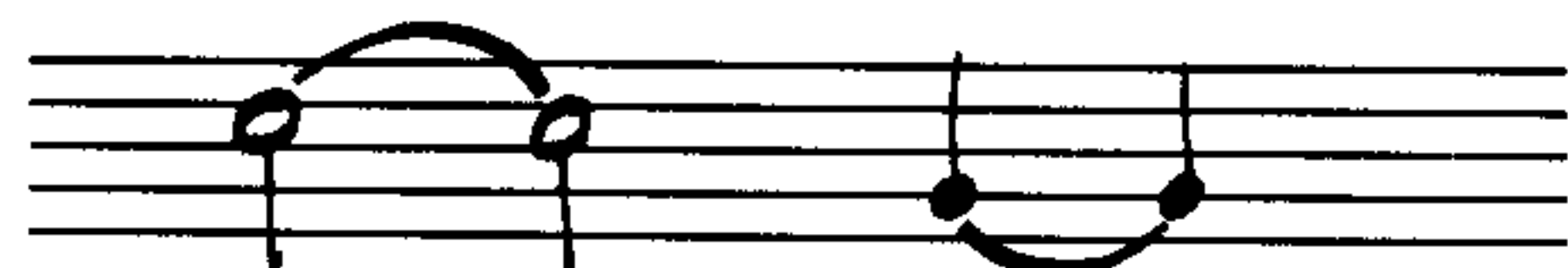

SLURS AND TIES



ties—placed above note heads when the stems are down and below note heads when the stems are up. The tones are held for the combined value of the notes involved. Only the first note is sounded.



ties—placed above whole notes that are on the third line or higher.



slurs—for a few notes and for short phrases, slurs are placed like ties when the stem direction for all notes is the same. The slur indicates that the notes involved are to be played *legato*—that is, smoothly or closely connected.



slurs—when one or more of the stems are down, slurs go above the notes.

TEMPO

These indications are generally written above the staff at the beginning of a piece and at any point where you want the tempo to change. Tempo may be indicated in two ways:

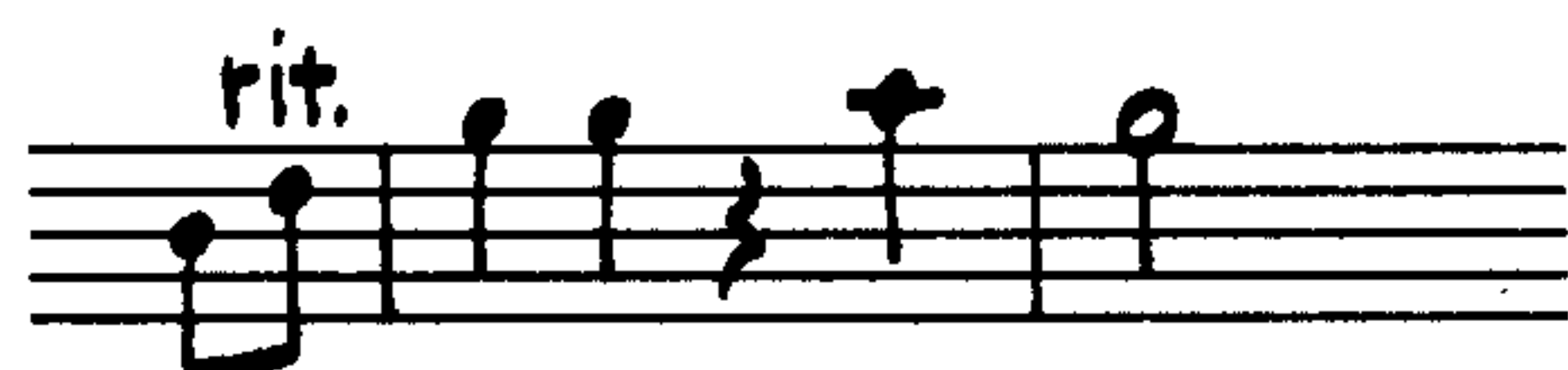

metronome marking—this symbol gives the tempo by telling you how many notes of the given value are in one minute.

words—using words that describe the character and speed of the piece. You should consult a dictionary of musical terms and use your imagination for the many ways of explaining the character and mood you intend.

Here are some other terms you will find useful:

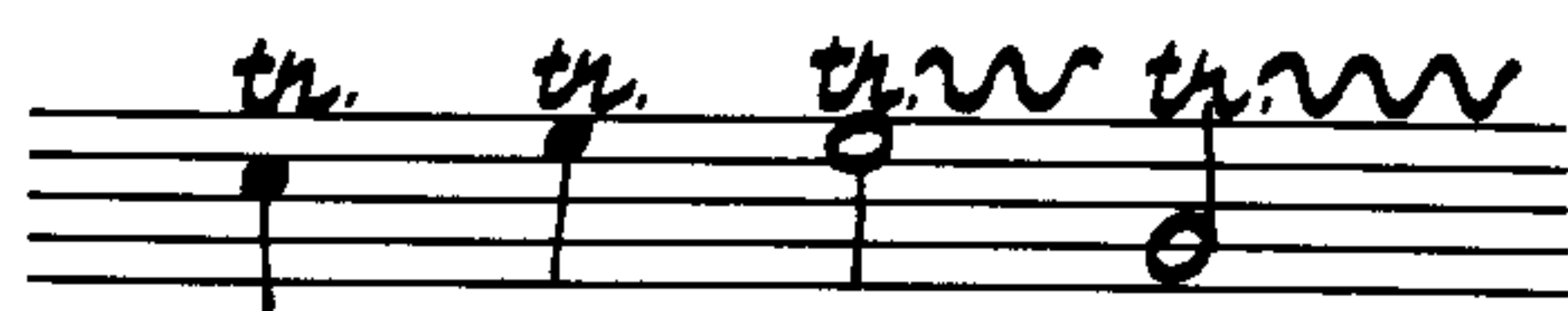


rit. (*ritardando*) gradually getting slower



accel. (*accelerando*) gradually getting faster; this is usually followed by a change in tempo, or *a tempo* (return to the original tempo)

GENERAL SYMBOLS



' = *breath mark* (this also suggests a pause for non-wind instruments)

tr. = *trill*

tr. ~~~~~ = *trill* (for ½ notes or longer)

sim. (*simile*) *similarly*; continue a formula that has been indicated, such as an accent pattern or the arpeggiating of chords (*simile* may be placed above or below the staff)

MUSIC

Aimed at those who have some knowledge of music but no formal training in composition, this concise introduction to composing music starts right in with a composition exercise using four notes, then proceeds through a series of increasingly complex and challenging problems, gradually expanding the student's musical grammar. Blank music score is provided for exercises and experimentation. *Composing Music* also includes the principles of setting words to music, as well as sections on minimalism and "picture music" (music written without notes). Thus, in addition to providing the immediate, practical experience of composition, *Composing Music* is a reference book of ideas for future pieces.
